Part one

ORGANIZATIONAL MEETING FOR 1985

Held at United Nations Headquarters on 19 and 22 February 1985

Chapter I

ORGANIZATION OF THE MEETING

4. The Governing Council of the United Nations Development Programme, in accordance with rule 1, paragraph 2, of its rules of procedure (DP/1/Rev.4), 1/ held its organizational meeting for 1985 at United Nations Headquarters, on 19 and 22 February 1985 (1st, 2nd and 9th meetings).

Attendance

5. Members of the Governing Council represented at the meeting, States represented by observers, United Nations Secretariat units, United Nations bodies, specialized agencies and other organizations of the United Nations system, and other intergovernmental organizations, which were represented at the meeting, are listed in annex II to the present report.

Election of officers

6. In accordance with rule 11 of its rules of procedure, the Council elected, by acclamation, Wlodzimierz Natorf (Poland) President for 1985. The Council elected the following other officers, also by acclamation, as Vice-Presidents: Thabo Makeka (Lesotho), C. Richard Mann (Canada), Lloyd M. H. Barnett (Jamaica) and M. S. Mukherjee (India).

7. Mr. Mann was designated Chairman of the Budgetary and Finance Committee and Mr. Barnett was named Chairman of the Drafting Group. It was further agreed that the President would preside over the meetings of the Committee of the Whole and that he, in conducting the proceedings of those and the plenary meetings, would be assisted by the Vice-Presidents.

Agenda

8. The Governing Council adopted the agenda for its organizational meeting, (DP/1985/L.1) as well as the provisional agenda of the special meeting of the Governing Council (DP/1985/L.2). The agenda is reproduced in annex III to the present report.

Summary records of the meeting

9. The statements made and views expressed during the organizational meeting are contained in documents DP/1985/SR.1, SR.2 and SR.9.

Chapter II

PROGRESS REPORT ON RATIONALIZATION OF THE WORK OF THE GOVERNING COUNCIL

10. Under agenda item 4, the Secretary of the Governing Council reported orally on steps taken to further implement various decisions of the Council on the rationalization of its work and on measures taken concerning the documentation of the Governing Council in pursuance of decision 83/40 of 18 June 1983. The Council took note of the statement (see annex I, decision 85/1, sect.III). The views expressed by delegations on the item are contained in summary record DP/1985/SR.1.

Chapter III

MATTERS RELATING TO THE WORK OF THE COUNCIL IN 1985

Thirty-second session of the Governing Council, 3-28 June 1985

11. Under agenda item 5, the Council had before it for consideration notes by the Secretariat containing the draft provisional agenda and a tentative schedule of work for the thirty-second session (DP/1985/L.3 and L.4), as well as a request for a waiver of the 10-week rule for the submission of certain documents to be considered at that session (DP/1985/2).

12. The Governing Council postponed a decision on the provisional agenda for its thirty-second session but agreed to the dates for the thirty-second session as set out in DP/1985/L.4. The Council did not object to waiving the requirement of the 10-week rule for the submission of certain documents (see DP/1985/2). The views expressed during the consideration of those matters are contained in the relevant summary records (DP/1985/SR.1-2, SR.9).

Part two

SPECIAL MEETING ON PREPARATIONS FOR THE FOURTH PROGRAMMING CYCLE

Held at United Nations Headquarters from 19 to 22 February 1985

Chapter I

ORGANIZATION OF THE MEETING

Meeting

13. In accordance with decision 84/20 taken at its thirty-first session, the Governing Council of the United Nations Development Programme held a special meeting on preparations for the fourth programming cycle at United Nations Headquarters, from 19 to 22 February 1985 (3rd to 8th meetings).

Attendance

14. Members of the Governing Council represented at the meeting, States represented by observers, United Nations Secretariat units, United Nations bodies, specialized agencies and other organizations of the United Nations system, and other intergovernmental organizations, which were represented at the meeting, are listed in annex II to the present report.

Agenda

15. At its 3rd meeting, the Governing Council adopted the provisional agenda for its special meeting (DP/1985/L.2). The annotations to the provisional agenda are also contained in DP/1985/L.2. They were orally amended at the organizational meeting (lst meeting). Two documents were submitted to the special meeting (DP/1985/1 and DP/1984/47).

Summary records of the special meeting

16. An account of the discussions held during the special meeting is contained in the summary records (DP/1985/SR.3-8).

Chapter II

PREPARATIONS FOR THE FOURTH PROGRAMMING CYCLE

17. Under agenda item 2, the Governing Council had before it a report of the Administrator containing alternative scenarios for the fourth programming cycle, prepared in accordance with paragraph 2 of decision 84/20 (DP/1985/1).

18. At the 3rd meeting, the Associate Administrator introduced the report of the Administrator. The views expressed during the consideration of that item are contained in the relevant summary records (DP/1985/SR.3-8). The Council decided on a two-stage process to Council negotiations before the thirty-second session. The first stage would be conducted by the Administrator through individual and collective contacts with delegations to be completed by 1 May. The second stage would begin once the first one was completed and would be conducted by an open-ended working group on the fourth programming cycle under the co-chairmanship of two Vice-Presidents of the Council. The Administration would prepare an analytical and structural overview of the positions stated at the special meeting.

Chapter III

TECHNICAL CO-OPERATION AMONG DEVELOPING COUNTRIES (TCDC): USE OF COUNTRY INDICATIVE PLANNING FIGURES (IPF) FOR TCDC

19. For its consideration of agenda item 3, the Governing Council had before it a report of the Administrator on the question of use of country IPFs for TCDC activities (DP/1984/47). The thirty-first session of the Governing Council had not dealt with that matter.

20. At its 5th meeting, the Associate Administrator introduced the report of the Administrator (DP/1985/47). The views expressed during the consideration of the item are contained in the relevant summary records (DP/1985/SR.5 and SR.8). The Governing Council decided that the matter should be referred to the fourth session of the High-level Committee on TCDC and subsequently be taken up at its thirty-second session (see annex I, decision 85/1, sect. IV).

Part three

THIRTY-SECOND SESSION

Held at United Nations Headquarters from 3 to 29 June 1985

<u>Chapter</u> I

ORGANIZATION OF THE SESSION

Meetings

21. The Governing Council of the United Nations Development Programme held its thirty-second session at United Nations Headquarters from 3 to 29 June 1985 (10th to 34th meetings).

22. The Budgetary and Finance Committee of the Council held 31 meetings between 3 and 29 June to consider financial, budgetary and administrative matters. Mr. D. Mondal served as Rapporteur of the Committee. For the Committee's final report, see document DP/1985/70.

23. The Council's Committee of the Whole held 10 meetings between 3 and 7 June to consider country and intercountry programmes and projects (agenda item 5(b) and evaluation (agenda item 4(d)). For the report of the President on the work of the Committee of the Whole, see DP/1985/L.8.

24. The Drafting Group of the Council held 13 meetings between 21 and 28 June to consider proposals for draft decisions referred to it by the Council. For the report of the Drafting Group, see DP/1985/L.9 and Add. 1-25.

Attendance

25. Members of the Governing Council represented at the meeting, States represented by observers, United Nations Secretariat units, United Nations bodies, specialized agencies and other organizations of the United Nations system, and other intergovernmental organizations, which were represented at the meeting, are listed in annex II to the present report.

26. In accordance with rule 1, paragraph 2, of its rules of procedure (DP/1/Rev.4), the Council's officers were elected at its organizational meeting for 1985. (See part one, chap. I, para. 6, above.)

Agenda

27. At its 10th meeting, the Council adopted the provisional agenda and the organization of work for its thirty-second session (DP/1985/5/L.5; see annex I, decision 85/2). The annotations to the provisional agenda are contained in DP/1985/3 and DP/1985/3/Add.1. For a list of the documents submitted to the Council at its thirty-second session, see DP/1985/3/Add.2. The report on the status of the pre-session documents is contained in DP/1985/3/Add.4.

Summary records of the meetings

Chapter II

POLICY REVIEW: MEASURES TO BE TAKEN TO MEET THE CHANGING TECHNICAL CO-OPERATION REQUIREMENTS OF THE DEVELOPING COUNTRIES

29. For its consideration of agenda item 3, the Governing Council had before it a report of the Administrator on Co-ordination of external technical co-operation at the country level and examination of steps taken by the United Nations Development Programme to strengthen co-ordination in practice (DP/1985/4 and DP/1985/4/Add.1).

30. At the llth meeting, the Administrator introduced his report on the item (DP/1985/4 and DP/1985/4/Add.1). The views expressed during the Council's general debate, which was designated as the high-level segment of the thirty-second session, are contained in the relevant summary records (DP/1985/SR.11 and SR.13-20).

31. At its 37th meeting, the Governing Council, following its consideration of the recommendation of the Drafting Group (see DP/1985/L.9/Add.15), adopted decision 85/3 (see annex I).

Chapter III

PROGRAMME IMPLEMENTATION

A. Annual report of the Administrator for 1984

32. For its consideration of agenda item 4 (a), the Council had before it the following documents:

33. At the llth meeting, the Administrator introduced his annual report as part of his policy statement. An informal note on measures to improve programme and project quality was made available.

34. At the 21st meeting, the Administrator introduced the note on human resources development. The Director, Division of External Relations, also made an introductory statement with respect to the reports of the Joint Inspection Unit. The views expressed during the consideration of the annual report of the Administrator for 1984, including those expressed at the high-level segment of the session (agenda item 3), are contained in the relevant summary records (DP/1985/SR.11, SR.13-22).

1. Evaluation programme: women in development

36. The Governing Council had before it a note by the Administrator on the interorganizational assessment of women's participation in development: summary report (DP/1985/10) and a report of the Administrator on women in development (DP/1985/55).

37. At the 22nd meeting the issue was introduced by the Assistant Administrator, Bureau for Programme Policy and Evaluation. The views expressed during consideration of the issue are contained in the relevant summary records (DP/1985/SR.22-23).

38. At its 37th meeting, the Council, following its consideration of the recommendation of the Drafting Group (see DP/1985/L.9/Add.5), adopted decision 85/7 (see annex I).

2. Measures to promote better understanding of the role and activities of the United Nations Development Programme and of the resource needs of the Programme

39. The Governing Council had before it a note by the Administrator on measures to promote better understanding of the role and activities of the United Nations Development Programme and of the resource needs of the Programme (DP/1985/8).

40. At the 21st meeting, the issue was introduced by the Administrator. The views expressed during consideration of the issue are contained in the relevant summary records (DP/1985/SR.21 and SR.25).

41. At its 37th meeting, the Governing Council, following its consideration of the recommendation of the Drafting Group (see DP/1985/L.9/Add.13) and the recommendations of the Budgetary and Finance Committee (DP/1985/BFC/L.2/Add.13), adopted decision 85/8 (see annex I).

3. Government execution

42. The Governing Council had before it a report of the Administrator on government execution (DP/1985/12).

134. For the consideration of agenda item 10 (b), the Governing Council had before it a note by the Administrator on action taken by other organs of the United Nations system in 1984 (DP/1985/66 and Add.1).

135. At its 38th meeting, the Governing Council took note of the note of the Administrator (see annex I, decision 85/48, para. (f)).

Chapter X

136. For consideration of the question relating to documentation, the Governing Council had before it a note by the Administrator on the usefulness of documents issued for the Governing Council (DP/1985/69).

Taking into account the mandate of the Resident Co-ordinator in facilitating the co-ordination of the operational activities of the United Nations system,

<u>Taking note</u> of the report of the Administrator of the United Nations Development Programme on the co-ordination of external technical co-operation at the country level and examination of steps taken by the United Nations Development Programme to strengthen co-ordination in practice (DP/1985/4 and Add.1) and the comments of Governments thereon, 1. Invites developing countries to take all measures that may be necessary to ensure the best possible co-ordination of all external technical assistance, including the establishment of national programmes for the identification of priority technical co-operation needs, and, where necessary, to strengthen consultative arrangements with a view to promoting common understanding of the priorities and strategies established by the recipient country and thereby more effective external technical co-operation;

2. <u>Encourages</u> bilateral aid agencies and multilateral organizations to align their technical co-operation activities with the priority technical needs established by developing countries;

3. <u>Invites</u> Governments, as may be willing, to utilize fully the revised round-table process, in those countries that have selected the process, in order to attain, <u>inter alia</u>, the maximum co-ordination of external technical co-operation;

4. <u>Notes with satisfaction</u> the increased co-operation between the United Nations Development Programme, the World Bank and regional development banks in accordance with paragraph 23 of General Assembly resolution 38/171 of 19 December 1983 and within the framework of the follow-up activities;

5. Urges those organizations to continue their close collaboration with the Programme, especially with respect to country and sectoral analysis and the programming and implementation of technical co-operation;

6. <u>Notes</u> the progress achieved with regard to the revised round-table process, technical co-operation assessment missions and consultative group meetings;

7. <u>Requests</u> the Administrator to give priority attention to ensuring that the United Nations Development Programme is responsive to assisting developing countries, if so requested, in strengthening their capabilities in co-ordination, including the co-ordination of national technical co-operation programmes;

8. Welcomes the steps being taken by the UNDP to that effect, as outlined in paragraphs 41-45 of document DP/1985/4;

9. Invites Governments to continue their efforts at co-ordination of national action with regard to operational activities for development, thus making it possible for concerted policies to be pursued in the United Nations and other organizations of the United Nations system and so facilitate the implementation of the present decision;

10. <u>Reaffirms</u> the responsibilities of the Resident Co-ordinator on behalf of the United Nations system with respect to co-ordination of operational activities carried out by the United Nations system at the country level in accordance with General Assembly resolutions 32/197 and 34/213, including activities arising from co-financing arrangements;

The Governing Council,

Having considered the annual report of the Administrator of the United Nations Development Programme for 1984 (DP/1985/5 and Add.1, DP/1985/5/Add.2 (Parts I and II), DP/1985/5/Add.3 and 4, DP/1985/5/Add.5 (parts I and II) and DP/1985/5/Add.6),

<u>Having taken note</u> of the Administrator's proposals for improving the guality of programmes and projects financed by the United Nations Development Programme as announced in the Administrator's opening statement to the Council on 10 June 1985,

Taking into account the views expressed on those proposals during the thirty-second session of the Governing Council,

1. <u>Reaffirms</u> the provisions of paragraph 38 of the annex to the consensus contained in the annex to General Assembly resolution 2688 (XXV) of 1 December 1970 that the role of the organizations of the United Nations system in the implementation of country programmes should be that of partners, under the leadership of the United Nations Development Programme;

2. <u>Also reaffirms</u> the responsibility and accountability of the Administrator of the United Nations Development Programme for the effective use of Programme resources, as well as for all other aspects of implementation of the Programme;

3. <u>Supports</u> the efforts undertaken by the Administrator to improve the guality and effectiveness of programmes and projects financed by the United Nations Development Programme - in particular those measures aimed at strengthening the technical capability and role of the United Nations Development Programme in project development, including the establishment of a project development facility for an initial experimental period extending to the end of the third programming cycle, to be financed from Special Programme Reserve up to a maximum of appraisal missions to be financed from project budgets, if such are established, it being understood that missions in the identification and formulation stage are to be undertaken at the request of Governments and appraisal missions with the concurrence of Governments;

4. Further supports those measures related to improving agency performance in project formulation and implementation;

5. <u>Urges</u> Governments and agencies involved to make every effort to streamline internal procedures and institutional mechanisms in order to ensure the speedy implementation of activities financed by the United Nations Development Programme in accordance with existing rules and regulations; 6. <u>Requests</u> Governments and the Administrator, as appropriate, to use indicative planning figure resources in identifying requirements for technical assistance, with a view to mobilizing and programming external resources to meet those requirements;

7. <u>Takes note</u> of the exceptional measures adopted by the Administrator in response to the critical situation in Africa and, in particular, of the efforts being made to co-ordinate emergency assistance with longer-term rehabilitation and development measures;

8. Urges the United Nations Development Programme to continue to respond to the changing technical co-operation requirements of developing countries;

9. <u>Takes note</u> of the Administrator's efforts in the management of residual funds transferred from the United Nations Emergency Operation Trust Fund and their utilization for activities in countries affected by drought, famine, flood and other natural disasters;

10. Encourages the Administrator to pursue further the progress achieved in enhancing the round-table process of consultation in favour of the least developed countries;

11. <u>Notes</u> with concern the decline in programme delivery in recent years despite the availability of resources;

12. <u>Requests</u> the Administrator to carry out further intensive consultations with participating and executing agencies in order to improve project budgeting practices in the light of recent difficulties;

13. <u>Further requests</u> the Administrator to report on the implementation of the measures proposed and initiated to improve programme and project quality at the thirty-third session (1986) of the Governing Council.

85/5. The development of human resources

The Governing Council,

Emphasizing that the expansion of human capacities and skills in all developing countries should keep pace with capital investment and should be accorded sufficient priority in official development assistance and development plans of developing countries,

Recognizing the need to strengthen the vital role of human resources in the development process and also the need to take greater account of human resources needs in the design of projects and programmes,

<u>Reaffirming</u> the critical role of technical co-operation in the development of human resources in developing countries and the contribution of the United Nations Development Programme to that effect,

1. Welcomes the emphasis placed by the Administrator of the United Nations Development Programme on the importance of strengthening the human factor in development;

2. <u>Takes note</u> of the establishment by the Administrator of a task force in the United Nations Development Programme to advise him on measures to be taken to that effect;

3. Welcomes further the course of action set out in the report of the Administrator (DP/1985/22) and in his introductory statement for a series of workshops to be undertaken in the coming months as part of an intensive, world-wide process to promote human resources development;

4. <u>Appeals</u> to Governments to lend their full support to those endeavours in order to ensure that the crucial role of the development of human resources receives the attention it deserves at the national, regional and international levels.

Accepts the recommendations of the Joint Inspection Unit contained in its report, taking into account the comments of the Secretary-General on those recommendations;

2. <u>Requests</u> the Administrator to co-operate fully with the Secretary-General, in carrying out activities designed to enhance the co-ordination throughout the United Nations system of projects and programmes in the area of drug-abuse control;

3. <u>Requests</u> the Administrator to report to the Governing Council on a regular basis on the activities carried out by the United Nations Development Programme in the field of drug-abuse control.

85/7. Evaluation programme: women in development

The Governing Council,

Having considered the summary report of the Administrator of the United Nations Development Programme on the interorganizational assessment of women's participation in development (DP/1985/10) and the report of the Administrator on women in development (DP/1985/55),

Bearing in mind the pertinent provisions of the forward-looking strategies of implementation for the advancement of women and concrete measures to overcome obstacles to the achievement of the goals and objectives of the United Nations Decade for Women (A/CONF.116/PC/25/Add.1),

<u>Recognizing</u> the efforts made by the United Nations Development Programme and other organizations of the United Nations development system to ensure that the interests of women as participants in and beneficiaries of development are taken into account in planning, designing and implementing projects,

Taking note of the data indicating that women's participation in development projects assisted by the United Nations Development Programme is slowly increasing and that the decline shown by the figues for 1980 has been reversed in subsequent years,

1. <u>Urges</u> Governments to give more priority to using the special programming assistance for the integration of women in development being offered by the United Nations development system;

2. <u>Strongly urges</u> Governments, the United Nations development system and non-governmental organizations to implement the recommendations contained in the call for action in paragraphs 103-125 of the report of the Administrator of the United Nations Development Programme on the interorganizational assessment of women's participation in development (DP/1985/10); 3. <u>Requests</u> the Administrator to develop, for presentation to the Governing Council at its thirty-third session, an internal implementation strategy to strengthen the capacity of the Programme to deal with issues of women in development which, calling on the experience of the United Nations Development Fund for Women, would establish verifiable objectives and a time-frame for implementation with a view to promoting accountability and also give special attention to improved staff training, monitoring existing guidelines, instructions and procedures for inclusion of women in development in programming missions and strengthening the focal point within the Programme's headquarters for the co-ordination of women's programmes.

85/8. Measures to promote better understanding of the role and activities of the United Nations Development Programme and of the resource needs of the Programme: information support to technical co-operation among developing countries and to the International Drinking Water Supply and Sanitation Decade

The Governing Council,

<u>Recalling</u> its decision 83/15, of 18 June 1983, in which it authorized allocations from Special Programme Resources for information and communication support for the International Drinking Water Supply and Sanitation Decade and for information support for the promotion of technical co-operation among developing countries,

Having considered the proposals by the Administrator of the United Nations Development Programme in his note (DP/1985/8) for the continuation of those projects in 1986 by further allocations from Special Programme Resources, pending allocation of resources for the fourth cycle,

1. <u>Approves</u> an allocation of \$319,200 from Special Programme Resources for continued information and communication support for the International Drinking Water Supply and Sanitation Decade in 1986;

2. <u>Approves</u> an allocation of \$150,000 from Special Programme Resources for continued information support for the promotion of technical co-operation among developing countries in 1986;

3. <u>Requests</u> the Administrator of the United Nations Development Programme to present a report with his recommendations to the Governing Council at its thirty-third session (1986).

37th meeting 28 June 1985

The Governing Council,

<u>Having considered</u> the report of the Administrator of the United Nations Development Programme on the progress of government execution (DP/1985/12),

Taking note of the progress achieved in furthering the modality of government execution of projects through the steady increase in the number of such projects being undertaken,

Also taking note of the fact that various difficulties remain, particularly owing to the lack of familiarity on the part of Governments with existing procedures,

<u>Further noting</u> that the add-on arrangement which was established has not been operational for the full experimental period of two and one half years, as foreseen in Governing Council decision 82/8,

1. Approves the extension of the experimental period of the add-on as established by decision 82/8 until 31 December 1987;

2. <u>Requests</u> the Administrator of the United Nations Development Programme to monitor closely the use of add-on in supporting government execution;

3. Further requests that the review and assessment of government execution and the impact of the add-on which was envisaged in decision 82/8, including special reference to cost-effectiveness, be presented to the Governing Council at its thirty-fourth session (1987).

85/10. Recent trends in the recruitment, cost and utilization of project personnel and other personnel working in development co-operation

The Governing Council,

Having considered the report of the Administrator of the United Nations Development Programme on the recent trends in the recruitment, cost and utilization of project personnel and other personnel working in development co-operation (DP/1985/9),

1. Endorses initiative of the Administrator of the United Nations Development Programme to ensure a more intensive use, as appropriate, of nationally recruited project personnel, the Transfer of Knowledge through Expatriate Nationals etc., as mentioned in document DP/1985/9, with a view to achieving more cost-effectiveness;

2. <u>Further endorses</u> the Administrator's efforts to use operational assistance contracts, which facilitate the return of nationals in accordance with the criteria set out in paragraph 11 of document DP/1985/9;

3. Urges agencies and other parties in the development process to pay particular attention at the project design stage to ensuring greater cost-effectiveness in the utilization of project personnel by identifying the most appropriate categories of personnel, in accordance with the requirements of individual projects and appropriate guidelines of the United Nations Development Programme;

4. <u>Reaffirms</u> the need to take into account, in the design of projects, the potential role of United Nations Volunteers in the development process;

5. <u>Strongly urges</u> agencies to continue their efforts to improve their recruitment policies and procedures with respect to project personnel by:

(a) Ensuring that the best suited individuals are selected and nominated to meet the specific requirements of projects, in accordance with existing rules and procedures of the United Nations system;

(b) Promptly circulating job descriptions for vacancies, taking into account and making full use of the capacity of national recruitment services;

(c) Submitting more than one candidate to recipient Governments for each vacant post;

6. Also strongly urges recipient Governments to speed up the clearance process of project personnel;

7. Further invites Governments to adhere as much as possible to the schedule agreed upon, in the project document in assigning their own staff to the project;

8. Further endorses the Administrator's efforts to improve the collection of data in order to monitor the quality and impact of various categories of personnel;

9. Requests the Administrator to report to the Governing Council at its thirty-fourth session (1987), by comparative analysis, on the cost, quality and impact of all categories of personnel.

85/11. Implementation of the Substantial New Programme of Action for the 1980s for the Least Developed Countries

The Governing Council

1. <u>Takes note</u> of the report of the Administrator of the United Nations Development Programme on the implementation of the Substantial New Programme of Action for the 1980s for the Least Developed Countries (DP/1985/11);

2. <u>Endorses</u> the Administrator's proposals contained in paragraphs 21 and 22 for the revitalization of the Special Measures Fund for the Least-Developed Countries as a special-purpose fund for those countries;

3. <u>Requests</u> the Administrator to report to the Council at its thirty-third session on the arrangements made by him for the utilization and management of resources in the Special Measures Fund;

4. <u>Urges</u> all Governments to contribute or make increased contributions to the Special Measures Fund for the least developed countries and to the United Nations Capital Development Fund, in accordance with the recommendations of the Substantial New Programme of Action;

5. <u>Notes</u> the findings of the evaluation of experience with the round-table process in the Africa and the Asia and Pacific regions, and welcomes the introduction of an improved format for the round-table process as a result of that evaluation;

6. <u>Requests</u> the Administrator to ensure that the round-table process provides an effective instrument for the implementation of the Substantial New Programme of Action, and, in particular, for the promotion of a dialogue between the Governments of the least developed countries and bilateral and multilateral donors on policy guidelines directed to the economic development of the least developed countries concerned through appropriate internal measures and external assistance;

7. Further requests the Administrator to review periodically the round-table mechanism with a view to ensuring that it responds to the needs of the least developed countries and of the donors in the efforts to achieve effective aid co-ordination in the least developed countries;

8. <u>Also requests</u> the Administrator to present, to the Mid-term Review of the Substantial New Programme of Action by the High-level Meeting of the Intergovernmental Group on the Least Developed Countries of the United Nations Conference on Trade and Development, a comprehensive report on the Programme's special efforts in favour of the least developed countries with particular emphasis on the period since the United Nations Conference on the Least Developed Countries, held in Paris in 1981;

9. Further requests that in this report the Administrator assess, among other things, and to the extent possible, the results of round-table conferences held since 1981 and present his views on how the United Nations Development Programme, donors and the least developed countries themselves might contribute to the ultimate success of the initiatives taken by the Programme towards improved development co-operation with the least developed countries;

10. Agrees in principle to the Administrator's proposal for the financing of the cost of the various activities related to the round-table process during the fourth programming cycle (1987-1991) from Special Programme Resources, and requests him to make the necessary recommendations to the Council at its thirty-third session (1986), including an indication of the various types of expenses that the United Nations Development Programme expects to incur.

85/12. Strengthening the response to the crisis in Africa

The Governing Council,

<u>Recalling</u> its decision 84/18 of 29 June 1984, concerning the economic and social crisis in Africa,

Taking note of General Assembly resolution 39/29 of 3 December 1984 concerning the critical situation in Africa, and the decision of the Organization of African Unity of November 1984,

Welcoming the Secretary-General's decision to establish the Office for Emergency Operations in Africa, his appointment of the Administrator of the United Nations Development Programme in his personal capacity as its Director and the Office's initial actions,

<u>Recognizing</u> with deep concern the persistent and continuing nature of the economic and social crisis in Africa and the necessity for the United Nations Development Programme and all other parts of the international community to respond to and assist African countries to meet their critical short-term needs and fulfil their legitimate aspirations to achieve rehabilitation, stabilization and development in the medium and longer term,

Taking note with satisfaction of the report of the Administrator (DP/1985/23) on the activities of the United Nations Development Programme's in the African region during the past year, including measures, particularly at the field level, to strengthen the effectiveness of the round-table process, to co-ordinate emergency planning and relief efforts and to reorient programmes of assistance financed by the United Nations Development Programme so that they will respond better to the immediate and longer-term priorities of African countries,

Also taking note of the Administrator's report on the strengthening of field offices in Africa (DP/1985/16),

Recognizing the increased volume of the work-load of the resident representative and field offices, exacerbated by the current economic and social crisis in the African region, and the increased responsibilities it entails in order for them to achieve, inter alia, higher quality and relevance in their traditional activities; to assist Governments to improve planning, conduct aid co-ordination activities and implement the improved round-table process; to help to mobilize additional resources; and to strengthen governmental capacity with respect to the programming and delivery of emergency aid to the affected countries,

Noting its decision 85/3 of 28 June 1985, on co-ordination,

1. <u>Invites</u> the Administrator of the United Nations Development Programme to intensify and make more effective the central role of the Programme and the resident representative in supporting the co-ordination of the United Nations system's response to facilitating, with the agreement of the countries concerned, the international community's reaction to the short-term and longer-term technical co-operation requirements of African countries which arise from both the critical economic situation and longer-term development objectives;

2. <u>Requests</u> the Administrator to take steps to continue to strengthen the United Nations Development Programme's assistance to African Governments, at their request, in reinforcing their management capacities, particularly related to the planning and co-ordination of aid; and to help African Governments to establish national strategies, plans and policies which adequately reflect their rehabilitation, reconstruction and development requirements;

3. Further requests the Administrator to strengthen the United Nations Development Programme's assistance to African Governments, at their request, in

conducting systematically the necessary assessments of technical co-operation requirements and in helping them to establish national programmes for priority human resources development and technical co-operation, which can serve, <u>inter alia</u>, as a basis for strengthening public-sector management and also improving the country programmes of assistance financed by the United Nations Development Programme during the fourth programming cycle and a framework for more co-ordinated and more effective technical co-operation from all aid partners;

4. <u>Encourages</u> the Administrator to continue to take measures, in conjunction with recipient Governments and the executing agencies, to orient the approved and prospective programmes supported by the United Nations Development Programme so that they are relevant and fully co-ordinated and have the greatest impact on the priority needs of African countries;

5. <u>Urges</u> Governments, as may be willing, organizations of the United Nations system and other aid partners of the African countries to make better use of the co-ordination and facilitating functions of the resident co-ordinator and of the capacity of the United Nations Development Programme to make co-ordinated and effective linkages of technical co-operation programmes;

6. Requests the Administrator to ensure that all the parts of the United Nations Development Programme under his responsibility continue to play an integrated, strong and supportive role vis-a-vis the Office for Emergency Operations in Africa and, with regard to both short-term and long-term co-operation, welcomes the fullest use by that Office of the capacity and central role of the resident co-ordinator and the United Nations Development Programme field network in all countries in sub-Saharan Africa affected by the emergency situation;

7. <u>Supports</u> the Administrator's proposals for strengthening the capacity of field offices in sub-Saharan Africa in accordance with the United Nations Development Programme budget for 1986;

8. <u>Invites</u> the Economic and Social Council, at its second regular session of 1985, to endorse the action set out in the present decision and to request the Secretary-General, in consultation with the Administrator of the United Nations Development Programme and other executive heads, to take the necessary measures, in accordance with General Assembly resolution 32/197, of 20 December 1977, to enable the resident co-ordinator, who is normally the resident representative of the United Nations Development Programme, to carry out the responsibilities envisaged in the present decision as effectively as possible.

85/13. Focal point for short-term advisory services

The Governing Council,

<u>Mindful</u> of the shortages of skills that exist in most developing countries and the need for assistance from all appropriate sources to support national efforts at overcoming such shortages, Taking note of the existence of sources of human skills that have been relatively untapped by multilateral technical co-operation and the support that may be available from such sources, including those from developing countries,

Having considered the note of the Administrator of the United Nations Development Programme on the original proposal to establish a human resources facility (DP/1985/14), prepared in accordance with paragraph 18 of Council decision 84/4 of 29 June 1984, and the exchange of views in the Council thereon,

<u>Recognizing</u> that the services to be provided by the focal point should be appropriately related to the needs of the recipient developing countries,

1. <u>Takes note</u> of the interest shown for the concept of a human resources facility;

2. Decides that:

(a) The Administrator of the United Nations Development Programme, taking fully into account the debate on that subject, be authorized to confer on a focal point, for a trial period of twenty-four months, commencing on 1 July 1985, within the headquarters of the United Nations Development Programme, the task of utilizing the expertise and skills to be made available at the request of developing countries at highly concessional rates or at no cost from sources not normally tapped by multilateral programmes of technical co-operation;

(b) The purpose of the focal point shall be to enhance the flow of skills to the enterprises and institutions of developing countries, as requested by them through their Governments, through short-term missions of highly gualified advisers drawn from the above-mentioned sources in developed and developing countries, to perform precisely defined tasks, which may include training;

(c) The function of the focal point, which shall be envisaged as a means of technical co-operation additional to mechanisms that already exist in the field, shall be to act as a clearing-house matching requests for specialized skills with the sources of supply mentioned above;

(d) Requests for assistance made to the focal point from Governments or national focal points specifically established for that purpose by the Government should be channelled through the field office of the United Nations Development Programme;

(e) The focal point should collaborate closely with existing mechanisms making available expertise to developing countries, including the United Nations development system, non-governmental organizations and other interested organizations and associations; and it should, in so doing, co-operate fully with the facilities established to promote technical co-operation among developing countries;

(f) The focal point, to the extent possible, should aim at developing links between sources of expertise and beneficiaries in developing countries and their respective Governments;

(g) Funding for mission costs will generally be shared by donor and recipient institutions on the basis reflected in paragraph 38 (a) of DP/1985/14. Multilateral and bilateral development institutions, Governments and other sources

such as foundations, enterprises and similar entities, could contribute to the financing of such missions on a case-by-case basis;

(h) The financing of the administrative costs of the focal point for the trial period shall be made available, during the period 1 July 1985 through 31 December 1986, from the Special Programme Resources at an annual cost of \$125,000 for salaries and an amount not to exceed \$100,000 for other expenses;

(i) The trial period of two years shall come to an end on 30 June 1987, unless decided otherwise by the Council;

3. Invites all Governments to support the operations of the focal point;

4. <u>Requests</u> all interested organizations, similarly, to support the operations of the focal point and, as required, to consider financial contributions to meet special operational costs of the focal point;

5. <u>Requests</u> the Administrator to provide a progress report to the Council at its thirty-third session (1986) and to provide a report to the Council at its thirty-fourth session (1987), based on a full evaluation of the activities of the focal point, which should contain a clear recommendation on whether to continue the focal point after the experimental period.

85/14. Assistance to the national liberation movements recognized in its area by the Organization of African Unity

The Governing Council,

Having considered the report of the Administrator of the United Nations Development Program on assistance to the national liberation movements recognized in its area by the Organization of African Unity (DP/1985/17), and the statements made during the debate by Governing Council members, observers and representatives of those national liberation movements,

1. <u>Takes note</u> of the continuing efforts and resolves of the Administrator of the United Nations Development Program to ensure timely, efficient delivery and close monitoring of assistance to the national liberation movements concerned;

2. <u>Endorses</u> the actions that the Administrator has taken, and plans to take in the future, to evaluate ongoing assistance projects with a view to determining the direction and thrust of development assistance to the national liberation movements concerned over the next programming cycle, 1987-1991;

3. Requests the Administrator to:

(a) Continue to assist, with the maximum flexibility possible within the mandate of the United Nations Development Programme, the national liberation movements recognized in its area by the Organization of African Unity;

(b) Take all necessary steps to ensure that such assistance is delivered as expeditiously as possible, and that the quality and the effectiveness thereof are maintained at the high levels expected of Programme assistance;

(c) Continue to report to the Governing Council on the trends, developments and other issues relating to the administration, management and effectiveness of assistance to national liberation movements.

85/15. Assistance to the Palestinian people

The Governing Council,

Recalling its decisions 79/18 of 26 June 1979, 81/13 of 23 June 1981, 82/13 of 18 June 1982, 83/11 of 24 June 1983 and 84/13 of 29 June 1984 and the relevant provisions of General Assembly resolutions,

Recognizing that the economic and social situation of the Palestinian people continues to require the special and urgent attention of the international community,

Reaffirming the commitment of the United Nations Development Programme to assist the Palestinian people in advancing their economic and social development,

Noting the difficulties encountered in efforts by the international community to bring meaningful and comprehensive development assistance to the Palestinian people in the occupied territories,

Taking note of the report of the Administrator of the United Nations Development Programme concerning the programme of assistance to the Palestinian people (DP/1985/18),

1. <u>Expresses its appreciation</u> to the Administrator of the United Nations Development Program for his continuous efforts in the implementation of the programme of assistance to the Palestinian people;

2. <u>Recommends</u> that further and vigorous efforts be made urgently in collaboration and direct consultation with all parties concerned, as requested in various relevant resolutions of the General Assembly, to achieve the goals regarding meeting the economic and social needs of the Palestinian people;

3. Expresses its gratitude to those Governments and funds which have responded generously to appeals by the Governing Council and the General Assembly for additional special contributions to the third programming cycle;

4. <u>Reconfirms</u> the need for additional special contributions, now made even more urgent by the full commitment of all funds made available from Special Programme Resources, and other sources;

5. <u>Notes</u> that, unless additional contributions are received, it will not be possible to undertake in a timely and fully effective fashion the ready pipeline of basic development projects in the West Bank and the Gaza Strip; 6. <u>Authorizes</u> the allocation of an additional \$2 million from the third cycle Special Programme Resources in order to maintain the Programme's momentum and ensure a smooth transition into the fourth cycle;

7. <u>Requests</u> the Administrator to report to the Governing Council at its thirty-third session (1986) on the concrete measures taken for the full implementation of the present decision and the result achieved in that respect.

38th meeting 29 June 1985

85/16. Fourth programming cycle

The Governing Council

1. Decides to maintain for the fourth programming cycle a five-year planning period to cover the years 1987-1991, inclusive;

2. Also decides that the World Bank data on population and per capita gross national product for 1983 shall be used in the calculations in all cases where they are available; in all other instances where reference is made in the present decision to those criteria, the Administrator shall determine and use the best estimates available, taking into account estimates provided to the Statistical Office of the United Nations Secretariat and from other reliable sources, including estimates given by Governments of recipient countries concerned;

3. <u>Decides further</u> that for the purposes of forward planning an assumed average annual growth of total voluntary contributions of at least 8 per cent on a basis of the target of \$700 million anticipated for 1986, shall apply;

4. Further decides that, in June 1989, the Governing Council shall review the resources available to date, the plans and any further indications by contributors to the Programme regarding the remaining years of the cycle, taking into account the perceived needs of the recipient countries, and make a determination as to whether higher indicative planning figures (IPFs) shall be established for the remaining years of the cycle, such higher IPFs shall be calculated on the basis of the criteria set out below;

5. <u>Approves</u> the following guidelines and criteria for the allocation of financial resources to the various programmes:

(a) Of the total resources allocated for IPFs, 19 per cent shall be allocated for intercountry IPFs and 81 per cent for country IPFs;

(b) Within the total amount of IPF resources allocated to intercountry programmes, 79.5 per cent will be allocated to the regional programmes, 8 per cent to the interregional programme and 12.5 per cent to the global programme;

(c) In addition to the above-mentioned resources for the intercountry programme, an amount of \$20 million will be allocated to the global programme from the resources set aside for increase in the Operational Reserve;

(d) For the calculation of individual country IPFs, the methodology and criteria should take into account the following:

- (i) Eighty per cent of the total amount available for country IPFs shall be allocated to countries with 1983 per capita GNP of up to \$750; the calculation to be made in such a way that the weighting is more advantageous to low-income countries with 1983 per capita GNP of \$375 and below;
- (ii) The remaining 20 per cent of total country IPFs shall be allocated to countries with 1983 per capita GNP of above \$750, the calculation to be made in such a way that the weighting is more advantageous to countries with 1983 per capita GNP between \$751 and \$1,500;
- (iii) Countries with a 1983 per capita GNP of below \$3,000 and small island countries with a population of 1 million or less and with a 1983 per capita GNP between \$3,000 and \$4,200 shall have a supplement, if necessary, to their IPFs for the fourth cycle so that they receive no less than 100 per cent of their country IPFs for the third cycle, as established on the basis of paragraph 10 of decision 84/16 of 29 June 1984;
- (iv) Countries other than those referred to in paragraph (d) (iii) above shall have, if necessary, a supplement to their IPFs for the fourth cycle so that they receive no less than 80 per cent of their country IPFs for the third cycle, as established on the basis of paragraph 10 of decision 84/16;
 - (v) Each country with a 1983 per capita GNP of above \$1,500 shall receive a country IPF for the fourth cycle of an amount which may not be in excess of its IPF for the third cycle, as established on the basis of paragraph 10 of decision 84/16;
- (vi) The weight ratio between the basic criteria and supplementary criteria used in computing illustrative country IPFs will be 75 to 25. In addition, the amount allocated for each supplementary point given will comprise a fixed part per supplementary point (25 per cent) and a variable part (75 per cent), the latter directly correlated to the amount of the IPF calculated on the basis of basic criteria, and there will be a cap to limit the amount given for supplementary criteria to a maximum of 50 per cent of the amount given for basic criteria;

(e) For the fourth cycle, the following supplementary criteria will be applied for any given country:

- (i) Inclusion in the list of countries designated as least developed among developing countries or, by decision of the Governing Council, designated to be treated as if it had been included in that list;
- (ii) It is a land-locked developing country;
- (iii) It is an island developing country;
 - (iv) It has acceded to independence during the second programming cycle or thereafter;
 - (v) It is a front-line State;

- (vi) It suffers from acute ecological or geographical disabilities;
- (vii) The magnitude of its development effort, the extent to which the Government is making structural changes to promote the development process and the distribution of income and other elements of social justice;
- (viii) Its total annual debt service payments exceeds 20 per cent of total export earnings on goods and services, in 1983;
 - (ix) Its current account deficit exceeds 10 per cent of its gross domestic product or national income for at least two years out of the three-year period 1981-1983;
 - (x) Its continued deterioration in terms of trade, measured as a decline by more than 15 per cent in at least two years out of the three-year period 1981-1983;

6. <u>Decides</u> that for regional IPFs the supplementary criteria enumerated in paragraph 10 of decision 80/30, shall apply;

7. <u>Strongly urges</u> all countries, especially those who have hitherto made only relatively modest contributions, to increase their voluntary contributions at a level necessary to maintain the momentum of the Programme in accordance with paragraph 6 of decision 80/30 and further urges those countries whose contribution to the Programme, expressed as a percentage of their official development assistance is low compared to the average of the contributions of such countries, to use every effort to increase their contributions;

8. Urges that countries with per capita GNP of between \$1,500 and \$2,000 to exert their best efforts to increase gradually their annual regular contributions so as to reimburse partially on a voluntary basis as great a proportion as possible of the Programme-financed programme, using the annualized IPF as a reference;

9. Decides that, taking into account the contributions to field office costs, in accordance with the Standard Basic Agreement or similar agreements, countries with a 1983 per capita GNP of between \$2,000 and \$3,000 and island developing countries referred to in paragraph 5 (d) (iii), above, would gradually increase their annual regular contributions on a voluntary basis, so as to reimburse partially the Programme-financed programme in order to reach from the year 1987 onwards, on an annual basis, a ratio of contributions of at least 75 per cent of the IPF expenditure in each year, in addition to the cost of the Programme field office, as determined in consultation with host Governments, and as incurred in each year, excluding the cost of the resident representative and the deputy; in determining such local costs there shall be deducted costs which are not related to the delivery of the IPF programme;

10. <u>Recognizes with appreciation</u> that certain recipient developing countries with a per capita GNP above \$3,000 have achieved or expect to achieve voluntary net contributor status during the third cycle, and calls upon them to continue to do so in the fourth cycle;

11. Notes that certain recipient countries with 1983 per capita GNP above \$3,000, excluding island developing countries with a population in 1983 of less than 1 million and with 1983 per capita GNP between \$3,000 and \$4,200, have not

yet achieved net contributor status, and in order for them to do so calls upon the Administrator to negotiate with Governments, as defined below, an amendment to the Standard Basic Agreement or similar agreements incorporating measures to ensure contributions equivalent to the IPF expenditure in each year, together with the cost of the United Nations Development Programme field office, as determined in consultation with host Governments and as incurred in each year, excluding the cost of the resident representative and the deputy; in determining such local cost there shall be deducted costs which are not related to the delivery of the IPF programme;

12. <u>Requests</u> the Administrator to report to the Council at its thirty-third session on the results of the negotiations referred to in paragraph 11 above;

13. Decides also that,

(a) Beginning with the year 1987, the Administrator shall determine the difference in each year between the contributions made by the Government both to the Programme and to the cost of the local office, on the one hand, and, on the other, the IPF delivered together with the cost of the United Nations Development Programme field office, as defined in paragraph 11 above; the deficiency, if any, in each year shall be deducted from the IPF available for the rest of the cycle, beginning with the year 1989;

(b) The Administrator shall in each year monitor the position so as to ensure that the deficiency of an individual country at no time exceeds its IPF remaining unspent;

(c) Pending final resolution of financial regulations dealing with currency of contribution, contributions above expenditures paid by the United Nations Development Program in local currency shall be paid as much as possible in convertible currencies;

(d) The Administrator shall report at the midterm on the extent to which the arrangements in paragraphs 8-13 above have been fulfilled;

14. <u>Decides further</u> that the IPF for national liberation movements shall be increased in the same proportion as the total increase of IPFs for countries with a per capita GNP below \$750;

15. Decides, taking into account the special circumstances relating to the situation of Namibia, to increase, on an exceptional basis, the fourth cycle IPF for Namibia, as determined by the criteria for calculating country IPFs above, by 50 per cent; an additional amount of up to \$3 million shall be provided for Namibia following submission of a report by the Administrator to the Governing Council at its thirty-third session (1986) to justify that amount;

16. Decides also to maintain, wherever possible, ongoing subregional projects aimed at enhancing multi-island co-operation and therefore, without prejudice to the allocation of regional IPFs, to allocate an amount of \$2.5 million for a separate IPF for that purpose for the fourth programming cycle;

17. <u>Reconfirms</u> that 1.24 per cent of total resources during the fourth cycle will be allocated to specific activities to be financed under the Special Programme Resources. In addition to those resources, an amount of \$20 million will be allocated to the Special Programme Resources from the resources set aside for increase in the Operational Reserve; 18. <u>Requests</u> the Administrator, in administering the Programme, in all circumstances, to keep programme commitments within foreseen available resources and if mobilization of resources fall short of the target set in paragraph 3 above, to make a flat across-the-board percentage reduction in all IPFs in supercession of any criteria that may interfere with the share of the respective countries; the same principle shall apply to other Programme elements, subject to the Governing Council's decision on the biennial administrative budget of the United Nations Development Programme.

85/17. Programming

The Governing Council,

Recalling the consensus contained in the annex to General Assembly resolution 2688 (XXV) of 1 December 1970 and its decision 83/5 of 24 June 1983 regarding, inter alia, strengthening the role of the Governing Council and participating Governments in programme planning and programme review,

<u>Recognizing</u> the exclusive right of recipient countries to establish their own priorities in the use of external technical assistance within their national plans and programmes,

Recognizing also the work-load involved in the Council's consideration of programming matters and the need to expedite thoughtful and thorough treatment of such matters,

Recalling specifically the mandate of the Committee of the Whole:

(a) To consider major issues related to programme matters;

(b) To review country, regional, interregional and global programmes and projects;

(c) To review programme and project implementation;

(d) To consider reports on evaluation studies; and

(e) To deal with other matters related to the programme management of the United Nations Development Programme;

Emphasizing at the same time the accountability of the Administrator of the United Nations Development Programme to the Governing Council,

<u>Recognizing</u> the requirement of the Governing Council to review programming matters on a continuous basis,

1. Decides to convene, immediately after the organizational session, a special session of the Governing Council in order to examine country programmes, as available, and programming matters and, further, to consider the possibility of convening other sessions in accordance with the information provided by the Administrator of the United Nations Development Programme; 2. <u>Recognizes</u> that country and intercountry programmes will be considered in accordance with paragraph 1 above;

3. Decides to establish, on an experimental basis and within existing resources, a working group of the Committee of the Whole, consisting of 24 members of the Governing Council, to facilitate and help expedite the consideration of matters arising from the mandate of the Committee of the Whole, particularly in respect of programming matters, other than country and intercountry programmes, which will meet on a regular basis with attendance open to all members of the Programme, and which will report to the Committee of the Whole;

4. Decides that the review of the three-year trial period of the Committee of the Whole which will take place at the thirty-third session (1986) of the Governing Council will be undertaken in the light of additional experience of the working group and in the context of the Council's requirement to review programme matters on a continuous basis.

(a) Asia and the Pacific: Bhutan (DP/CP/BHU/4); Fiji (DP/CP/FIJ/4); India (DP/CP/IND/3); Indonesia (DP/CP/INS/3); and Tonga (DP/CP/TON/4);

(b) Latin America: Guatemala (DP/CP/GUA/4);

2. <u>Takes note</u> of the extension of the country programme for Bangladesh (DP/CP/BGD/Extension/I) and the country programme of Suriname (DP/CP/SUR/Extension/III);

3. <u>Authorizes</u> the Administrator to proceed with appraisal and approval action on requests for United Nations Development Programme assistance for projects falling within the outlines of each country programme, in accordance with Governing Council decision 81/16 of 27 June 1981 in which it is stipulated that expenditures should be kept in conformity with the relevant indicative planning figures, increased as appropriate with governmental cost-sharing contributions, and always subject to the overriding requirements of containing expenditures within the financial resources available at any given time so as to preserve the financial integrity of the Programme.

<u>Authorizes</u> the Administrator, in the absence of a country programme for Afghanistan, for the remaining portion of the third cycle, to provide continued support for ongoing projects in Afghanistan and to consider for approval new projects consistent with the rules, regulations and normal criteria of the United Nations Development Programme.

2. <u>Takes note</u> of the steps the Administrator has taken, in consultation with the World Bank and the Food and Agriculture Organization of the United Nations in securing international status for some of the agricultural research centres of the Consultative Group on International Agricultural Research, including arrangements being concluded between the World Bank and the United Nations Development Programme to reconstitute, with the concurrence of the respective host Governments, Colombia and Mexico, the International Centre for Tropical Agriculture and the International Centre for Maize and Wheat Improvement as interorganizational organizations under the aegis of the Consultative Group;

3. <u>Takes note also of the fact that the above-mentioned arrangements are</u> consistent with those worked out in setting up the International Crops Research Institute for the Semi-Arid Tropics, the International Centre for Agricultural Research in Dry Areas and the International Service for National Agricultural Research by co-sponsors of the Consultative Group in agreement with the respective host Governments, India, the Syrian Arab Republic and the Netherlands.

Emphasizing the sovereignty of nations in the formulation, adoption and implementation of their population policies, consistent with basic human rights and responsibilities of individuals, couples and families,

Recalling paragraphs 2 and 3 of General Assembly resolution 3019 (XXVII) of 18 December 1972, concerning the role of the Governing Council of the United Nations Development Programme relating to the United Nations Fund for Population Activities,

<u>Continuing to underscore</u> the importance of the human rights and voluntary aspects of family planning for all couples and individuals, as embodied in the World Population Plan of Action, a/ the recommendations for the further implementation of the World Population Plan of Action, b/ the Mexico City Declaration on Population and Development, c/ the Universal Declaration of Human Rights, d/ the International Covenants on Economic, Social and Cultural Rights and on Civil and Political Rights e/ and other international declarations and strategies adopted by the United Nations,

<u>Affirming</u> that it is the policy of the Fund, in accordance with its own family planning guidelines and the various declarations and strategies cited in the above paragraph, not to provide assistance for abortions, abortion services or abortion-related equipment and supplies as a method of family planning,

Taking into account the views expressed by delegations during the consideration of agenda item 6,

1. <u>Takes note</u> of the reports of the Executive Director of the United Nations Fund for Population Activities on the activities of the Fund in 1984 (DP/1985/28 (parts I and II), DP/1985/29, DP/1985/30 (parts I and II));

2. <u>Notes with satisfaction</u> the increase in resources contributed to the Fund in 1984, expresses its appreciation to all donors to the United Nations Fund for Population Activities;

3. <u>Urges</u> all countries that are able to do so to increase their contributions in 1986 and future years, and to make their contribution payments as early as possible;

4. <u>Authorizes</u> the Executive Director to request the convening of a special session of the Governing Council at any time prior to the next regularly scheduled session of the Council, should, in his opinion, developments in regard to the Fund's resource situation and the necessity for reprogramming of available resources warrant it;

5. Notes with satisfaction the relative proportions of assistance allocated to the priority programme areas outlined in paragraph 3, section I, of Governing Council decision 81/7, of 23 June 1981, and particularly the increase in the percentage of total programme resources allocated to family planning, as reflected in the annual report of the Executive Director of the United Nations Fund for Population Activities for 1984 (DP/1985/28 (parts I and II)), in accordance with the Council's previous directives;

6. Expresses the expectation that the present global proportions will be maintained, keeping in mind the current needs of certain individual countries for support in lower priority work-plan categories and the role of women in population activities;

7. <u>Also notes with satisfaction</u> the increase in 1984, as noted in the report of the Executive Director on the activities of the Fund in 1984, in the proportion of assistance from the Fund to priority countries;

8. <u>Reiterates</u> its goal of devoting up to two thirds of country programme assistance to the priority countries for population assistance from the Fund;

9. <u>Recalls</u> its request, as outlined in paragraph 4, section I, of decision 83/17, for a report by the Executive Director to be presented to the Council at its thirty-third session on the experience gained by the Fund in using the present set of criteria for selecting priority countries;

10. <u>Notes with appreciation</u> the Fund's increased attention to the role and status of women, and requests that the Fund further strengthen its activities directed both to special women's projects and to the role of women in all population programmes and activities;

11. Further notes that the project implementation rate in 1984 remained at about the same level as in 1983 as reflected in the report of the Executive Director on the activities of the Fund in 1984 and in the report of the Executive Director on progress achieved in improving the project implementation rate and on obstacles to, and measures to be taken towards, improving programme and project implementation and monitoring (DP/1985/33);

12. <u>Also notes with satisfaction</u> the Fund's intention to address the need for further developing and strengthening the system of monitoring and evaluation and for the feedback of the results into its policies and programmes;

13. <u>Requests</u> the Executive Director to strengthen the Fund's efforts to improve the implementation of projects and to strengthen the capacity of Governments to implement their population policies and programmes and to report on implementation experience relating to allocations and expenditures with the different executing agencies to the Governing Council at its thirty-fourth session (1987);

14. Expresses its appreciation for the progress report on the extent to which the various regional and interregional demographic training and research centres have incorporated the principles related to funding and programming, contained in document DP/1985/28 (part I);

15. <u>Requests</u> the Executive Director to provide, in view of his request for the Council to consider the importance of training in the whole spectrum of population activities, a progress report on the regional and interregional centres, as requested in paragraph 7, section I, and paragraph 4, section V, of Governing Council decisions 84/21;

16. Also expresses its appreciation for the report on the evaluations undertaken by the Fund in 1984, as outlined in document DP/1985/28 (part II);

17. <u>Recalls</u> its decision 83/17, in paragraph 7, section I, of which it called for a report to the Council at its thirty-third session (1986) on the comparative results of past evaluations according to major work-plan categories, including activities related to women and also including results of different kinds of evaluation undertaken in connection with projects funded by the Fund;

18. <u>Approves</u> UNFPA assistance to the large-scale country programmes or projects, as set forth in the recommendation by the Executive Director (DP/1985/L.7) and included in the work plan for 1986-1989, subject to availability of resources:

In Ghana (DP/FPA/PROJECTS/REC/16) in the amount of \$3 million;

In the Ivory Coast (DP/FPA/PROJECTS/REC/17) in the amount of \$1.7 million;

In Sierra Leone (DP/FPA/PROJECTS/REC/18) in the amount of \$2.8 million;

In Uganda (DP/FPA/PROJECTS/REC/19) in the amount of \$3.5 million;

In Bangladesh (DP/FPA/PROJECTS/REC/25) in the amount of \$20 million;

In India (DP/FPA/PROJECTS/REC/24) in the amount of \$63.8 million;

In Indonesia (DP/FPA/PROJECTS/REC/23) in the amount of \$18 million;

In Brazil (DP/FPA/PROJECTS/REC/22) in the amount of \$15 million;

In Cuba (DP/FPA/PROJECTS/REC/21) in the amount of \$2.4 million;

In Nicaragua (DP/FPA/PROJECTS/REC/20) in the amount of \$1.2 million with the balance of a total of \$6 million, as described in DP/FPA/PROJECTS/REC/20, to be provided from other sources;

19. Decides to consider, at its organizational session in 1986, making provision for more time at future sessions of the Governing Council in which to discuss items and documentation of the United Nations Fund for Population Activities on the agenda of the Council, in order to ensure adequate and full consideration of those matters; Taking note of the reports of the Executive Director of the United Nations Fund for Population Activities on a problem-oriented analysis of the Fund's experience in the family planning area (DP/1985/31), on the use of incentives and disincentives in family planning programmes (DP/1985/32) and on the results of the recommendations of the Policy and Co-ordination Committee of the World Health Organization's Special Programme of Research, Development and Research Training in Human Reproduction together with a recommendation for the level of the United Nations Fund for Population Activities funding for the Special Programme for the period 1986-1989 (DP/1985/34),

1. <u>Confirms</u> that all activities undertaken by the Fund should be consistent with the provisions of the World Population Plan of Action, <u>a</u>/ the Mexico City Declaration on Population and Development <u>c</u>/ and the recommendations for the further implementation of the Plan of Action; <u>b</u>/

2. <u>Requests</u> the Executive Director of the United Nations Fund for Population Activities to continue to pursue improvements in the design, management, monitoring and evaluation of family planning programmes and projects;

3. <u>Also requests</u> the Executive Director, in view of the relative paucity of research in the area of incentives and disincentives in family planning programmes, to encourage and support research on the effects of incentive and disincentive schemes on the quality of services offered and on the individual's free and informed choice;

4. Takes note with satisfaction of the greater co-ordination of international efforts in the field of contraceptive research, as outlined in document DP/1985/34;

5. <u>Approves</u> the allocation by the United Nations Fund for Population Activities of an additional \$500,000 to the World Health Organization's Special Programme for Research, Development and Research Training in Human Reproduction for 1985, for a total of \$2.5 million for 1985;

6. <u>Decides</u> that the Fund's allocations to the Special Programme should be increased, if resources increase and funds are available, to the level of \$2.75 million for 1986, \$3 million for 1987, \$3.25 million for 1988, and \$3.5 million for 1989.

Expressing satisfaction with the outcome of the International Conference on Population, \underline{a} / the recommendations adopted for the further implementation of the World Population Plan of Action \underline{b} / and the Mexico City Declaration on Population and Development, \underline{c} /

Recalling General Assembly resolution 39/228 of 18 December 1984,

<u>Further recalling</u> Economic and Social Council resolution 1985/4 of 28 May 1985, particularly paragraph 4, in which the Council invited the Secretary-General to avail himself of the advice of members of, <u>inter alia</u>, the overning Council of the United Nations Development Programme in carrying out the task entrusted to him in paragraph 13 of General Assembly resolution 39/228, <u>Recalling also</u> section IV of its decision 84/21, in which it, <u>inter alia</u>, invited the Secretary-General, subsequent to the International Conference on Population, to take into account the views of the Governing Council in the study and examination of ways and means to ensure the more effective delivery of population assistance by the United Nations system,

Taking note of the report of the Executive Director of the United Nations Fund for Population Activities on the implications of the recommendations of the International Conference on Population for the activities of the Fund (DP/1985/37 and Add.1),

Keeping in mind the views expressed on the role of the United Nations Fund for Population Activities in DP/1985/37/Add.1,

1. <u>Requests</u> the Executive Director of the United Nations Fund for Population Activities to continue to concentrate the Fund's assistance in its core areas, as defined in paragraph 3, section I, of Council decision 81/7, and to give increased emphasis to the strengthening of Fund activities at the national level;

2. <u>Further requests</u> the Executive Director to circulate to all members of the Governing Council, as soon as it is available, the report of the Secretary-General regarding the relevant recommendations - in particular recommendation 83 - for further implementation of the World Population Plan of Action concerning the role of international co-operation;

3. <u>Notes</u> the proportional distribution of allocations between country and intercountry activities achieved in 1984;

4. <u>Reaffirms</u> the existing target of up to 25 per cent of programmable resources for intercountry activities;

The Governing Council,

Having considered the 1986-1987 biennial budget estimates for administrative and programme support services of the United Nations Fund for Population Activities for the biennium 1986-1987 (DP/1985/39 and Corr.1 and Add.1), the report of the Executive Director of the Fund on the inclusion of the Fund's deputy representatives and other field and headquarters' posts into the regular manning table and on the basic manpower requirements of the Fund (DP/1985/38 and Corr.1 and 2), together with the report of the Advisory Committee on Administrative and Budgetary Questions thereon (DP/1985/40);

<u>Recognizing</u> the importance of the Fund's field staff in the Fund's efforts to assist developing countries to increase their self-reliance in population matters, as well as the importance of regular rotation between headquarters and field professional staff;

Having taken into account the views and comments of members of the Council on the documentation before it;

1. <u>Approves</u> the appropriations in the amount of \$36,643,669 net to be allocated from the resources of the United Nations Fund for Population Activities to finance the 1986-1987 administrative and programme support services as follows:

2. <u>Authorizes</u> the Executive Director of the United Nations Fund for Population Activities to transfer credits between programmes within reasonable limits, with the concurrence of the Advisory Committee on Administrative and Budgetary Questions; 3. Requests the Executive Director to keep the administrative and programme support services costs during the biennium 1986-1987 to a minimum, including a reduction in travel and communication costs, as recommended in paragraphs 36 and 37 of the report of the Advisory Committee on Administrative and Budgetary Questions (DP/1985/40), and in hospitality costs, all of which are reflected in the above figures, with the intention of holding down the ratio between administrative costs and total costs, particularly in the light of the resource situation;

4. <u>Requests</u> the Executive Director to prepare a comprehensive report on personnel management and recommendations thereon to be submitted to the Governing Council at its next session (1986), including a study of the link between the work load and personnel structure in the United Nations Fund for Population Activities; priorities to set in order to strengthen specific areas of the Fund, according to paragraph 6, section III, of Governing Council decision 83/17; career development; feasibility of redeployment of posts and rotation of personnel between the field and headquarters; and recruitment policies;

5. <u>Also requests</u> the Executive Director to present to the Governing Council for approval, at its thirty-third session (1986), draft guidelines for what should be regarded as project-related personnel expenditures - consequently budgeted as project costs - and what should be regarded as administration-related personnel expenditures - consequently budgeted as administrative costs;

6. Decides to establish in the regular administrative and programme support services budget for the biennium 1986-1987 the following new posts:

(a) Thirty-three deputy representatives and senior advisors on population posts, of which 17 could be filled in 1986;

(b) Nine international programme officer posts in those countries in which no post under (a) above exists;

(c) Ten professional posts at headquarters - namely, a programme officer for the Asia and Pacific Branch, a chief, Budget and Managment Analysis Section, a senior management specialist, a senior family planning specialist, an evaluation officer, a programme officer for the Africa Branch, two procurement officers, a policy officer and a technical officer, with all corresponding posts currently financed by project funds to be abolished;

7. Also decides that all new posts established within the budget under the provisions of paragraph 6 above shall be filled in accordance with established criteria governing appointments, as stipulated in the United Nations Staff Rules and United Nations Development Programme personnel policies and practices;

8. <u>Decides</u> that no further project-funded posts shall be established at headquarters without prior approval of the Council, pending the approval of the quidelines called for in paragraph 5 above;

9. Also decides that the project-funded Professional posts at headquarters shall be abolished upon the expiration of the contracts of the current incumbents, with the exception of the minimum number of posts absolutely necessary for the operations of the Fund, for which contracts may be extended until the end of 1986; 10. Further decides that headquarters project-funded General Service posts that are vacant, and those which, upon expiration of the contracts of the current incumbents, are, in the judgement of the Executive Director, not essential for the operation of the Fund, shall be abolished, and that consideration of the remaining project-funded General Service posts be deferred until the thirty-third session of the Governing Council;

11. Decides that, in principle, the new posts for deputy representatives and senior advisors on population, mentioned in paragraph 6 above, shall be established up to the P-5 level; any further upgrading of such posts to the D-1 level shall be submitted to and approved by the Governing Council;

12. <u>Requests</u> the Executive Director to report to the Governing Council, at its thirty-third session (1986) on the implementation of the decisions outlined in paragraphs 6-11 above, particularly paragraph 6 (a), including justification for any remaining project-funded posts at headquarters;

13. <u>Authorizes</u> the Executive Director to implement the results of the job classification exercise and the new salary scale for General Service staff of the United Nations Fund for Population Activities when such results are implemented by the Secretary-General for the United Nations General Service, and with the same effective date;

14. <u>Authorizes</u> the Executive Director to implement the reclassification results for Professional posts effective 1 January 1986.

II

Having considered the format of the biennial budget estimates for the 1986-1987 biennium, as contained in document DP/1985/39 and Corr.1 and Add.1,

<u>Requests</u> the Executive Director, when presenting the financial and budgetary situation of the United Nations Fund for Population Activities, to follow the guidelines used by the United Nations Development Programme, in particular:

(a) To use identical parameters and designations, where feasible, for the presentation of basic financial and budgetary data and to present to the Council at its thirty-third session (1986) a prototype for an improved format of future budgets, taking into account the comments made in the Budgetary and Finance Committee during the thirty-second session of the Council;

(b) To present to the Governing Council, at each session, in addition to the biennial presentation of budget proposals, documentation containing the annual financial review, including, for information, extrabudgetary resources and revised budget estimates, if any.

III

<u>Having considered</u> the audited accounts of the participating and executing agencies related to funds allocated to them by the United Nations Fund for Population Activities as at 31 December 1983 (DP/1985/41) and the reaction of participating and executing agencies and the Panel of External Auditors in regard to narrative audit reports (DP/1985/42), 1. <u>Takes note</u> of the audited accounts of the participating and executing agencies;

2. <u>Requests</u> the Executive Director of the United Nations Fund for Population Activities to reiterate to agencies the importance attached by the Governing Council to long-form narrative reports, and to continue his efforts to obtain those reports from the participating and executing agencies and the Panel of External Auditors.

85/21. United Nations technical co-operation activities

The Governing Council,

Taking note with appreciation of the report of the Secretary-General on United Nations technical co-operation activities (DP/1985/43 and Add.1-3),

Recalling its decision 84/22 of 29 June 1984,

1. <u>Commends</u> the Department of Technical Co-operation for Development of the United Nations Secretariat for reducing its administrative costs and for continuing to improve its processes and procedures, thereby increasing the efficiency and effectiveness in the delivery of its services to developing countries, despite the sharp reductions in staff over the past two years, and urges it to continue its efforts to eliminate the deficit in its overhead income account;

2. <u>Notes with concern</u>, however, that fundamental constraints external to the Department have yet to be addressed, in order to place the Department on a firmer financial footing;

3. <u>Reiterates accordingly</u> its request that necessary action by the Secretary-General be completed, in pursuance of paragraphs 62 and 63 of General Assembly resolution 32/197, of 20 December 1977, with regard to the clustering in a single organizational entity of all technical, managerial and operational capabilities related to technical co-operation activities of the United Nations Secretariat;

4. <u>Requests</u> the Secretary-General to continue to explore specific measures in administrative, financial, and personnel matters to increase the Department's competitiveness as an executing agency, and to report back to the Council at its thirty-third session;

5. Endorses the major role of the Department in setting into place a Special Action Programme for Africa to improve the administrative and managerial capabilities in the field of public administration and finance, as reflected in Economic and Social Council resolution 1985/10, of 29 May 1985, and draws attention to the need for a greater concentration of resources on administrative and management programmes;

6. <u>Reaffirms</u> its support for the programme of work of the Department under the Regular Programme of Technical Co-operation and the use of that source of financing, inter alia, to support the country programming exercise, as welcomed in its decision 79/22 of 28 June 1979, and to cover on a cost-sharing and reimbursable pasis the cost of project identification, appraisal and formulation;

7. <u>Requests again financial and funding institutions to make the fullest</u> possible use of the Department's special competence, experience and operational capabilities during the various phases of the project cycle;

8. <u>Requests</u> the Secretary-General to develop for presentation to the Governing Council at its thirty-third session an internal implementation strategy based on the valuable work already done to strengthen further the capability of the Department to deal with issues of women in development and invites the Department to co-operate fully with the United Nations Development Programme in that respect.

85/22. United Nations Volunteers programme

The Governing Council,

1. <u>Takes note</u> of the annual report of the Administrator of the United Nations Development Programme on the United Nations Volunteers programme (DP/1985/44 and Add.1);

2. <u>Notes</u> the progress achieved in assisting the most severely affected African countries in utilizing more effectively emergency relief assistance through, <u>inter alia</u>, the provision of qualified United Nations Volunteers under a regional project (RAF/84/024) approved by the Governing Council at its thirty-first session, in decision 84/18;

3. <u>Urges</u> the Administrator to continue assisting the Governments of African countries affected by the present emergency, through, <u>inter alia</u>, the provision of United Nations Volunteers beyond the duration of the present regional emergency project;

4. Also urges donor Governments and all organizations in the United Nations system to consider the particular advantages of flexibility, speed and cost-effectiveness of using United Nations Volunteers when making additional allocations to assist in the current emergency;

5. Takes note with satisfaction of the fact that the relevance and advantages of the United Nations Volunteers programme have now been fully recognized by the developing countries, as manifested by the number of United Nations Volunteers now serving in development projects - the highest number ever achieved since the inception of the programme;

6. <u>Urges</u> Governments and organizations in the United Nations system to continue and increase the utilization of United Nations Volunteer contributions, where appropriate, in meeting the crucial qualified manpower requirements in the execution of development programmes and projects and to give them due consideration in the design and preparation of such programmes and projects;

85/23. International Day for Volunteers for Economic and Social Development

The Governing Council,

Taking note of the annual report of the Administrator of the United Nations Development Programme on the United Nations Volunteers programme (DP/1985/44),

<u>Considering</u> that volunteer service as exemplified not only by the United Nations Volunteers programme but also by thousands of volunteers of all nationalities, belonging to many organizations throughout the world, is making a most noteworthy contribution to programmes for socio-economic development,

<u>Recognizing</u> that the observance of an appropriate day would serve to create greater world-wide awareness of the nature of that contribution and thereby stimulate more people to offer their services as volunteers, both at home and abroad,

<u>Cognizant also</u> of the fact that such an observance would stimulate the work of all volunteer organizations and constitute a source of encouragement for those volunteers, many of whom engage in volunteer service at considerable personal sacrifice,

Noting the assurance of the Administrator that the observance would involve no further financial implications for the United Nations Development Programme,

Recommends that the General Assembly consider the question of designating an International Day for Volunteers for Economic and Social Development.

5. Notes with appreciation the successful efforts of the Administrator to obtain co-financing for the project in Saint Lucia, and urges him to continue such efforts;

6. Notes with concern the depletion of the resources of the Fund, thereby hampering the approval of projects in support of the programmes of the developing countries for the exploration and utilization of their mineral and geothermal resources;

7. <u>Renews its appeal</u> to Member States to contribute to the financial resources of the Fund in order for it to fulfil its mandate.

Noting decision 13/30 B of 23 May 1985, of the Governing Council of the United Nations Environment Programme f/ in which the Council, inter alia, endorsed again that Programme's partnership with the United Nations Development Programme in support of the joint venture to assist the countries of the Sudano-Sahelian region, through the United Nations Sudano-Sahelian Office, in combating desertification,

<u>Conscious</u> of the need for the speedy implementation in the Sudano-Sahelian region of the Plan of Action to Combat Desertification g/as an integral part of the general efforts to promote the economic and social development of the region on an ecologically sound basis and of the crucial role of the United Nations Sudano-Sahelian Office in implementing the Plan,

Stressing that desertification is both a major form of environmental degradation and an obstacle to development in areas with fragile ecosystems, characterized by low and erratic rainfall and that it is increasing at an alarming rate throughout the African continent,

1. <u>Takes note</u> of the report of the Administrator of the United Nations Development Programme on the implementation of the Plan of Action to Combat Desertification in the Sudano-Sahelian region (DP/1985/50);

2. <u>Commends</u> the initiative of the Ministerial Conference on Desertification held at Dakar in July 1984, which led to an extensive debate in the Second Committee of the General Assembly on that aspect of the present economic and social crisis in Africa;

3. Takes note of decision 13/10, taken on 23 May 1985 by the Governing Council of the United Nations Environment Programme, and endorses the decision to add the United Republic of Tanzania to the list of countries which are eligible to receive assistance through the United Nations Sudano-Sahelian Office in implementing the Plan of Action to Combat Desertification;

4. <u>Commends</u> the Administrator on the progress achieved by the United Nations Sudano-Sahelian Office/United Nations Development Programme/United Nations Environment Programme venture, in implementing the Plan of Action to Combat Desertification;

5. <u>Urges</u> all Governments, the organizations, organs and other bodies of the United Nations system, and other intergovernmental and non-governmental organizations, to intensify their assistance either bilaterally or through the United Nations Sudano-Sahelian Office or any other intermediary, in response to the priority requirements of the countries of the region;

3. <u>Expresses</u> its gratitude to the Governments, United Nations agencies and ther intergovernmental organizations, non-governmental organizations and idividuals that have contributed to the implementation of the medium-term and ong-term recovery and rehabilitation programme in the Sudano-Sahelian region;

4. <u>Appeals</u> to all Governments and other actual and potential donors to rengthen further their support for the United Nations Sudano-Sahelian Office so to enable it to respond more fully to the priority requirements of the States mbers of the Permanent Inter-State Committee on Drought Control in the Sahel, icluding voluntary contributions through the United Nations Pledging Conference r Development Activities;

5. <u>Requests</u> the United Nations Sudano-Sahelian Office to continue its close -operation with the Permanent Inter-State Committee on Drought Control in the el and its member States, with a view to supporting the second-generation ogramme of member States; 6. <u>Requests</u> the Administrator to continue to report annually to the Governing Council on the implementation of the medium-term and long-term recovery and rehabilitation programme in the Sudano-Sahelian region.

The Governing Council,

Having considered the report of the Administrator of the United Nations Development Programme on the results achieved in assisting countries in the development of their high-priority energy programmes and projects in 1984 (DP/1985/52 and Add.1),

Taking note of General Assembly resolutions 39/173 of 17 December 1984 on the implementation of the Nairobi Programme of Action for the Development and Utilization of New and Renewable Sources of Energy, and 39/176, of 17 December 1984, on the development of the energy resources of developing countries,

Noting the catalytic role played by the Energy Account in mobilizing additional resources, both multilateral and bilateral, to implement energy projects and the existing close co-operation between the United Nations Development Programme and the Office of the Director-General for Development and International Economic Co-operation in matters of energy,

<u>Further noting</u> that donors have found the Energy Account mechanism for channelling additional funds useful, especially since it has led to increased participation on the part of bilateral and multilateral programmes in energy activities,

Recalling the central funding and co-ordinating role of the United Nations Development Programme,

1. Authorizes the Administrator of the United Nations Development Programme to continue with an Energy Account within the United Nations Development Programme, as established by Governing Council decision 80/27 of 26 June 1980, as long as it receives adequate funding support from donors;

2. <u>Calls upon</u> all Governments that are in a position to do so to contribute on an increasing basis to the Energy Account in order that it may continue on a more stable basis;

3. <u>Notes with satisfaction</u> the progress achieved in assisting the countries of the South Pacific through the Regional Energy Development Programme, including financing of services of energy planners from the Energy Account;

4. Also notes with satisfaction the assistance provided to a number of countries in conducting energy sector assessments;

5. <u>Requests</u> the Administrator to continue to support the priority energy requirements of the Pacific and other regions;

6. <u>Requests</u> the Administrator to report in detail to the Governing Council at its thirty-third session (1986) on the results of the activities financed from the Energy Account, especially on the extent to which the Account has contributed by playing a catalytic role in mobilizing additional resources to implement the Nairobi Programme of Action for the Development and Utilization of New and Renewable Sources of Energy.

3. <u>Decides</u> to consider the 1986-1987 biennial budget proposal for the Fund, as well as staffing matters, at its organizational meeting for 1986, to be held in February of that year;

4. <u>Authorizes</u> the Administrator to maintain the current level of staffing and budgetary expenditures, pending approval by the Governing Council of the 1986-1987 biennial budget;

5. <u>Requests</u> the Administrator to report to the Governing Council on an annual basis on the establishment of administrative arrangements relating to the association of the United Nations Development Fund for Women with the United Nations Development Programme.

The Governing Council,

Having considered the 1986-1987 biennial budget estimates of the United Nations Development Programme and the funds administered by the United Nations Development Programme (DP/1985/57),

1. <u>Takes note with appreciation</u> of the related report of the Advisory Committee on Administrative and Budgetary Questions (DP/1985/56);

2. <u>Approves</u> appropriations in an amount of \$170,319,100 (gross), to be allocated from the resources indicated in the annex below to finance the 1986 budget, and resolves that the income estimates in an amount of \$24,946,000 shall be used to offset the gross appropriations, resulting in net appropriations of \$145,373,100, as indicated in the annex below;

3. <u>Decides</u> that of the appropriation for Programme resources approved in paragraph 2 above, \$3.0 million shall be reflected as a separate appropriation line within the 1986 budget, entitled "Africa strengthening" and that those resources shall take the form of a subvention to the extrabudgetary account for "Strengthening field offices in Africa" and shall be reimbursed to the extent that contributions are made by donors for that purpose;

4. <u>Calls upon</u> member States to make further pledges to the extrabudgetary account in order to ensure that the resources of the United Nations Development Programme are devoted to their primary purpose - namely, technical co-operation, to the maximum extent possible;

Strongly urges those organizations of the United Nations system which 5. either benefit from the services being provided by the field offices of the United Nations Development Programme in Africa or whose mandates and substantive involvement render them most suitable for providing assistance to Africa (for example, within the United Nations, the Department of Technical Co-operation for Development, the Department of International Economic and Social Affairs and the Economic Commission for Africa), to make available to the United Nations Development Programme suitable resources in cash or in kind through redeployment from within their own provisions for the purpose of strengthening co-ordination and emergency functions in Africa by the United Nations system, and in particular the United Nations Development Programme; and decides that such contributions shall be treated as a credit to the extrabudgetary account for strengthening field offices in Africa referred to in paragraph 3 above, and would be an appropriate reflection of the principle that all agencies of the United Nations system should share in the response to Africa;

6. <u>Requests</u> the Administrator to continue his efforts in that regard with the Secretary-General of the United Nations, and with the heads of the specialized agencies of the United Nations system, with a view to securing the co-operation outlined in the preceding paragraph;

7. Urges States members of the governing bodies of the organizations of the United Nations system to ensure that the requests contained in the three preceding paragraphs are met to the maximum extent possible;

8. <u>Requests</u> the Department of Technical Co-operation for Development of the United Nations Secretariat to submit to the Governing Council at its organizational session in (February) 1986, proposed adjustments to the guidelines endorsed by the Council in the exercise of its authority to establish guidelines for the regular programme of technical co-operation (sect. 24 of the United Nations programme budget), which would enable the Department to play its full and appropriate part in addressing the emergency situation in Africa, as well as the long-term development needs of that continent;

9. <u>Notes</u> that no decision was taken at the current session concerning the closure of the field office at Belgrade, and that the issue is to be reconsidered at the thirty-third session;

10. <u>Authorizes</u> the Administrator to implement the reclassification results for international Professional posts effective 1 January 1986.

Having considered the note by the Administrator of the United Nations Development Programme contained in document DP/1985/60, 1. <u>Approves</u> the texts proposed by the Administrator in 1981 as financial regulations 3.5, 3.6, 12.3 and 12.4 for inclusion in the financial regulations as regulations 4.5, 4.7, 13.3 and 13.4, respectively, in place of the former regulations 6.4, 6.6, and 4.2 and 4.3, which had remained in force pending agreement on those matters;

2. Decides that the Budgetary and Finance Committee will consider during its meetings at the thirty-third session of the Governing Council, within the framework of the provisional agenda for the thirty-third session, proposed financial regulation 4.6, remaining in brackets (see DP/1985/60, annex III), as well as those other matters on which consensus was not achieved at the thirty-second session of the Council (see DP/1985/60, annex II), with a view to facilitating the resolution of those issues by the Council.

85/39. Financial regulations: guidelines for the procurement of equipment, supplies and services

The Governing Council,

<u>Having considered</u> the note by the Administrator of the United Nations Development Programme (DP/1985/61) and the information provided orally by the Assistant Administrator, Bureau for Special Activities,

1. Notes with appreciation the efforts undertaken by the United Nations Development Programme and the executing agencies to harmonize their practices in procurement of equipment, supplies and services;

2. <u>Requests</u> the Programme and the executing agencies to continue their co-operation to achieve uniformity in their procurement practices and to reflect such common practices in the General Business Guide issued by the Inter-Agency Procurement Services Unit so as to make the United Nations system's procurement process both more accessible and more transparent;

3. Urges the United Nations Development Programme and the executing agencies to increase their efforts to expand the geographical distribution of the sources of supply, including under-utilized donors and developing countries;

4. <u>Requests</u> the Administrator of the United Nations Development Programme to consult with the executing agencies on the possibility of producing, for the information of the Governing Council, a more specific analysis of replies to the questionnaire on the procurement practices of those agencies;

5. <u>Requests</u> the Administrator to make an oral report to the Council at its thirty-third session (1986) on the results achieved in the implementation of the present decision.

85/40. Audit reports

The Governing Council,

Having considered the note by the Administrator of the United Nations Development Programme containing the audited accounts of the executing agencies for the financial period ending 31 December 1983, the reports of the external auditors thereon, the Administrator's comments on substantive observations made by the external auditors and a description of the action taken by the Administrator in response to Governing Council decision 84/40 (DP/1985/62 and Add.1),

Having also considered the audited financial statements of the United Nations Development Programme for the year 1983 and of the United Nations for the biennium 1982-1983, and the relevant reports of the United Nations Board of Auditors (A/39/5/Add.l and A/39/5, vol. I), copies of which had been made available to the Council at its thirty-second session,

1. Expresses its appreciation for the increasing emphasis given by the external auditors to the preparation of long-form narrative audit reports which include observations on the effectiveness of the financial management of projects;

2. <u>Requests</u> the Administrator to bring this decision, and the views expressed by the Committee in the course of its discussion of this subject, to the attention of the Panel of External Auditors, and to continue his efforts, in consultation with the Panel, to ensure that long-form narrative audit reports are submitted in respect of every executing agency which carries out a significant volume of UNDP-financed activities;

3. Further requests the Administrator in future years to expand the scope of his comments on the audit reports received so as to include a summary of the most significant observations contained in audit reports of UNDP itself and of the United Nations, as well as of the comments made and follow-up actions taken by the respective administrations in response to those observations.

Recalling its decision 84/41 of 29 June 1984 in which it approved the allocation of funds, subject to resource availability, through 1986 for both the sectoral support programme with smaller agencies and the Senior Industrial Development Field Adviser Programme with the United Nations Industrial Development organization in the amounts of \$912,000 and \$2,031,000, respectively,

4. <u>Recommends</u> to the General Assembly that it endorse the proposals contained in paragraph 7 of the report of the Administrator (DP/1985/64) relating to the closure as of 31 December 1985 of the Fund of the United Nations for the Development of West Irian, the United Nations Korean Reconstruction Agency -Residual Assets, the United Nations Relief Operations in Bangladesh and the Trust Fund Programme for the Republic of Zaire.
