COORDINATION IN HEALTH POLICY AND PROGRAMMING: FOLLOW-UP TO EXECUTIVE BOARD DECISION 96/38

NOTE BY THE PRESIDENT

- 1. This note provides a brief summary of the status of the follow-up to decision 96/38, on coordination in health policy and programming, and of recent developments that have a direct bearing on the possible membership of the UNDP/UNFPA Executive Board in the UNICEF/WHO Joint Committee on Health Policy.
- 2. Decision 96/38 of 13 September 1996 requested the President of the UNDP/UNFPA Executive Board, with the assistance of the secretariat of UNFPA, to ascertain the views of the Executive Boards of the World Health Organization and the United Nations Children's Fund on possible membership of the UNDP/UNFPA Executive Board in the UNICEF/WHO Joint Committee on Health Policy (JCHP) (para. 3). It also requested the President of the UNDP/UNFPA Executive Board to take appropriate action to enable the UNFPA secretariat to participate as an observer in the JCHP meeting scheduled for January 1997 (para. 4). Decision 96/38 further requested the Executive Director of UNFPA to report to the Executive Board at its second regular session 1997 on the observations made in the JCHP and to make further recommendations as appropriate on the action needed for the UNDP/UNFPA Executive Board to obtain full membership in the JCHP (para. 5) (decision 96/38 attached as annex I).

- 3. It should be noted that the JCHP meeting originally scheduled for January 1997 was postponed and rescheduled for May 1997. This altered the timing of the requests set forth in paragraphs 4 and 5 of decision 96/38 but not the substance of those requests.
- 4. In compliance with decision 96/38, the President of the UNDP/UNFPA Executive Board contacted the Presidents of the Executive Boards of WHO and UNICEF, seeking their assistance in bringing the decision to the attention of their respective Executive Boards and, in particular, in facilitating the implementation of paragraphs 2, 3 and 4 of the decision (letters dated 17 September 1996 attached as annexes II and III).
- 5. In a separate action, on 16 September 1996, the Executive Director of UNFPA contacted the executive heads of WHO and UNICEF concerning decision 96/38 and the views expressed by delegations at the third regular session of the UNDP/UNFPA Executive Board on the issue of the Board's possible membership in the JCHP (letters attached as annexes IV and V). The joint response of the Executive Director of UNICEF and the Director-General of WHO to that letter is attached as annex VI). The joint response notes that the executive heads of UNICEF and WHO plan to submit to their respective Executive Boards the following proposed arrangements:
- (a) The agenda of the meeting of the Committee would be organized in such a way that matters of direct reference to UNFPA were clustered together. This selective management of the agenda would enable UNFPA to organize the attendance of its Board members and staff in the most economical and effective way it might wish to adopt;
- (b) The present UNICEF/WHO Joint Committee on Health Policy would be known as the UNICEF/WHO/UNFPA Coordinating Committee on Health and its terms of reference would be amended accordingly.

The joint letter also noted that the approval of the above proposed arrangements by the respective Boards of all three organizations prior to the next meeting of the (present) JCHP (scheduled for May 1997) could set in place the new arrangements for the first meeting of the new Committee in May 1997.

6. In her reply, the Executive Director of UNFPA took note of the proposed arrangements and informed the Executive Director of UNICEF and the Director-General of WHO that she would bring the proposals to the attention of the UNDP/UNFPA Executive Board as soon as possible (letter dated 4 November 1996 attached as annex VII).

Elements of a decision

7. In view of the recent developments noted above, the Executive Board may wish to approve the proposed arrangements recommended by the executive heads of UNICEF and WHO as contained in their joint letter in annex VI and recommend that the UNDP/UNFPA Executive Board become a full member of the new UNICEF/WHO/UNFPA Coordinating Committee on Health once it is established. The Executive Board may further wish to recommend that the joint Secretariat of the newly established Committee amend the terms of reference of the Committee accordingly.

The Executive Board

- 1. <u>Welcomes</u> the oral report of the Executive Director of the United Nations Population Fund on coordination in health policy and programming;
- 2. <u>Reaffirms</u> the need for close collaboration at all levels among the United Nations Children's Fund, the World Health Organization and the United Nations Population Fund in the area of health policy and programming, including reproductive health, and invites the UNICEF-WHO Joint Committee on Health Policy to ensure that the United Nations Population Fund can participate in the meetings of the Joint Committee on Health Policy;
- 3. Requests the President of the Executive Board of the United Nations Development Programme and of the United Nations Population Fund, with the assistance of the secretariat of the United Nations Population Fund, to ascertain the views of the Executive Boards of the World Health Organization and the United Nations Children's Fund on possible membership of the Executive Board of the United Nations Development Programme and of the United Nations Population Fund in the Joint Committee on Health Policy;
- 4. <u>Requests</u> the President of the Executive Board of the United Nations Development Programme and of the United Nations Population Fund to take appropriate action to enable the United Nations Population Fund secretariat to participate as an observer in the Joint Committee on Health Policy in January 1997;
- 5. Also requests the Executive Director to report to the Executive Board at its second regular session 1997 on the observations made in the Joint Committee on Health Policy and to make further recommendations as appropriate on the action needed for the Executive Board of the United Nations Development Programme and the United Nations Population Fund to obtain full membership.

We refer to the discussions that took place at the UNFPA Executive Board, in the context of interagency coordination, concerning the participation of the UNFPA Executive Board in the WHO/UNICEF Joint Committee on Health Policy, and as referred to in your letter of 16 September 1996.

We attach great importance to coordination within the United Nations system. In this regard, we fully share the concern that both you, yourself, and the Board members have expressed regarding the need to ensure close collaboration, and coordinated action, between UNFPA, UNICEF and WHO. We look forward to working more closely with UNFPA on issues related to the work of the three agencies.

In recent meetings, we have had an opportunity to review jointly the question of UNFPA membership in the JCHP.
