The conference room paper provides an update on the progress of key change management-related initiatives approved by the Executive Board in its decision 97/15. The challenges of sustaining the efforts made so far in implementing the UNDP 2001 decisions and the lessons learned from the process are the main focus of the report. The paper also highlights the areas in which progress has not been achieved as quickly as anticipated. The paper explains the reasons for the delays, together with the efforts of UNDP to overcome difficulties.

In its decision 98/19, the Executive Board confirmed the application of the various financial parameters of decision 95/23 for the years 2000-2001. Application of the resources distribution methodology gives rise, however, to some issues that require review by the Executive Board. The conference room paper responds to the request in decision 98/19 for a detailed analysis of the various scenarios outlined in paragraphs 91-97 of document DP/1998/34, including the full cost implications for both Governments and UNDP of maintaining offices in net contributor countries (NCCs); the implications for the resident coordinator system and for the additional services relating to United Nations system representation provided by UNDP offices in NCCs; and an analysis of the

proposal made in paragraph 96 of document DP/1998/34 to take NCCs out of the target for resource assignment from the core (TRAC) calculation model and to manage and monitor that category as a separate group of programme countries. The conference room paper also reports on possible implications for the programming arrangements resulting from the assessment of the pilot phase of the United Nations Development Assistance Framework and ways to improve the flexibility in the allocations of TRAC-2 resources. The Board is called upon to take a decision concerning the issues contained in the document.

UNDP work in environment and natural resource management is carried out through core programme activities, which are complemented by trust-funded programmes. Among these are the Global Environment Facility, the Multilateral Fund for the Montreal Protocol, the Office to Combat Desertification and Drought (UNSO) and the United Nations Revolving Fund for Natural Resource Exploration. This report provides a brief background on each of the trust-funded programmes and covers recent programme developments, resource allocations, and results and impacts for each programme. It also summarizes some general lessons learned and the contributions of the programmes to the overall goals of UNDP.

The report contains an analysis of the risk situation of the operational reserve and presents an assessment of the financial risks faced by UNDP. It presents a review of financial management concepts, including liquidity, working capital, and reserves for regular resources as well as for other resources. The Administrator outlines his approach to determining appropriate levels for each. In so doing, he notes his intention to revise the formula for the calculation of the operational reserve for regular resources and to establish a reserve for other resources. The Administrator requests the Executive Board to note these actions and to support the establishment of the reserve for other resources funded from extrabudgetary funds.
