In 2000, the initiatives undertaken by UNDP to implement the Administrator's Business Plans, 2000-2003, aimed at creating the foundations on which the new UNDP would be built. Strong emphasis was given to restructuring and grounding a culture of performance, particularly in country offices, through a reprofiling exercise. To institutionalize the change, five priorities were identified in the annual corporate plan. The planning was integrated with the budget allocation process with the objectives of aligning resources with the goals and priorities of the Business Plans.

UNDP is seeking the continued endorsement of the Executive Board for the directions it has taken and its support for further resource mobilization efforts.

##### **Reforming Technical Cooperation for Capacity Development**

Oral report

UNDP has taken the lead in the initiative entitled "Reforming Technical Cooperation for Capacity Development." The initiative is a follow-up to the work of UNDP in the early 1990s, including the publication "Rethinking technical cooperation" and focuses on the issue of national ownership.

## **Item 4 UNAIDS**

### **UNDP contribution towards reversing the HIV/AIDS epidemic in the context of the United Nations system strategic plan for HIV/AIDS for 2001-2005** **DP/2002/3**

As requested by the Executive Board in its decision 2001/12, this document describes the specific contribution of UNDP towards reversing the HIV/AIDS epidemic within the larger framework of the United Nations system strategic plan for HIV/AIDS for 2001-2005.

The document also addresses the role of the resident coordinator system in supporting the United Nations response at the country level. It also provides details of UNDP modalities for programme support, monitoring, coordination and funding.

The Board may wish to adopt a decision on the report.

## **Item 5 Special funds and programmes**

### **Report on UNDP activities financed by the Global Environment Facility and the Montreal Protocol** **DP/2002/4**

This paper provides brief descriptions of UNDP activities funded by the Global Environment Facility (GEF) and the Montreal Protocol and outlines the key determinants of their successes. The replenishment of GEF and the discussions about its institutional architecture are the two key challenges. The Montreal Protocol, however, may need a new method to calculate support costs either based on two components or by allocating core funding for corporate functions and support costs for individual projects. The Montreal Protocol also draws attention to the need for UNDP to have mechanisms in place to deal with concessional loans in order to continue to implement any financially significant portfolios under the Multilateral Fund.

## **Item 6 Evaluation**

### **Annual report of the Administrator on evaluation** **DP/2001/26**

This report on evaluation, for July 2000 to June 2001, emphasizes three strategic areas in which evaluation activities have contributed to increasing the effectiveness of UNDP: (a) aligning monitoring and evaluation instruments with results-based management; (b) strengthening substantive accountability; and (c) promoting organizational learning and knowledge. The report sets out the ongoing challenges with regard to strengthening and integrating the monitoring and evaluation function with the transformation of UNDP to a results-based management culture.

**Evaluation of non-core funding resources**

This report was prepared in consultation with programme countries, relevant units of the United Nations system and members of the Executive Board. It covers aspects of activities funded by non-core resources, including government cost-sharing, and their impact on national capacities, particularly concerning the modalities applied by UNDP.

The evaluation of direct execution was launched in 2000 at the request of UNDP senior management. The aim was to provide an assessment of the experience with direct execution so far, following Executive Board decision 98/2.
