This conference room paper analyses UNFPA involvement in sector-wide approaches. It examines issues of general concern as well as issues specific to UNFPA. #### **UNFPA: Multi-year funding framework (MYFF), 2000-2003**

**DP/FPA/2000/6**

This report responds to Executive Board decisions 98/24 and 99/5 relating to the UNFPA funding strategy. It contains the first UNFPA proposed multi-year funding framework for 2000-2003, which consists of a results framework and an integrated resources framework. The report also discusses managing for results and a proposal for reporting on the MYFF.

The results framework identifies the organization's goals and outputs with corresponding indicators and priority programmatic strategies that should contribute to achieving results. The integrated resources framework presents two possible scenarios for resource requirements over the MYFF period.

The Executive Board may wish to comment on and endorse the UNFPA multi-year funding framework for 2000-2003.

The present reports are prepared in compliance with General Assembly resolutions 53/192, 50/120 and 47/199 and Economic and Social Council resolutions 1994/33 and 1998/27. The reports were prepared in conformity with a joint format agreed by the United Nations Development Programme, the United Nations Population Fund and UNICEF, with the list of issues identified in consultations among United Nations Development Group members.

They discuss: implementation of the reform programme of the Secretary-General and the provisions of the triennial comprehensive policy review; follow-up to international conferences; and humanitarian and disaster-relief assistance.

The Executive Board may wish to take note of the present reports and transmit them with its comments to the Council.

**Sharing new ground in post-conflict situations:** **DP/2000/14**  
**The role of UNDP in reintegration programmes**

In a strategic evaluation of support to reintegration programmes in post-conflict situations, UNDP has assessed its interventions in order to recommend a basis for becoming a more effective development partner in those situations. This subject is regarded as particularly timely since over the last several years UNDP has

responded to a sharply increased demand for assistance in those situations without a coherent framework for response. The recommendations of the team seek to clarify how UNDP should position itself to respond to work in post-conflict situations and the value it could add through its interventions.

The Executive Board may wish to take note of the evaluation "Sharing new ground in post-conflict situations: The role of UNDP in reintegration programmes."

**Meeting the challenge: the role of UNDP in crisis, post-conflict and recovery situations, 2000-2003**

**DP/2000/18**

This document addresses the role of UNDP in crisis, post-conflict and recovery situations and builds on the vision of the Administrator in this area.

## **Item 10: United Nations Development Fund for Women**

### **The United Nations Development Fund for Women: DP/2000/15 and Add.1 Strategy and Business Plan 2000-2003**

This document reflects the UNIFEM mandate to play an innovative and catalytic role in relation to the United Nations overall system of development cooperation in undertaking activities benefiting women, in line with national and regional priorities.

The Strategy and Business Plan, 2000-2003 builds on the results, lessons learned, and remaining gaps from the Strategy and Business Plan, 1997-1999. It also takes into consideration the larger and changing social, economic, political and cultural contexts that influence the organization's efforts — and those of its partners — to achieve gender equality. The Plan reflects the priorities emerging from the United Nations reform process, and the UNDP transition, as well as the preparatory processes and gender outcomes of the five-year reviews on United Nations world conferences, and in particular the Fourth World Conference on Women (Beijing, 1995).

The addendum provides detailed substantive information and is an integral part of the UNIFEM Strategy and Business Plan, 2000-2003.
