This document presents detailed information in tabular form on the net flow of contributions and financial statements as well as a summary of all active trust funds, with a focus on those established by the Administrator in 1997.

Activities of the Inter-Agency Procurement Services  
Office (including procurement from developing countries)

DP/1998/30

The report summarizes IAPSO activities in support of effective and transparent procurement under national execution: IAPSO contributions to the common services initiatives of the Secretary-General; and IAPSO activities designed to improve the flow of information directed to the business community on United Nations procurement needs.

UNDP: Annual statistical report

DP/1998/31

The report provides detailed United Nations procurement statistics by country of procurement, United Nations organization and source of funding. In addition, supply profiles of member countries of the Development Assistance Committee of the Organization for Economic Cooperation and Development are included as well as lists of major contracts for goods and services funded by UNDP.

Since the financial framework for the initial period of the arrangements (1997-1999) expires in about 15 months, the document also contains information relating to deliberations on: (a) mid-term adjustments needed in response to a foreseen 30 per cent shortfall in resources for the initial period and (b) the financial framework and parameters to be established for the next period, 2000-2002. The latter should be reviewed in conjunction with the document prepared by the Open-ended Working Group for a Funding Strategy for UNDP in response to decision 98/31.

The revised budget estimates for the biennium 1998-1999 for the United Nations Office for Project Services are contained in this document. They have been reviewed and approved by the Management Coordination Committee and submitted to the Advisory Committee for Administrative and Budgetary Questions.

The budget proposal is based on targeted growth in the UNOPS project delivery and service portfolio. It is further proposed in the document that a distinction be made between recurring operating expenditures and extraordinary expenditures. The document fully details the nature and scope of the extraordinary expenditures to be incurred by UNOPS during the biennium 1998-1999.

Approval of the budget estimates for the 1998-1999 biennium is requested of the Executive Board, including specified projected charges to the UNOPS operational reserve, the establishment of one post at the D-1 level and the relocation of two posts from UNOPS headquarters to the UNOPS office in Rome.
