Report of the Advisory Committee on Administrative and Budgetary Questions on the UNOPS revised budget estimates and procedures for establishing posts at the D-1 level **DP/2000/38**

The revised budget estimates for the biennium 2000-2001 are presented, together with information regarding the financial statement for the biennium ending 31 December 1999. The estimates confirm that UNOPS continues to operate on the basis of the self-financing principle.

Annual review of the financial situation, 1999 **DP/2000/29**

The paper provides an overview of the main lessons that have been learned thus far with the introduction of results-based management in UNDP. As the paper highlights, while it is rather early to pinpoint definitive lessons, an analysis of the strategic results framework/results-oriented annual report processes has already yielded a number of important considerations with a clear impact on the current workings of the organization.

This document presents more detailed information on technical cooperation expenditure in the form of statistical tables.

Evaluation: Report of the Administrator

This report on evaluation, covering January 1999 to June 2000, emphasizes four strategic areas in which evaluation activities have contributed to increasing the effectiveness of UNDP: (a) aligning monitoring and evaluation instruments with results-based management; (b) strengthening substantive accountability; (c) promoting organizational learning and knowledge; and (d) macro-level assessment of UNDP performance based on evaluation data. The report sets out the ongoing challenges of strengthening the role of monitoring and evaluation as results-based management is consolidated within UNDP.

The period covered by the first global cooperation framework adopted by the Executive Board in September 1997 will come to an end in December 2000, hence the need to review the GCF before the second global cooperation framework is submitted to the Executive Board in January 2001. The review positions the GCF in the global context and recalls the framework in which it was implemented. Achievements and performances of the GCF are analysed and management issues addressed. Conclusions and recommendations presented will be taken into account as lessons learned in the preparation of the second global cooperation framework.

The Executive Board may wish to take note of the review of the first global cooperation framework.

Strengthening partnerships for drylands development and poverty eradication — UNDP's role and activities in support of the UNCCD **DP/2000/CRP.14**

The report provides information on UNDP's evolving role in support of drylands development and implementation of the CCD, since 1995. It highlights the close linkages between development of the drylands of the world and UNDP's mission to eradicate poverty, as well as the activities undertaken by UNSO and various programmes of UNDP in support of the CCD in affected countries worldwide. The challenges being faced by affected countries and in delivering UNDP's support, including funding, are also discussed. It presents the new Business Plan of UNSO that emphasizes decentralization of operational activities to regional units in Africa, Asia and other regions and the transformation of UNSO from a project delivery facility to an instrument for policy development, advocacy and mainstreaming of drylands concerns into national development strategies and plans, as well as UNDP country cooperation frameworks.
