PROGRAMME IMPLEMENTATION

Draft decisions

Pre-Investment

The Governing Council,

1. <u>Takes note</u> of the Report of the Administrator on investment follow-up (DP/442), the Note by the Administrator presenting the consultant's study on UNDP and pre-investment (DP/472), the Administrator's comments on the consultant's study (DP/479), and the views expressed on these documents during the twenty-seventh session;

2. <u>Reiterates</u> its invitation to Governments to accord due priority to pre-investment activities in their country programmes;

3. Endorses the recommendation of the Administrator contained in paragraph 7 of document DP/442 that the UNDP/FAO co-operative arrangement be continued and authorizes the Administrator to enter into similar arrangements with other Agencies;

4. Endorses the proposal contained in paragraph 30 of document DP/479 that arrangements be made to ensure that Resident Representatives and Deputy Resident Representatives receive special training in investment development;

5. <u>Decides</u> ... (text on financial implications to be added on the basis of the recommendation of the Budgetary and Finance Committee);

6. <u>Decides</u> to examine further the question of UNDP involvement in pre-investment activities at its twenty-eighth session.

International co-operative action in support of the Mar del Plata Plan of Action

The Governing Council,

1. <u>Takes note</u> of the Administrator's report on international co-operative action in support of the Mar Del Plata Plan of Action (DP/474) and of the views expressed thereon during the twenty-seventh session;

2. <u>Calls upon</u> Governments in preparing their country programmes to give due attention to the inclusion of programmes and projects to ensure that the priorities identified in the Mar del Plata Plan of Action are met by the end of the International Drinking Water Supply and Sanitation Decade.

Co-operation Procedures

The Governing Council,

1. <u>Takes note</u> of document DP/468, Consultations on more uniform or standard procedures to facilitate the administration of development co-operation, and the views expressed thereon during the twenty-seventh session;

2. <u>Requests</u> that the Administrator include the findings of the report as part of UNDP's recommendations for action to the World Conference on Least Developed Countries to be convened in 1981;

3. <u>Further requests</u> that the Administrator pursue follow-up action through the appropriate ACC machinery, as necessary.
