Chapter IV. COUNTRY AND INTERCOUNTRY PROGRAMMES AND PROJECTS

A. Trends and problems in the country programmes

1. For its consideration of agenda item 6 (a), the Council had before it a report of the Administrator contained in DP/522.
2. At the Council's 709th, meeting the Deputy Administrator introduced the report. The views expressed during the Council's consideration of this item are contained in document DP/SR.710-716 and 729.
3. At its 729th meeting, the Council decided to take note of the report of the Administrator contained in DP/522. The text of the decision appears in the annex below as decision 81/23, section I.

At the Council's 729th meeting, the Chief of the Unit for Europe introduced the country programmes for Bulgaria and Poland. At the 730th meeting, the Assistant Administrator and Director of the Regional Bureau for Africa introduced the country programmes for Congo, Kenya, Mauritius and Rwanda. At the same meeting, the Officer-in-charge of the Regional Bureau for Arab States introduced the country programme for Egypt. At the Council's 731st meeting, the Assistant Administrator and Director of the Regional Bureau for Asia and the Pacific introduced the country programmes for Bangladesh, Bhutan, Maldives, Nepal, Philippines and Viet Nam.

6. The views expressed during the Council's consideration of agenda item 6 (b) as contained in documents DP/SR. 709, 710, 713-716 and 729-732.

7. At its 730th meeting, the Council approved the country programmes for Bulgaria, Congo, Cuba, Egypt, Kenya, Mauritius, Poland and Rwanda. The text of the Council's decision appears in the annex below as paragraphs 1 and 4 of Section II of decision 81/23.

8. At its 731st meeting, the Council adopted the draft decision on the country programme for Viet Nam as contained in document DP/L.366. The text of the decision appears in the annex below as paragraphs 2, 3 and 4 of Section II of decision 81/23.

9. At its 732nd-meeting, the Council approved the country programmes for Bangladesh, Bhutan, Maldives, Nepal and the Philippines. The text of the Council's decision appears in the annex below as paragraphs 1 and 4 of Section II of decision 81/23.

C. Intercountry programmes

10. For its consideration of agenda item 6 (c), the Council had before it the proposed intercountry programmes for Asia and the Pacific contained in a note by the Administrator (DP/523).

11. At the Council's 731st meeting, the Assistant Administrator and Director of the Regional Bureau for Asia and the Pacific introduced the intercountry programme for Asia and the Pacific.

12. The views expressed during the Council's consideration of agenda item 6 (c) are contained in documents DP/SR, 731 and 732. In addition, the views of delegations expressed on the subject of intercountry programming are contained in documents DP/SR, 710, 712, 715 and 716.

13. At its 732nd meeting, the Council took note of the intercountry programme for Asia and the Pacific. The text of the Council's decision appears in the annex below as Section III of decision 81/23.
