#### AGENDA AND ORGANIZATION OF WORK

#### Note by the secretariat

- 1. In accordance with the Council's decision 81/37, paragraph 4(a), annex I to this document contains the agenda for the meeting of the Budgetary and Finance Committee at the twenty-ninth session of the Governing Council of UNDP. The Council, at its organizational meeting on 25 February 1982, allocated item 7(a) through 7(h), and those financial and administrative aspects of item 6(b), UNFPA, to the Committee for its consideration.
- 2. A tentative schedule of work for the Committee's meetings is contained in annex II. As agreed by the Council at its organizational meeting in connection with the plenary's schedule of work, it is understood that if consideration of an item by the Committee has been completed before the date indicated, a subsequent item can begin immediately.
- 3. In accordance with decision 81/46, the Budgetary and Finance Committee will consider during its meeting commencing immediately prior to the twenty-ninth session of the Governing Council those parts of the financial regulations (decision 81/28) and other questions on which consensus was not achieved at the twenty-eighth session of the Council with a view to facilitating resolution of these issues by the Council. At the Council's organizational meeting it was decided that the matters to be considered by the committee in this connection shall consist of the Administrator's proposed financial regulations 3.5, 3.6, 12.3, 12.4 and the newly proposed regulation 3.6, as well as the bracketed sub-paragraphs 8(b) and 8(c) of Council decision 81/16. Provision has accordingly been made in the tentative schedule of work for consideration of these matters on the first day of the Committee's meetings, and for the Committee to revert to these matters again towards the end of the session.

- 4. As mentioned in document DP/1982/L.5, inherent policy issues related to agenda item 7(c), Programme support and administrative services budget, 1982-1983, will be taken up by the Council in the course of its general debate. Provision has accordingly been made in the Committee's tentative schedule of work for further consideration of this item after completion of the general debate.
- 5. As in previous years, the Committee will have to consider matters referred to it by the plenary session of the Governing Council for a review of any financial implications of proposals under consideration by the plenary. As shown in annex I, these matters have been included as item 5 of the Committee's agenda.
