RESOLUTIONS ADOPTED BY OTHER ORGANIZATIONS OF THE UNITED NATIONS SYSTEM

A. Economic and Social Commission for Asia and the Pacific $\frac{1}{2}$

220(XXXVIII) Annex Statute of the regional co-ordination centre for research and development of coarse grains, pulses, roots and tuber crops in the humid tropics of Asia and the Pacific

Technical Advisory Committee

"22. The Centre shall have a Technical Advisory Committee (hereinafter referred to as "TAC"), consisting of eminent scientists and experts directly connected with technical aspects, representing various fields of agricultural research. The maximum number of members of TAC shall be 12. The members of TAC shall be appointed by the Director of the Centre in consultation with the Executive Secretary of ESCAP. Representatives of ESCAP, UNDP and FAO shall be ex officio members of TAC. Representatives of other national and international research institutes and agencies concerned shall be invited to participate, as necessary."

226(XXXVIII) Food supply and distribution in Asia and the Pacific: medium-term outlook and regional co-operation

"3. Requests the Executive Secretary to seek the co-operation of relevant international organizations and agencies, including the United Nations Conference on Trade and Development, the United Nations Development Programme, the World Food Council, the World Food Programme, the Food and Agriculture Organization of the United Nations, the World Bank, the International Fund for Agricultural Development and the Asian Development Bank, in the preparation of the above-mentioned studies with a view to ensuring a well-co-ordinated approach to food security in the region;"

450 (PLEN.16) Support for the Economic Emergency in Bolivia

"1. Requests the Secretary-General of the United Nations to invite all the specialized agencies of the United Nations system to allocate all possible resources to Bolivia and to expand their programme for Bolivia to the extent necessary in their respective fields of competence and in close collaboration with the Government of that country;"

13(VII) Functioning of the CDCC Secretariat 3/

"2. Requests the Government of CDCC Member States to assist in securing fulfilment of the expressed wishes of the CDCC through appropriate follow-up action by Caribbean representatives in the central organs of the United Nations;"

430(XVII) African Household Survey Capability Programme

- "3. <u>Urges</u> the African representatives on the Governing Council of the United Nations Development Programme to stress at the next Council meeting the importance that African countries attach to the National Household Survey Capability Programme and the need for the United Nations Development Programme, in co-operation with the World Bank and in consultation with multilateral and bilateral agencies, to mobilize resources for the implementation of country projects under this programme;
- "4. Requests the Executive Secretary to seek the necessary resources from the United Nations Development Programme and other multilateral and bilateral donor agencies for the continuation of the regional component of the programme beyond 1982."

433(XVII) African Institute for Economic Development and Planning

"4. <u>Urges</u> the United Nations Development Programme to continue its financial support to the Institute at least at the present level of \$US 1.3 million per annum;"

Requests the United Nations Development Programme to provide the requisite financial resources from the unprogrammed portion of the regional indicative planning figures during its third programming cycle, 1982-1986, for the organization of the joint project on seminars on multimodal transport operations in Africa of the Organization of African Unity, the Economic Commission for Africa and the United Nations Conference on Trade and Development;"

438(XVII) Pan-African Documentation and Information System

- "10. Further requests the specialized agencies of the United Nations system, international organizations and all other agencies to make available to the Pan-African Documentation and Information System all information in their possession which may be useful for the social, economic and technological development of Africa;
- "11. Expresses its appreciation to the United Nations Development Programme, the International Development Research Centre and the African Development Bank for their financial contributions and calls for their continued support;"

441(XVII) Development of Intra-African Trade

- "4. Requests the Governing Council of the United Nations Development Programme to earmark from the existing indicative planning figures resources for the newly established Preferential Trade Area for Eastern and Southern African States to promote intercountry trade within the Preferential Trade Area;"
- "7. Notes with satisfaction the results achieved by the project on the development of intra-African trade and monetary and financial co-operation during the period 1979-1981 and expresses its gratitude to the United Nations Development Programme for having provided the Commission with financial resources for the implementation of this project;
- "8. Further takes note with satisfaction of the positive recommendation made by the evaluation team composed of representatives of the United Nations Conference on Trade and Development, the Commission and the United Nations Development Programme for the continuation of this project, and urgently appeals to the United Nations Development Programme to continue to provide financial assistance at the current or at an increased level for the duration of the Programme's programming cycle 1982-1986."

442(XVII) Formulation and Implementation of a Programme for the Industrial Development Decade for Africa

"11. <u>Urges</u> the Administrator of the United Nations Development Programme to increase, in accordance with the resolutions adopted by the General Assembly and the Organization of African Unity on the Decade, the amount of funds allocated to the industrial sector in its national and regional programme for Africa with a view to expanding the scope and volume of its assistance in the programming and implementation of the Decade programme at the national, subregional and regional levels;"

FURTHER INFORMATION ON OPERATIONAL ACTIVITIES QUESTIONS WITHIN THE UNITED NATIONS SYSTEM

The Governing Body decided:

- "(a) to place on record its serious concern over the downward trend in resources for technical co-operation and to appeal to all concerned with a view to reversing this trend;
- "(b) to request the Director-General to continue to participate actively in inter-agency efforts to increase multilateral development aid including UNDP resources;
- "(c) to request the Director-General to take all possible steps with a view to securing resources for ILO technical co-operation from all sources including multi-bilateral channels, development banks, funds in trust, etc.;
- "(d) to request the Director-General to mobilise the necessary support and goodwill for the above measures through its broad range of contacts with governments, international and national non-governmental organisations, particularly employers' and workers' organizations; and
- "(e) to request the Director-General to inform the Governing Body of the results of these efforts at an appropriate time."

TRIPARTITE PARTICIPATION IN UNDP-FUNDED TECHNICAL CO-OPERATION ACTIVITIES EXECUTED BY THE ILO

The Governing Body asked:

- "(a) the Director-General to bring these arrangements to the attention of governments and, through them, to employers' and workers' organisations while requesting them to give their full support to their practical application; and
- "(b) the Director-General to take all appropriate measures that would facilitate the wider application of these arrangements and to report to the Governing Body at regular intervals on the outcome."

- "2. Takes note of the policy proposals that the Administrator of the United Nations Development Programme (UNDP) submitted to the 29th session of its Governing Council concerning the future role of UNDP, and of the comments of the Director-General on these proposals;
- "3. Recalls the essential role of UNDP as central co-ordinator of the United Nations development system at the field level and welcomes the assurances and clarifications given by the UNDP Representative to the effect that the new policy proposals of the Administrator will not lead to an expansion of the role of UNDP as Executing Agency;
- "4. Expresses the hope that these new proposals will contribute to the maintenance between UNDP and the Specialized Agencies, through close co-operation, of a sharing of tasks taking due account of UNDP's essential central role, as well as of the statutory responsibilities and technical competence of the agencies;

- "5. Welcomes the decision of the Inter-sessional Committee of the Whole of the Governing Council to formally invite the executing agencies to its meetings, and in this connection expresses the hope that full use will also be made of existing inter-agency consultative machinery in future discussions of UNDP policy proposals;
- "6. Expresses its concern at the growing tendency to reduce voluntary contributions to UNDP and the extra-budgetary programmes; and strongly supports the appeals of the Administrator for a substantial and real increase of resources for UNDP, in accordance with relevant decisions of the Economic and Social Council and the General Assembly of the United Nations;
- "7. Recommends that the maximum use be made, in the implementation of UNDP-supported programmes and projects, of the national and regional expertise and consultancy services and facilities available in the developing countries themselves;
- "8. Invites the Director-General to pursue, in conformity with resolution 7/02 adopted by the General Conference at its twenty-first session, his action in support of technical co-operation among developing countries which should be duly stimulated and co-ordinated to complement to the fullest extent possible the resources available within UNDP;"

"Resolves

- "1. that the Union shall continue its full participation in the UNDP, within the framework of the Convention and under the conditions established by the UNDP Governing Council or by other competent bodies of the United Nations system;
- "2. that the administrative and operational service costs resulting from the Union's participation in the UNDP shall be included in a separate part of the Budget of the Union, on the understanding that the support cost payments from the UNDP shall be included as income in that part of the Budget;
- "3. that the support cost payments received from the UNDP shall not be taken into consideration in fixing the limits of the Union's Ordinary Budget;
- "4. that the Union's auditors shall check all the expenditures and income relative to participation of the Union in the UNDP;
- "5. that the Administrative Council shall also examine these expenditures and take whatever steps it deems appropriate to ensure that the funds thus assigned by the UNDP are used exclusively for administrative and operational services costs;

"instructs the Secretary-General

- "1. to present each year to the Administrative Council a detailed report on the participation of the Union in the UNDP;
- "2. to submit to the Administrative Council such recommendations as he may deem necessary to improve the efficiency of this participation;

"instructs the Administrative Council

- "1. to take all necessary measures to ensure the maximumm efficiency of the Union's participation in the UNDP;
- "2. to take into account the decisions of the Governing Council of the UNDP with regard to support cost payments for the Executing Agencies, when establishing the credits required to cover the total administrative and service costs to be incurred as a result of the Union's participation in the UNDP."
- 17. Inter-Country Projects Financed by the United Nations Development Programme (UNDP) in the Field of Telecommunications

"resolves to invite the UNDP

with a view to increasing the technical cooperation in the telecommunication sector and thereby contributing significantly to an

accelerated pace of integration and development, to consider favourably an increase of the allocations to inter-country projects of assistance and to sectoral support activities in this sector;

"invites Member administrations

to inform the governmental authority responsible for coordinating external aid to their countries of the contents of this Resolution and to stress the importance the Conference attaches to it;

"invites those Members of the Union which are also Members of the Governing Council of the UNDP

"to take account of this Resolution in that Council."

19. Special Voluntary Programme for Technical Cooperation

"resolves

to set up a special voluntary programme for technical cooperation based on contributions in currency, training services, or in any other form to meet as much of telecommunication needs of developing countries as possible;

"urges Member countries, their Recognized Private Operating Agencies and Scientific or Industrial Organizations, and other entities and organizations

in close collaboration with the ITU, to make technical cooperation available in whatever form is required to meet the telecommunications needs of the developing countries more effectively;"

20. Establishment of the Independent International Commission for World-Wide Telecommunications Development

"instructs the Secretary-General

1. after prior consultation and in cooperation with Member Governments to propose a list of 15 to 20 representatives of the highest decision-makers from administrations, operating agencies, and industry in the developing and developed countries as well as the major financial institutions (including the development banks and the UNDP) and other appropriate entities, also seeking as good a representation of all the regions of the world as possible;"
