ACTION TAKEN IN 1982 BY ORGANS OF THE UNITED NATIONS AND RELATED AGENCIES

Note by the Administrator

- 1. In accordance with established practice, the attention of the Governing Council is drawn to those resolutions and decisions adopted in 1982 by the General Assembly, the Economic and Social Council and organizations of the United Nations system which call for action by or are of relevance to the Governing Council and the United Nations Development Programme.
- 2. The appropriate operative paragraphs have been quoted of resolutions which require specific action by or are of direct relevance to the Governing Council and UNDP. However, in accordance with Governing Council decision 79/14, the texts of resolutions already referred to in the documentation presented to the Council under other items are not reproduced in the documentation under this item. For those resolutions of general interest to the Governing Council and UNDP, only the titles have been given. This is in line with General Assembly resolution 2836 (XXVI) of 17 December 1971, which states in paragraph 3(d) that "the texts available in easily accessible documents should not be incorporated in or annexed to reports."
- 3. The operative paragraphs of the two resolutions adopted by the General Assembly and the Economic and Social Council in 1982 specifically on UNDP are reproduced separately in section I. The rest of the resolutions are listed in numerical order. Resolutions and decisions adopted by organizations of the United Nations system are contained in the addendum to this document.

I. RESOLUTIONS ADOPTED BY THE GENERAL ASSEMBLY AND THE ECONOMIC AND SOCIAL COUNCIL ON UNDP

A. General Assembly 1/

37/227. Critical situation of financial resources of the United Nations Development Programme

- "1. <u>Takes note</u> of the report of the Governing Council of the United Nations Development Programme for the year 1982 and the decisions contained therein;
- 2. Endorses Economic and Social Council resolution 1982/53 of 29 July 1982, in which the Council, inter alia, took note of decision 82/5 of 18 June 1982 of the Governing Council of the United Nations Development Programme, by which the Governing Council reaffirmed its decisions 80/30 of 26 June 1980 and 81/16 of 27 June 1981, including, in particular, those provisions relating to the indicative planning figures, the assumed over-all average annual rate of growth of voluntary contributions and the level of resources envisaged for the third programming cycle for the purposes of forward planning; and welcomes the establishment of an Intersessional Committee of the Whole to study options and recommendations for the longer-term financing of the United Nations Development Programme and for strengthening the work of the Governing Council;
- 3. Notes with deep concern the result of the 1982 United Nations Pledging Conference for Development Activities and the serious consequences it would have on the proposed programme delivery for the third programming cycle of the United Nations Development Programme;
- 4. Expresses its appreciation to all Governments, of both developed and developing countries, which, at the 1982 Pledging Conference, announced contributions or their intention to contribute to the United Nations Development Programme for 1983 in amounts approaching, equalling or exceeding an average annual increase of 14 per cent in their contributions; and to those Governments which have consistently maintained their contributions at a high level;
- 5. <u>Urges</u> all other Governments, especially those whose voluntary contributions may not reflect their capacity to contribute, to renew their efforts to provide the United Nations Development Programme with the resources necessary to establish a sound financial basis for the implementation of the Programme's planned activities for the third programming cycle, 1982-1986, which, for the purpose of forward planning, would assume an over-all average annual growth of resources of at least 14 per cent;
- 6. Expresses its appreciation to the Administrator of the United Nations Development Programme for his tireless efforts to obtain the necessary level of resources envisaged for the third programming cycle in order to secure the financial viability of the Programme and to improve further the quality, efficiency and effectiveness of the Programme; and encourages the Administrator to continue those efforts, taking into account, inter alia, the need to restrain administrative expendituures in order to maximize programme delivery in accordance with paragraph 4 of Governing Council decision 81/16;

7. Expresses its hope that the Intersessional Committee of the Whole of the Governing Council of the United Nations Development Programme, in accordance with its mandate as set out in decision 82/5, will succeed in identifying measures, in accordance with the principles and objectives as reflected in the consensus, as set forth in the annex to General Assembly resolution 2688 (XXV), that would enable the implementation of the Programme's planned activities for the third programming cycle, 1982-1986, and beyond."

B. Economic and Social Council $\frac{2}{}$

1982/53. Report of the Governing Council of the United Nations Development Programme

- "1. Takes note of the report of the Governing Council of the United Nations Development Programme for the year 1982 and decisions contained therein;
- 2. Expresses its serious concern at the alarming decline in the rate of growth of the resources of the United Nations Development Programme, which threatens its effectiveness with respect to the third programming cycle, 1982-1986, as well as the full implementation of the Substantial New Programme of Action for the 1980s for the Least Developed Countries;
- 3. Takes note of decision 82/5 of 18 June 1982 of the Governing Council of the United Nations Development Programme, by which the Governing Council reaffirmed its decisions 80/30 of 26 June 1980 and 81/16 of 27 June 1981, including, in particular, those provisions relating to the indicative planning figures, the assumed over-all average annual rate of growth of voluntary contributions and the level of resources envisaged for the third programming cycle for the purpose of forward planning;
- 4. <u>Welcomes</u> the establishment of an intersessional committee of the whole to study options and recommendations for the longer-term financing of the United Nations Development Programme and for strengthening the effectiveness of the work of the Governing Council;
- 5. Appeals to all Governments, in particular those whose previous contributions have been below their capacity to pledge, to increase their voluntary contributions, starting with the 1982 United Nations Pledging Conference for Development Activities, so as to achieve an over-all average annual rate of growth of 14 per cent for the third programming cycle, as envisaged by the Governing Council in its decision 80/30;
- 6. <u>Urges</u> all States, particularly donor countries, international financial institutions in a position to do so and other multilateral financial institutions to make all possible efforts with a view to contributing substantially and effectively to the Special Measures Fund for the Least Developed Countries of the United Nations Development Programme and to the United Nations Capital Development Fund, as well as through other suitable channels for the least developed countries, in order to assist in ensuring the timely and full implementation of the Substantial New Programme of Action;

- 7. Endorses the invitation of the Governing Council of the United Nations Development Programme to the General Assembly to consider, during its thirty-seventh session, the financial situation of the Programme and the need to sustain technical assistance to developing coutries through the Programme in the light of the outcome of the 1982 United Nations Pledging Conference for Development Activities;
- 8. Welcomes decision 82/8 of 18 June 1982 of the Governing Council of the United Nations Development Programme, designed to promote government execution of projects assisted by the Programme;
- 9. <u>Invites</u> Governments of recipient countries and urges all organizations of the United Nations system to facilitate the role of the resident co-ordinator in strengthening the co-ordination of all United Nations technical assistance activities in accordance with the consensus of 1970 and in carrying out the tasks assigned to him or her by the General Assembly in its resolutions 32/197 of 20 December 1977, 33/202 of 29 January 1979 and 34/213 of 19 December 1979;
- 10. Reaffirms the need for the United Nations Development Programme and its executing agencies to review their operational support systems, working methods, arrangements and staffing, with a view to bringing about significant reductions in over-all support costs, in order to make more resources available to meet the assistance requirements of developing countries."

- 7. <u>Invites</u> the organs, organizations and bodies of the United Nations system dealing with the flows of concessional resources to developing countries to pay greater attention, in their reviews of these issues, to the funding needs of the United Nations funds and programmes;
- 12. <u>Invites</u> all organs, organizations and bodies of the United Nations system engaged in operational activities for development to adopt appropriate measures leading to a greater use of the capacities of developing countries in local or regional procurement of material and equipment, in training and in services, in facilitating the increased use of local contractors, and in the

recruitment of training, technical and managerial personnel, bearing in mind decision 81/28 of 30 June 1981 of the Governing Council of the United Nations Development Programme;

- 13. <u>Decides</u> that the guidelines on procurement to be issued pursuant to paragraph 7 of Governing Council decision 81/28 and section II, paragraph 2 of Governing Council decision 82/34 of 18 June 1982 should, in due course, govern the procurement activities of organs and bodies under the authority of the General Assembly in their execution of projects financed by the United Nations Development Programme;
- 14. <u>Welcomes</u> decision 82/8 of 18 June 1982 of the Governing Council of the United Nations Development Programme, designed to promote government execution of projects assisted by the Programme, and the real savings that could result therefrom;
- 15. <u>Invites</u> the Administrator of the United Nations Development Programme and the President of the World Bank to examine the possibilities of further co-operation between the Programme and the World Bank regarding utilization of facilities available to the two organizations, and requests the Administrator to report thereon to the Governing Council of the United Nations Development Programme;

Takes note of the measures being pursued to reduce costs and to improve efficiency described in the Director-General's report, and urges the Secretary-General and the executive heads of organs, organizations and bodies of the United Nations system to seek to minimize administrative and other support costs without affecting the field programmes and the network of the United Nations Development Programme offices in developing countries and bearing in mind the need to maintain an appropriate level of support functions, with a view to increasing the proportion of resources available to improve the programme delivery to developing countries;
- 19. Requests the organs and bodies of the United Nations receiving resources of an extrabudgetary nature, such as support cost payments, to include information on these resources and their utilization in the reports to their governing bodies, and invites the governing bodies of the organizations of the United Nations system receiving support cost payments from Governments and voluntary funds to examine information thereon;

- 20. Requests the Director-General to report on the implementation of paragraphs 18 and 19 of the present resolution and to include in his comprehensive policy overview a comparative analysis of the relationship between programme delivery and administrative costs pertaining to operational activities for development executed by organs, organizations and bodies of the United Nations system;
- 21. <u>Urges</u> all organs, organizations and bodies of the United Nations system, in the light of the recommendations contained in section III of the Director-General's report, to take the necessary steps to ensure the harmonization of administrative, financial, personnel, planning and procurement procedures, and requests the Administrative Committee on Co-ordination to report, in its annual overview report of 1984, on specific action taken;
- Reiterates the importance of co-ordination of multilateral development assistance at the field level, and requests the Director-General to pay particular attention in the comprehensive policy review of operational activities of 1983, to the need for improved coherence of action and effective integration at the country level in accordance with section V of the annex to resolution 32/197 and paragraph 11 of resolution 35/81, including a report on measures taken to date in this regard, together with his recommendations thereon, with specific reference to the role of resident co-ordinators in the co-ordination of operational activities of the United Nations system;
