# Provisional agenda and organization of work

### Note by the secretariat

- 1. In accordance with Governing Council decision 81/37, paragraph 4(a), this document contains, in annexes I and II, the provisional agenda and organization of work for the meeting of the Budgetary and Finance Committee at the thirtieth session of the Governing Council of UNDP.
- 2. The Council, at its organizational meeting on 14 February 1983, allocated items 7(a) through 7(g), and those financial and administrative aspects of items 6(b), UNFPA, 6(c), UNV, and 6(i)(i), UNSO: Plan of action to combat desertification in the Sudano-Sahelian region, to the Committee for its consideration.
- 3. As agreed by the Council at its organizational meeting in connection with the plenary's schedule of work, it is understood that if consideration of an item by the Committee has been completed before the date indicated, a subsequent item can begin immediately.
- 4. In accordance with decision 82/35, the Budgetary and Finance Committee will consider during its meeting commencing immediately prior to the thirtieth session of the Governing Council those parts of the financial regulations (decision 81/28) and other questions on which consensus was not achieved at the twenty-ninth session of the Council with a view to facilitating resolution of these issues by the Council. The matters to be considered by the Committee in this connection consist of the Administrator's proposed financial regulations 3.5, 3.6, 12.3, 12.4 and the newly proposed regulation 3.6, as well as the bracketed subparagraphs 8(b) and 8(c) of Council decision 81/16. Provision has accordingly been made in the provisional schedule of work for consideration of these matters on the first day of the Committee's meetings, and for the Committee to revert to these matters again towards the end of the session.
