Working paper by the Chairman of the Drafting Group

- 1. By its decisions 81/37 and 83/42, the Governing Council agreed that the Drafting Group would elaborate and finalize draft decisions on items referred to it by the plenary for the ultimate adoption of such draft decisions by the Council. All draft decisions formulated by the Drafting Group having financial implications would have to be referred to the BFC before action is taken by the Council. The Council may also assign the Drafting Group other specific tasks, as required.
- 2. By its decision 84/1, section IV, the Council confirmed the principles contained in section III of its decision 83/1 which shall guide the deliberations of the Drafting Group. It was thereby agreed inter alia that the Chairman of the Drafting Group would circulate working papers containing preliminary draft decisions prepared, at his request, by the secretariat to facilitate the work of the Drafting Group. The Chairman is hereby circulating a working paper with draft texts. Other draft texts will be circulated, as appropriate, in addenda to this document.
- 3. It should be emphasized that this working papers does not pre-empt the submission of draft decisions by the delegations on the subject contained in it. In cases where both delegations and the Chairman have circulated draft texts, precedence will be given to texts of delegations, as decided by the Council.

- It may be recalled that the Council agreed that this draft decision would initially be taken up by the Drafting Group, without precluding the possibility, however, that at a later stage this draft decision might be taken up and finalized by a separate negotiating group, should this prove to be necessary.

The Governing Council,

Reaffirming the critical role of technical co-operation in promoting self-reliance and building human resources in developing countries and the unique contribution of UNDP to this effort,

Reaffirming also the central and co-ordinating role of the United Nations

Development Programme as the leading body for technical co-operation within

the framework of the United Nations,

Recognizing the importance of ensuring that the technical co-operation activities of the United Nations system remain responsive to changing development needs and are geared to the specific requirements of individual countries.

Recognizing also the necessity to continue the examination of ways in which the provision of technical co-operation by UNDP in addressing those needs can be made more effective,

Recalling General Assembly resolutions 2688 (XXV) of 11 December 1970 on the capacity of the United Nations development system and 3405 (XXX) of 28 November 1975 on the new dimensions in technical co-operation, together with their annexes.

Recalling also General Assembly resolution 35/56 of 5 December 1980 stressing, inter alia, the important role to be played by technical co-operation in the International Development Strategy for the Third United Nations Development Decade,

Recalling further General Assembly resolutions 32/197 of 20 December 1977 on the restructuring of the economic and social sectors of the United Nations system and 35/81 of 5 December 1980 on a comprehensive policy review of operational activities for development, and General Assembly resolution 37/226 of 20 December 1982 on operational activities for development of the United Nations system and the role of UNDP therein,

Sharing the deep concern expressed by Governments and by the

Administrator of UNDP that UNDP be adequately financed and equipped to

meet the changing technical co-operation requirements of developing

countries,

Taking note of the report of the Administrator on measures to be taken to meet the changing technical co-operation requirements of developing countries (DP/1984/4) and the relevant parts of DP/1984/5, the Annual Report of the Administrator for 1983, and the comments of Governments thereon,

1. Notes the Administrator's findings on the continuing need for technical co-operation and on the changing requirements for such co-operation which call for new measures and adaptations on the part of UNDP.

The Governing Council,

Having considered the report of the Joint Inspection Unit on the Office for Projects Execution of the United Nations Development Programme (OPE) (JIU/REP/83/9),

Taking note of the comments of the Administrator, in document DP/1984/8, of the other organizations of the United Nations System in document DP/1984/74, and of the Secretary-General in document A/39/80/Add.1,

Recalling paragraphs 38 - 42 of General Assembly resolution 2688 (XXV) of 11 December 1970 on the responsibility of the Administrator in consultation with Governments to select the agent by which Programme assistance to each project will be implemented,

Recalling further the Administrator's full responsibility and accountability for all phases and aspects of the implementation of the Programme,

- 1. Does not accept Recommendation 1 made by the Unit;
- 2. Accepts Recommendation 2 made by the Unit;

- 3. Welcomes the Administrator's announcement on the principle of partnership and on providing the best possible service to developing countries;
- 4. Reaffirms that the Office of Projects Execution has been established with the full approval of the Council in recognition of the need of the Administrator to have at his disposal an appropriate instrument for providing direct project services to Governments;
- 5. Approves the continued use of the Office for Projects Execution as an agent for the implementation of projects where the Administrator decides in consultation with the Government that the expertise or services required are such that the delivery of service through the Office for Projects Execution will best serve the interests of the country concerned; and
- 6. Requests the Administrator to pursue vigorously the goal of selfreliance as expressed in the Governing Council decision on the New
 Dimensions for Technical Co-operation of 25 June 1975 and endorsed by
 the General Assembly by resolution 3405 (XXX) by promoting the modality
 of government execution and the innovative use of the Office of Projects
 Execution as a co-operating organization.

The Economic and Social Crisis in Africa
(Agenda items 4(a) and 4(c))

The Governing Council,

Recognizing with deep concern the economic and social crisis in Africa, aggravated, inter alia, by recent years of severe climatic conditions,

Recognizing further the serious consequences directly affecting a large part of the African population as well as the prospects for economic growth, development and the attainment of self-reliance,

Conscious of the particular burdens and severe difficulties faced by most African Governments, and, as a result, of their need for appropriate, intensive and sustained co-operation with and support from UNDP, other multilateral and bilateral aid partners, and the international community,

Taking note with appreciation of the Secretary-General's special initiatives undertaken in response to the economic and social crisis in Africa and of the close collaboration and support provided to the Secretary-General by the Administrator in this regard,

Taking note also of the Administrator's report on the implementation of

selected country programmes in the Africa region, 1983 (DP/1984/22) and of his comments on this subject in his introductory statement,

Taking note further of document DP on UNDP activities in the Africa region during the past year, as well as on the outlook for those activities,

- 1. Reaffirms the importance of the central co-ordinating role of UNDP in assisting African Governments to meet their urgent needs as well as their medium-term and long-term technical co-operation development requirements;
- 2. <u>Urges</u> Member Governments, organizations of the United Nations development system and multilateral programmes to make use, as appropriate, of the capacity of the Resident Co-ordinator and the UNDP field network for the improvement of the co-ordination of technical co-operation activity at the country level;
- 3. <u>Invites</u> the Administrator to continue to assist Governments, at their request, in strengthening their national planning and co-ordination capabilities;
- 4. <u>Further invites</u> the Administrator to continue his efforts at closer collaboration with the World Bankand with other organizations of the United Nations development system, in such areas as programming and co-ordinating assistance flows, resource mobilization and development of priority activities which could help alleviate the current economic and social crisis in Africa;
- 5. Notes with appreciation the increasing effectiveness with which round-table conferences of donors have been organized with UNDP assistance in the Africa region in order to increase the flow of development resources and to improve aid co-ordination and requests

the Administrator to provide all possible support to future roundtable conferences and to follow-up activities including the donor consultations which are being undertaken by an increasing number of African countries:

- 6. <u>Urges</u> donor countries to support the efforts of African countries, through UNDP and such other funds and programmes under the Administrator's authority as the United Nations Sudano-Sahelian Office, the United Nations Capital Development Fund and the United Nations Volunteers, to plan and implement development projects and longer-term development programmes designed to deal with the consequences of drought, famine, the shortfall of internal and external financial resources, as well as other aspects of the current economic and social crisis in Africa;
- 7. <u>Urges</u> all multilateral and bilateral aid partners, including non-governmental organizations, to consider supporting priority development projects related to the economic and social crisis in Africa through co-financing and other cost-sharing arrangements with UNDP;
- 8. Requests the Administrator to take all appropriate measures to effectively support the ICARA II Conference and, if so requested, to assist in the elaboration and implementation of developmental projects included in the Conference's programme;
- 9. Supports the Administrator's initiative to channel on an immediate and exceptional basis an increased number of United Nations volunteers to the most severely affected countries in Africa, to augment their indigenous infrastructure with technical personnel to handle the material assistance being provided from a variety of sources to face the current situation of economic crisis;
- 10. Endorses the Administrator's intention to review the capacity of

additional workload arising from the evolving circumstances and increased responsibilities which were not foreseen at the time of the Headquarters and Field Office Staffing Survey, and to present to the Council at its thirty-second session recommendations on how field offices in Africa may be better equipped to cope with the realities of the current economic and social crisis in Africa; and

11. Notes with appreciation the speedy action taken by the Administrator to implement General Assembly resolution 38/201, paragraph 1(a), the major part of the funds under which has been applied, in accordance with that resolution, to finance urgently needed projects in countries affected by famine and malnutrition in Africa.

The Governing Council,

Having considered the Progress Report of the Administrator on pre-investment activities (DP/1984/11),

Reiterating its invitation to Governments, to give due priority to preinvestment activities in their country programming,

- (a) Notes the progress made in financing feasibility studies from the special account of \$1 million from Special Programme Resources;
- (b) Endorses the efforts of the Administrator and the Agencies to increase pre-investment activities under the co-operative arrangements;
- (c) Takes note of the relationships established between UNDP and sources of development finance to promote complementarity of programming and follow-up investment to UNDP assisted pre-investment activities and requests the Administrator to intensify such relationships and consider broadening their scope to include other sources of finance; and

(d) Notes the progress under the training programmes in pre-investment at the Economic Development Institute of the World Bank for staff of UNDP and United Nations System Organizations and at the Asian Development Bank for UNDP staff and host Government counterparts and requests the Administrator to continue such training.

Mid-term review of the third programming cycle, 1982-1986
(Agenda item 5(a))

The Governing Council,

Having considered the report of the Administrator on the mid-term reivew of the third programming cycle (DP/1984/20 and Add.1),

- 1. Notes the Administrator's review of the voluntary contributions experience, noting in particular that voluntary contributions over the past four years increased, on the average, by 7.2 per cent annually in pledged currencies but declined, on the average, by 1.2 per cent annually expressed in US dollars;
- 2. Also <u>notes</u> the Administrator's projection of resumed growth in voluntary contributions for the years 1985 and 1986, although at a level far below the one envisaged for the cycle;
- 3. <u>Urges</u> all countries who are in a position to do so, to increase their contributions to the Programme to achieve adequate real growth of the resources of the Programme during the remaining years of the third programming cycle;
- 4. <u>Takes note with appreciation</u> of the Administrator's actions to maintain the Programme within available financial resources and thus

safeguard the financial integrity of the Programme, including the actions taken to reduce the staffing and other administrative costs to a level commensurate with the lower level of the Programme:

- 5. Furthermore takes note with satisfaction of the increasing amounts of cost sharing by recipient Governments and third parties which in many programmes have offset the unavoidable reductions in programming levels:
- 6. <u>Decides</u> that no meaningful general review of IPFs can be made under the current resource situation, nor is there any room for reconsideration of the IPFs of those countries whose real economic situation had deteriorated substantially from 1978 levels as any upward adjustment would have to be accompanied by corresponding reductions in other programmes;
- 7. Notes that the Administrator has been able to implement Council decision 83/14, section VI, in respect of the programme levels of countries with small TPFs, as the modest amounts involved made this possible:
- 8. Notes the Administrator's actions to increase the resource flows to and improve the co-ordination of UNDP's activities for the least developed countries;
- 9. <u>Decides</u> that for the purpose of determining the carry-forward to the fourth cycle, the norm against which positive or negative carry-forwards would be calculated shall be derived using the 55 per cent of the Illustrative IPF, except for those smaller IPFs covered by decision 83/14, as implemented;
- 10. Furthermore <u>approves</u> the proposed conditions for borrowing from fourth cycle IPFs as follows:
- (a) Borrowing will be authorized only to such an extent that it does not threaten the financial integrity of the Programme and that total

expenditures are kept within available resources,

- (b) Borrowing will be authorized only for countries in a region up to a maximum of expected under-expenditures in the third cycle in respect of other countries in the region,
- (c) Borrowing will be authorized only for countries where the fourth cycle IPF is expected to be larger than the third cycle illustrative IPF (at 55 per cent),
- (d) Borrowing will be authorized only up to a maximum of 15 per cent of the third cycle illustrative IPF (at 55 per cent) for each country qualifying for borrowing,
- (e) Borrowing for inter-country programmes will be allowed only up to the estimated extent of underspending in other inter-country programmes and not to exceed 15 per cent of each third cycle illustrative IPF (at 55 per cent). For the purpose of borrowing from the fourth cycle the global and interregional programmes may be counted together as recommended in DP/1984/20/Add.1,
- (f) In all cases the borrowed amount will constitute a first charge against the corresponding fourth cycle IPF,
- (g) The Administrator will report to the Governing Council on his use of selective borrowing from the fourth cycle,
- 11. Approves a pro-rated illustrative IPF for St. Helena of \$330,000 for the years 1984-1986;

12. Takes note of

(a) the continued lack of adequate data to calculate illustrative IPFs for Democratic Kampuchea and Lebanon for whom provisional illustrative IPFs of \$25.5 million and \$10 million respectively will remain in effect until sufficient data are available,

- (b) the fact that while revised data was available only for Hungary, the illustrative IPF for Hungary remains unchanged at its "floor" level, namely \$3.5 million,
- (c) the accession to independence by Brunei and the consequent revision of its illustrative IPF to \$730,000; and
- 13. Takes note of the Administrator's report on movement towards net contributor status as outlined in decision 80/30 paragraph 6(e) and urges those countries who have not made progress towards those targets outlined in the above decision to increase their efforts to do so.

Recalling its decision 79/18 of 26 June 1979, 81/13 of 23 June 1981, 82/13 of 18 June 1982, 83/11 of 24 June 1983 and the relevant provisions of General Assembly resolutions,

Reaffirming the commitment of UNDP to assist the Palestinian people in advancing their economic and social development,

Taking note of the report of the Administrator on the programme of assistance (document DP/1984/16),

- 1. Expresses satisfaction with the efforts of the Administrator in assisting the Palestinian people in the West Bank and the Gaza Strip;
- 2. <u>Notes with regret</u> that previous appeals by the Council and the General Assembly for additional special contributions amounting to at least \$8 million in the third programming cycle have only drawn a very modest response so far;

- 5. LIQUIDATION OF UN EMERGENCY OPERATION TRUST FUND

Action taken to implement General Assembly resolution 38/201
(Agenda item 4(c)(v)

The Governing Council,

Having considered the report of the Administrator on action taken by him to implement General Assembly resolution 38/201 dealing with the liquidation of the United Nations Emergency Operation Trust Fund and allocation of its remaining balance (DP/1984/71 and Add.1) and the further information proviously by the Administration,

1. Expresses its satisfaction at the speedy action taken by the Administrator, in pursuance of paragraph 1(a) of General Assembly resolution 38/201, in approving assistance to urgently needed projects, primarily in the food and agricultural sectors in countries afflicted by famine and malnutrition as a result, particularly, of severe or prolonged drought, with special emphasis on African countries;

- 2. The Governing Council,

Keeping in view the needs of all developing countries for increased technical co-operation, with the ultimate aim of achieving national and collective self-reliance as one of the means towards establishing the new international economic order,

Taking into account, in particular, the needs of the low-income countries, the least developed, land-locked and island developing countries, those facing serious economic problems or suffering from acute ecological and geographical disabilities and newly independent countries, as well as those on their way to independence,

Recalling General Assembly resolutions 3201 (S-VI) and 3202 (S-VI) of 1 May 1974, containing the Declaration and the Programme of Action on the Establishment of a New International Economic Order, and 35/36 of 5 December 1980, containing the International Development Strategy for the Third United Nations Development Decade,

Bearing in mind the role of the United Nations Development Programme in multilateral technical co-operation for the economic and social development of developing countries as defined by the General Assembly in its resolutions 2688 (XXV) of 11 December 1970 and 3405 (XXX) of 28 November 1975,

Affirming the role of the Programme as the central funding mechanism within the United Nations system for technical co-operation,

Reaffirming the basic principle of the universal and voluntary nature of the Programme,

Recalling decision 83/5 of the Council on measures to mobilize increased resources for the United Nations Development Programme on an increasingly predictable, continuous and assumed basis,

Having considered with appreciation the report of the Administrator (DP/1984/27) concerning preparations for the fourth programming cycle,

Bearing in mind the comments and observations made during the discussion of this item in the Plenary meetings of the Council, and its decision 1984/ dealing with measures to be taken to meet changing technical co-operation requirements.

- 1. Endorses the proposed time-table for the Council's actions in the preparations for the fourth programming cycle, including the possibility of a special meeting in February 1986;
- 2. <u>Decides</u> to maintain for the fourth programming cycle a five-year planning period to cover the years 1987-1991 inclusive;
- 3. Recognizes that the rolling five-year programme planning and control system established by the Administrator for the internal management of the Programme has enabled the Administrator to maintain sufficient and flexible control of the Programme's resources in the absence of an assured contributions base to match five-year-programme commitments;

Approves the Administrator's proposal to express the resource target for the fourth cycle as a range with a minimum target based on the assumption that donors will maintain the real value of their contributions and an upper target based on an agreed annual increase, with all planned levels of uses of resources, with the exception of the UNDP biennial budget which will be determined separately, also to be expressed as a range: and requests the Administrator to present alternative calculations to the thirty-second session of the Council on the above pattern and based on the informal consultations envisaged in decision 83/5 I(b).

Para. 4 alternative 2

- <u>74. Decides</u> that, for the purpose of forward planning, one single assumption will be made for the target level of resources to be available to the Programme during the fourth programming cycle 1987-1991, and that the Administrator will present alternative calculations to the thirty-second session of the Governing Council based on the informal consultations envisaged in decision 83/5 I(b);
 - 5. A paragraph on the Operational Reserve to be added based on BFC recommendation.
- 6. Requests the Administrator to follow, for the overall distribution of resources for the fourth programming cycle, essentially the same guidelines as for the third cycle, taking account of the following additional points:
- (i) The scope and size of Special Programme Resources may be enlarged to include a provision for the Administrator to respond to urgent needs of

- 7. Approves the continued use of per capita GNP and population as the basic criteria for calculation of individual country IPFs, together with the following supplementary criteria:
- (i) The special needs of least developed countries land-locked countries, island developing countries, newly independent countries and countries suffering from acute ecological and geographical disabilities;
- (ii) A country's cumulative debt burden and over-all balance of payments deficit and the chronic deterioration of terms of trade,
- 8. <u>Decides</u> that World Bank data on population and on per capita GNP shall be used in the calculations in all cases where they are available; otherwise, the Administrator shall determine and use the best estimates available, taking into account estimates of the Statistical Office of the United Nations Secretariat as well as from other reliable sources;
- 9. Further <u>decides</u> to retain for the fourth programming cycle the current methodology for the calculation of regional IPFs with the following supplementary criteria:
 - (a) The number of least developed countries in the region;
 - (b) The number of land-locked countries in the region;

- (c) The number of newly independent countries in the region;
- (d) The rate of physicians per 1,000 population;
- (e) The literacy rate;
- (f) The share of industry in GNP;
- (g) The number of island developing countries in the region;
- (h) The number of countries suffering from acute ecological and geographical disability in the region,
- 10. Requests the Administrator to arrange, in accordance with Council decision 83/5, I(b), informal consultations during the latter half of 1984 to be held among all participating Governments to discuss the size of the resources to be taken into account for the next programming cycle,
- 11. Requests the Administrator to consult individually with the Governments concerned regarding their achievement of net contributor status, taking into account for this purpose contributions made by them to the central resources of UNDP, to voluntary programme costs and to local office costs;
- 12. Requests the Administrator to prepare, for presentation to the thirty-second session of the Council, using in general the methodology followed for calculating the third cycle illustrative IPFs, illustrative calculations of individual country IPFs for the fourth programming cycle under various assumptions of resources for that period in the light of the informal consultations mentioned above, and similarly provide illustrative calculations of inter-country IPFs,

Taking note with appreciation of the report of the Secretary-General on United Nations Technical Co-operation activities (DP/1984/42, and Add. 1-3) and recalling its decision 83/16,

Commends the Department for the streamlining of its organizational structure and for the reduction of its administrative costs, and endorses the Department's efforts to promote a more integrated approach to programme and project management, and to improve further its processes and procedures with a view to achieving greater effectiveness and efficiency in the delivery of its services to developing countries;
- 2. Notes with concern, however, the decline in the availability of resources which are necessary to maintain DTCD-executed programmes and projects of vital interest to developing countries, and the resulting drop in overhead earnings which the Department requires in order to retain its technical expertise in a wide range of key economic and social sectors;
- 3. Reiterates once more its request that necessary action be completed, in pursuance of General Assembly resolution 32/197, to strengthen the role

of the Department, as the main operational arm of the United Nations

responsibilities;

Further invites, following General Assembly resolution 38/171, financial and funding institutions such as UNDP, UNFPA and the World Bank to take full account of the Department's special competence, experience and operational capability in the designation of executing agent for projects which they may fund in fields where DTCD has recognized expertise, with a view to improving co-ordination of activities and reducing administrative costs otherwise incurred in the creation of duplicate operational and managerial capabilities;

Reaffirms its support for the programme of work of the DTCD under the Regular Programme of Technical Co-operation, and endorses the more flexible use of the Regular Programme as seed money for innovative activities, including pilot projects which could lead to larger scale projects funded from other sources, as well as for the Department's programme of interregional advisory services in meeting the needs of the least developed, island developing, land-locked developing and other particularly disadvantaged countries;
- 6. Endorses the Department's efforts to develop appropriate programmes, particularly in the areas of institution building, training, and development of human and natural resources, in support of the Secretary-General's initiative for Africa; and
- 7. Recommends that in order to increase the access of the United Nations to funds allocated for technical co-operation by financial institutions such as the World Bank, consideration be given to

establishing within the Department a pre-financing facility which would cover the initial cost of project formulation and recruitment of experts, on a reimbursable basis once loans become effective; and

8. Recommends, in order to enable the Department to serve the interest of developing countries and to increase for that purpose access to funds allocated for technical co-operation by financial institutions such as the World Bank, that consideration be given to establishing within DTCD a flexible mechanism or facility to cover the initial cost of project formulation and recruitment of experts, on a reimbursable basis once loans become effective.

Notes with satisfaction the trends in the proportion of assistance allocated to the priority programme areas outlined in decision 81/7, I, paragraph 3, as reflected in the annual report of the Executive Director for 1983 (DP/1984/28, Parts I and II) and expresses the hope that these trends will continue, keeping in mind the specific needs of individual countries and the role of women in population activities;
- 2. Also notes with satisfaction the increase in 1983 by the United Nations Fund for Population Activities in the proportion of population assistance going to the priority countries and especially in the Fund's achievement of the goal of devoting up to two-thirds of country programme assistance to the priority countries for population assistance from the Fund;
- 3. Expresses concern about the decrease in the implementation rate for 1983; urges the Executive Director to take all necessary steps to improve the implementation rate in 1984 and future years, and notes the intention of the Executive Director to present to the Council at its thirty-second session a report analysing the obstacles to, and measures to be taken towards improving project implementation and monitoring;
- 4. Takes note with appreciation of the report on the evaluation activities of UNFPA (DP/1984/33); endorses the methodology for future evaluation activities as outlined in the document, as well as the need for training in evaluation at all levels; and recalls the report to be made to the Council at its thirty-third session on the comparative results of past evaluations, according to the major work plan categories, including activities related to women, as requested in decision 83/17, I, paragraph 7;

- 5. Expresses its appreciation for the reports on programme planning (DP/1984/34) and programming procedures (DP/1984/35 and Corr.1) and, taking into account the views expressed by Council members, requests the Executive Director to further improve programme planning and programming procedures;
- 6. Expresses its appreciation for the report on the programmes of the regional and interregional demographic training and research centres (DP/1984/41); urges continued assistance to such centres, taking into account the particular needs of the centres located in Sub-Saharan Africa, and requests the Executive Director to provide a progress report to the Council at its thirty-third session on the extent to which these centres have incorporated the principles for future training programme direction including steps taken by such centres to achieve self-reliance;
- 7. Requests the Executive Director to continue his efforts to reduce the proportion of assistance from the Fund allocated to intercountry activities:
- 8. Expresses its appreciation to all donors to the UNFPA, and urges all countries that are able to do so to increase their contributions to the Fund;
- 9. Also urges governments to make payments of their contributions to the Fund as early as possible; and
- 10. Approves UNFPA assistance to the large-scale country programmes or projects for: Central African Republic (DP/FPA/PROJECTS/REC/9), Togo (DP/FPA/PROJECTS/REC/10), Zambia (DP/FPA/PROJECTS/REC/11), China (DP/FPA/PROJECTS/REC/12), Viet Nam (DP/FPA/PROJECTS/REC/13), Dominican Republic (DP/FPA/PROJECTS/REC/14), and Peru (DP/FPA/PROJECTS/REC/15) and DP/FPA/PROJECTS/RECS/9-15/Corr. 1.

Taking note of the report of the Executive Director on UNFPA strategy for support of contraceptive research (DP/1984/36),

- 1. Approves the general principles outlined in section I of the document;
- 2. <u>Decides</u> that the level of the UNFPA contribution to the World Health Organization/Human Reproduction Programme should be fixed at \$2 million for 1985;
- 3. Approves the strategy for funding contraceptive research set forth in paragraph 19 of DP/1984/36; and
- 4. Requests the Executive Director to present to the Council at its thirty-second session a brief report on the results of the recommendations of the Policy and Co-ordination Committee of the WHO/HRP together with a recommendation for the level of UNFPA funding for the WHO/HRP for the period 1986-1989;

III.

Expressing its appreciation for the update of the review and reassessment and the Work Plan for 1985-1988 and request for approval authority (DP/1984/31), commending the Executive Director for his cautious approach in forward planning, and agreeing to the intended distribution of new programmable resources between country and intercountry activities for the years 1985-1988;

- 1. Approves the update of the review and reassessment contained in the report of the Executive Director (DP/1984/31) as well as the principles listed therein, and the Work Plan for 1985-1988, on the understanding that the Executive Director will limit approval of projects to available resources, and also approves net additional approval authority in accordance with the Work Plan in the following amounts:
- (a) For 1984, an additional \$3.8 million to bring the total for 1984 to \$142 million;
- (b) For 1985, \$48.4 million to bring the total for 1985 to 100 per cent

- (c) For 1986, \$44.9 million to bring the total for 1986 to 75 per cent of the 1985 level or \$114.0 million;
- (d) For 1987, \$41.5 million to bring the total for 1987 to 50 per cent of the 1985 level or \$76.0 million; and
 - (e) For 1988, \$38.0 million or 25 per cent of the 1985 level;
- 2. Expresses its appreciation for the report on the status of financial implementation of Governing Council-approved UNFPA country programmes and projects (DP/1984/32) and requests that similar reports be provided in future years as an annex to the Work Plan and request for approval authority; and
- 3. Further requests the Executive Director in the next Work Plan to report on intercountry activities by work plan categories.

IV.

Noting the suggestions and recommendations from several intergovernmental conferences and meetings in the context of preparations for the International Conference on Population, on the role of the United Nations in population activities, with particular reference to strengthening of the activities of UNFPA,

- 1. Requests the Executive Director to report to the Council at its thirty-second session on the implications of the recommendations of the International Conference on Population for the activities of UNFPA; and
- 2. <u>Invites</u> the Secretary-General, pursuant to the International Conference on Population, to take into account the views of the Governing Council in the study and examination of ways and means to ensure the more effective delivery of population assistance by the United Nations system.

Draft decision on convening of an international congress on human resources development

The Governing Council

- Takes note with appreciation of the statement made by the Administrator emphasizing the need for convening of a world conference on human resources. development to consider in a multidisciplinary way the critical importance of a mil heightened human capacity in the development process;
- Recognizes that one of the main constraints on economic and social development of developing countries is the gap in skilled human infrastructures and in the availability of appropriately-trained personnel and effective institutional structures;
- Recognizes also that physical capital formation and other non-human resources cannot by themselves produce self-reliant, self-sustaining and selfgenerating economic and social development and that durable development cannot be achieved without synchronized and more effective human resources development;

- 4. Convinced that the enhancement of the quality and level of human skills in all sectors, the establishment of creative educational and training systems, the improvement in public and private sectors of management capability and capacity, productivity and negotiating skills, adaptability to the new technological advancements and acquisition of high technological knowledge, the capacity to respond to new and changing technical, economic and social needs by the people of developing countries are essential to strengthen development prospects in all sectors
- 5. Recommends to the thirty-ninth session of the General Assembly to consider convening in early 1987 an international congress on human resources development open to all States. The objective of this congress should not be to reach general conclusions, but to take stock and exchange information on the accumulated experiences and knowledge in this field. The Congress' main findings should be summarized in a report. To accomplish this objective, the congress should examine, on the basis of practical, technical and scientific information, inter alia:
- (a) Issues relating to human resources building in the development process of developing countries, including:
 - (i) reasons for the failure to achieve greater progress in the enlargement of human skills and capacities in developing countries to date, with particular attention to the policies governing and priorities assigned to human resource development by developing countries;
 - (ii) in-depth inquiry as to whether traditional techniques for human resources development are adequate to the challenge; and

- (iii) identification and dissemination of information about particularly successful techniques of approaching human resources development problems;
- (b) Issues relating to human resources development in developing countries arising from adaptation to new technological advancements and high-level technology;
- (c) Role and responsibilities of different parties in the development of human resources;
- (d) Role and methods of technical co-operation in strengthening the capacity of the developing countries to identify and meet their changing human resources development needs.
- 6. Requests the Administrator to prepare a report in consultation with member governments, in order to assist the General Assembly in the consideration of the convening of an international congress on human resources development in developing countries. The report should address:
 - (a) The need for such a congress and its specific objectives;
- (b) The key issues for human resources building in developing countries which the congress should address;
- preparation and actual activities, including for example a multidisciplinary approach, means of taking account of different regional needs, and means of involving internationally-known experts, the private sector, universities and other non-traditional sources to assure the widest possible access to useful technical information, while avoiding cumbersome and costly practices:
 - (d) A timetable for congress preparations; and

- (e) Preliminary financial implications, including a minimal budget.
- 7. Recommends to the General Assembly that:
- (a) The Governing Council of the UNDP, either in its existing membership or enlarged form, should serve as the Preparatory Committee for such a congress;
- (b) New and innovative approaches should be applied in the preparation of the congress in order to ensure its success, widest possible dissemination of useful technical information, and to avoid cumbersome and costly practices; and
- (c) All appropriate elements of the United Nations system should fully co-operate and assist in the preparation of the congress and in the congress itself.
