Information on United Nations system regular and extrabudgetary technical
co-operation expenditures in 1984 financed from sources other than UNDP

Report of the Administrator

Summary

The present report is the latest in a series presented to the Governing Council each year since 1973. It responds to decision 81/34 in which the Council requested the Administrator to continue to provide information to it on technical co-operation expenditures for organizations in the United Nations system which are financed from sources other than UNDP.

The report is divided into four sections dealing with:

- (a) The coverage of the report and the nature of the data contained in it;
- (b) Characteristics of the 1984 expenditure data provided by the specialized agencies and the International Atomic Energy Agency (IAEA);
- (c) Data on the contributions received by the agencies in support of extrabudgetary technical co-operation activities in 1984;
- (d) Data which have been made available from other organizations on operational activities in 1984.

Detailed data provided by the United Nations, the specialized agencies and IAEA on their non-UNDP-financed technical co-operation expenditures are contained in annex tables 1-8. These data are provided by agency, by sector, by recipient country and by source of financing. The country-by-country estimates of United Nations system expenditures on operational activities in 1984 are contained in annex table 8.

Introduction

1. Since 1973, the Administrator has provided the Governing Council with an annual report on the magnitude and composition of the technical co-operation activities of the organizations in the United Nations system funded from sources other than UNDP. In 1981, the Council requested, in its decision 81/34, 1/ that the Administrator continue to provide such data to it, until alternative arrangements for the provision of such data had been made in the United Nations system. Consequently, and in the absence of such arrangements, the present report contains data on the specialized agencies and IAEA in 1984. As in previous years, these entities have co-operated with UNDP in the preparation of this report by providing the data relating to expenditures and contributions contained in the annex. In addition, this report continues the practice of presenting expenditure data made available by two non-technical co-operation bodies, namely the United Nations Children's Fund (UNICEF) and the World Food Programme (WFP), as well as certain data on disbursements made by the World Bank and the International Development Association (IDA). Sections I and II below contain a brief analysis of these data together with a preliminary overview of the total United Nations system expenditures on operational activities for development in 1984.
2. Five years ago, the format underwent extensive revisions in order to improve the coverage of the report and to ensure that the data therein could be used as an input to the annual reports on, as well as the comprehensive policy reviews of, operational activities for development of the United Nations system presented by the Director-General for Development and International Economic Co-operation, 2/ as well as to relate its data to those contained in the report of the Secretary-General on United Nations technical co-operation activities, presented each year to the Governing Council. 3/ The format used in the presentation of data in this report is the same as was used last year.
3. As in previous years, a questionnaire was sent to the participating and executing agencies requesting information on (a) technical co-operation expenditures against their regular budget and extrabudgetary sources other than UNDP; and (b) contributions received by them in support of these activities. In order to improve the quality and coverage of the data in the present report, as well as to minimize the danger of double-counting of the data, agencies were asked not to provide data on expenditures incurred by them against UNDP-administered funds and the United Nations Fund for Population Activities (UNFPA), since these data are being obtained from the funding organizations. In those cases where data on such expenditures were reported on, and identified as such, the data made available by the funding organization were substituted for those reported by agencies.
4. The funding sources according to the classification scheme agreed to by the agencies in 1979 have been adopted by all agencies. In the case of the World Health Organization (WHO), since it is subject to biennial budgeting and accounting (1984-1985 being the prevailing period), figures reported for 1984 represent disbursements made during 1984 and are provisional. They will be

reviewed in the next report. All WHO data reflect criteria for technical co-operation established by its Executive Board and the World Health Assembly. Moreover, the data supplied by WHO include support costs since the variety of forms of support costs - which can vary from one project to another - makes it difficult for WHO to report expenditures exclusive of support costs. Expenditure data submitted by the International Maritime Organization (IMO) also include support costs. The United Nations Educational, Scientific and Cultural Organization (UNESCO) continues the practice initiated in 1982 of reporting regular budget expenditures. However, the data provided by UNESCO under the heading "Regular budget" represent expenditures incurred under that organization's Participation Programme. As a rule, UNESCO considers that no technical co-operation activities are financed from its regular budget.

I. 1984 REGULAR PROGRAMME AND EXTRABUDGETARY TECHNICAL CO-OPERATION EXPENDITURES FINANCED BY SOURCES OTHER THAN UNDP

5. An overview of the expenditures on technical co-operation activities of each of the executing agencies is provided in table 1, together with a breakdown by main ACC programme classification category. The format of this table is the same as last year and distinguishes between expenditures financed from agency regular budgets, agency extrabudgetary sources, UNFPA and UNDP-administered funds, as well as those financed from UNDP central resources. Twenty-seven organizations and five regional commissions (excluding Governments, non-governmental organizations (NGOs) and the development banks) reported expenditures of almost \$841 million in 1984 financed from sources other than UNDP central funds, which is nearly the same amount as reported for 1983. Though the total expenditure for 1984 has remained at the level of \$841 million for 1983 (DP/1984/66), the regular technical co-operation expenditures went down by some 14 per cent and UNFPA-financed expenditures went down from \$123 million in 1983 to \$120 million, registering a decrease of about 2.4 per cent. However, expenditures funded by extraordinary sources other than UNDP, UNFPA and UNDP-administered funds went up to \$420 million in 1984 as against \$397 million during 1983, registering an increase of about 5.8 per cent. Those financed by UNDP-administered funds went up sharply and amounted to \$81 million in 1984 as opposed to \$64 million in 1983, reflecting an increase of 26.6 per cent.

6. The five larger agencies (the United Nations, the International Labour Organisation (ILO), the Food and Agriculture Organization of the United Nations (FAO), UNESCO and WHO) accounted for some 67.6 per cent of the total non-UNDP-financed technical co-operation expenditures for 1984 as against 70 per cent in 1982 and 1983. Three of these agencies, the United Nations, the ILO and WHO saw a decline in their expenditures by 6 per cent, 13.1 per cent and 14.6 per cent respectively, while expenditures for FAO went up by 14.7 per cent. In the case of UNESCO, while reported expenditures for 1984 were lower than those reported for 1982, they exceeded the 1983 figure by some 20 per cent. The decline in the United Nations share has been caused primarily by a drop in the UNFPA-financed programmes. For WHO, the decline could be partly due to the fact that, as a result of its

biennial budgeting and accounting period (see para. 4 above), only disbursements have been reported under the regular budget and that these figures are provisional and are subject to adjustment during 1985. Moreover, UNFPA-financed programmes for WHO have gone down from \$22 million in 1983 to 17.6 million in 1984. Despite this, WHO continues to have the largest non-UNDP-financed technical co-operation programme, reaching a total of almost \$261 million in 1984, followed by \$165 million of FAO.

7. As in the past, the expenditure data for the smaller agencies have not produced any generally valid trends, although their total share has grown over the last three years. Some smaller agencies have registered significant growth rates in their non-UNDP-financed technical co-operation expenditures. For example, in the case of the World Intellectual Property Organization (WIPO) and IMO, such expenditures went up by 14.8 per cent and 12.5 per cent respectively. The expenditures of the United Nations Industrial Development Organization (UNIDO) and IAEA continued the upward trend registered in 1982 and increased by 11.1 per cent, from \$27 million in 1983 to \$30 million in 1984 for UNIDO and by some 31 per cent, from \$22 million in 1983 to \$29 million in 1984 for IAEA. In contrast with these increases, non-UNDP-financed technical co-operation expenditures by the United Nations Centre on Transnational Corporations (CTC) decreased by 31.7 per cent, the International Telecommunication Union (ITU) decreased by 23.5 per cent and the International Trade Centre (ITC) went down by 11.7 per cent, whereas expenditures by the United Nations Conference on Trade and Development (UNCTAD) and the World Meteorological Organization (WMO) did not change significantly.

A. Sectoral distribution

8. As in past years, the relative size of the WHO regular budget has made health the sector with the highest concentration of expenditures not financed by UNDP central resources. This sector accounts for 31 per cent of all non-UNDP-financed technical co-operation expenditures in 1984. Agriculture, forestry and fisheries, with about \$125 million or some 15 per cent of the total non-UNDP-financed technical co-operation assistance, as against \$106 million reported in 1983, is the sector with the second highest expenditures and has replaced population, which now occupies third place with an expenditure of \$123 million, as against \$126 million for 1983. Next in importance is natural resources, with some \$64 million, or 7.6 per cent of the total expenditure, as against \$60 million for 1983. Transport and communications account for some 5.5 per cent of all regular and extrabudgetary expenditures, followed in importance by industry (4.7 per cent), general development issues, etc. (3.6 per cent), and science and technology (3.5 per cent).

9. The sectoral distribution of expenditures varies according to the source of financing. As can be inferred from the above, expenditures financed from regular budgets are concentrated in the health sector (some 68 per cent of total expenditures) followed by agriculture, forestry and fisheries (some 7.7 per cent), general development issues, etc., and natural resources (both 4.5 per cent) and science and technology (3.9 per cent).

10. Technical co-operation expenditures financed from extrabudgetary sources except "self-supporting" expenditures (i.e., those financed by recipient Governments) show a less marked concentration of expenditures in a few sectors. The most important sector financed by these sources is population with 24 per cent, followed in order by health (21 per cent), agriculture, forestry and fisheries (15 per cent) and natural resources (8 per cent).

11. Unilateral "self-supporting" expenditures (i.e., those expenditures which are financed by the developing countries themselves) are concentrated in the agriculture, forestry and fisheries sector with almost 27 per cent of such expenditures, followed by transport and communications (22 per cent) which has now been relegated to the second place. Expenditures on culture (14.8 per cent) occupy third place, while science and technology and natural resources account for some 11 per cent and 10 per cent respectively.

B. Regular budget expenditures

12. Reported regular programming expenditures amounted to \$220 million for 1984 as against \$257 million for 1983 and thus went down by some 14.4 per cent. Of the traditional executing agencies (i.e., excluding the development banks, UNFPA, UNICEF, NGOs and Governments), seven reported that they had incurred no technical co-operation expenditures financed from their regular budgets: CTC, the Economic Commission for Europe (ECE), the Office of the United Nations High Commissioner for Refugees (UNCHR), the International Civil Aviation Organization (ICAO), IMO, the World Tourism Organization (WTO) and ITC. On the average, agency regular budget expenditures accounted for some 26 per cent of total non-UNDP-financed technical co-operation expenditures (see annex 1 and 2), as against 31 per cent for 1983, with WHO and IAEA having the highest shares. With the exception of the United Nations, the Economic Commission for Africa (ECA), the Economic Commission for Western Asia (ECWA), the United Nations Centre for Human Settlements (UNCHS), IAEA and WIPO, which reported increased expenditures for 1984, agencies incurred expenditures either almost at the level of 1983 or lower than that for 1983. WHO, which continues to be the largest agency in terms of expenditures, reported a figure of \$144 million for 1984 as against \$185 million in 1983. However it should be noted that owing to the biennial system of budgeting and accounting of WHO, the figures for 1984 reflect actual disbursements made during the year. The expenditure for FAO, the second largest regular budget technical co-operation programme after WHO, declined from \$23 million for 1983 to \$20 million for 1984. The following agencies also reported decreases in their regular programme expenditures: UNIDO from \$4 million to \$3.7 million; the Economic Commission for Latin America and the Caribbean (ECLAC) from \$1.2 million to \$0.6 million; and the ILO from \$9.1 million to \$8.4 million. However, the expenditure for IAEA went to \$20 million from \$16.7 million in 1983, for UNCHS to \$600,000 from \$96,000; for WIPO to \$1.2 million from \$900,000; and for ECA to \$1.8 million from \$1.5 million. In the case of UNESCO, the data provided under "Regular programme" represent expenditures incurred under that organization's Participation Programme and has increased from \$5.5 million to \$8 million between 1983 and 1984. Expenditures for other organizations do not reflect notable variations between 1983 and 1984.

C: Expenditures financed from extrabudgetary sources

13. As in the pattern of previous years, extrabudgetary expenditures financed from United Nations system sources other than UNDP constituted an important source with \$228 million for 1984 (see annex tables 1 and 3) or 27 per cent of the total non-UNDP-financed technical co-operation expenditures. Compared with \$216 million reported for 1983, such expenditures reflected an increase of 5.6 per cent thereby maintaining the increasing trend regained in 1983 after a decline between 1982 and 1981. Overtaking the regular budget expenditure in size, Governments and UNDP (the latter comprising expenditures by the Office for Projects Execution (OPE), the United Nations Volunteers (UNV), the United Nations Revolving Fund for Natural Resources Exploration (UNRFNRE), the United Nations Sudano-Sahelian Office (UNSO) and the United Nations Financing System for Science and Technology for Development (UNFSSTD)) were the entities with the highest expenditures in this category, with \$50 million and \$38 million respectively, followed by WHO (\$25 million) and the United Nations (\$19 million).

14. Expenditures financed from non-United Nations system multilateral sources amounted to \$23 million for 1984 (annex table 4) as against \$20 million for 1983, reflecting an increase of 15 per cent. Of the agencies with such expenditures, FAO is by far the most important with some \$18.5 million as against \$15.8 million for 1983, or about 80.5 per cent of all expenditures financed from non-United Nations system multilateral sources. The ILO reported substantial increases in its expenditures, from \$68,000 to \$452,000, while UNESCO reported only a marginal increase from \$1.8 million to \$1.9 million. ICAO, ITU and WHO reported very substantial decreases in their activities financed from non-United Nations multilateral resources: \$62,000 from \$1.7 million by ICAO, \$87,000 from \$2.34 million by ITU; and \$472,000 from \$641,000 by WHO, WMO, the Economic Commission for Asia and the Pacific (ESCAP) and UNCHS reported nil expenditures as against \$1.09 million, \$1.49 million and \$47,000 respectively for 1983.

15. Extrabudgetary expenditures financed from bilateral sources continue to be one of the largest sources for non-UNDP-financed technical co-operation. They amounted to \$268 million for 1984 as against \$256 million for 1983 reflecting an overall increase of 4.7 per cent and have thus become the most important source again (as in 1981 and earlier years). The share of agency expenditures financed from bilateral resources in the total of regular and extrabudgetary expenditures increased from 30 per cent in 1983 to 31.9 in 1984, though it is lower than the 37 per cent reported for 1982. Among the agencies, WHO spent, with some \$89 million, the highest amount, or about 33.2 per cent of the expenditures financed by bilateral resources, closely followed by FAO which reported an expenditure of \$70 million as against \$62 million for 1983. Though the ILO reported a drop in its expenditure, from \$26 million in 1983 to \$24 million in 1984, it continues to occupy third place in terms of expenditures, followed by UNESCO (\$17 million) and UNIDO (\$16 million). IAEA reported a substantial increase in its activities and recorded an expenditure of \$8 million as against \$5.5 million for 1983.

16. Following the practice initiated in 1980, agencies were also requested to

provide data on expenditures financed from "self-supporting" contributions, that is those expenditures financed by the recipient Governments themselves (see annex table 1, line C.2, and the last column of annex table 8). The expenditures for 1984 amounted to \$103 million as against \$92 million for 1983, reflecting an increase of some 12 per cent. FAO reported the highest amount of such expenditures, \$39 million for 1984, which exceeded the 1983 expenditures by about 16 per cent. UNESCO, whose expenditures last year declined substantially, from \$28 million in 1982 to \$11 million in 1983, reversed the trend of negative growth and reported an expenditure of \$23 million. Though UNESCO did not reach its level of 1983 expenditure, it replaced ICAO as the second largest executing agency in this respect. Contrasting with these increases, such expenditures of ICAO, the ILO and WHO decreased by some 12 per cent, 29.5 per cent and 34 per cent respectively. As in previous years, most of these expenditures continue to be financed by the members of the Organization of Petroleum Exporting Countries (OPEC), with Saudi Arabia and the Libyan Arab Jamahiriya accounting for some 66 per cent of the total expenditures in this category as against 61 per cent in 1983 and 65 per cent in 1982. For reasons of space, the table showing the breakdown by agency of such expenditures is not included in the statistical annex but can be obtained from UNDP upon request.

II. EXTRABUDGETARY CONTRIBUTIONS TO THE SPECIALIZED AGENCIES AND IAEA FOR TECHNICAL CO-OPERATION ACTIVITIES IN 1983

17. For purposes of reporting contributions, agencies were requested to classify the contributions made to them by type, making a distinction between general contributions and unilateral "self-supporting" contributions, corresponding to that of expenditures. General contributions data are contained in annex table 6, classifying the sources of contributions by country, by United Nations system sources, by non-United Nations system multilateral sources and by other miscellaneous sources. Annex table 7 contains contributions for "self-supporting" activities.

18. Twenty-one organizations reported general extrabudgetary contributions of \$378 million received in 1984 as against the same organizations' receipts of \$372 million in 1983. In addition, various contributions were reported for a number of additional organizations from different funding sources (mostly UNDP-administered funds), raising the total to some \$468 million from \$465 million in 1983. The expenditures financed by UNFPA and UNDP-administered funds are now registered as contributions to the relevant organizations, since such expenditures are in fact paid up during, or shortly following, the year in which they were incurred.

19. Contributions by countries directly to agencies for the purposes of technical co-operation were reported by 21 organizations as amounting to \$231 million for 1984, as against \$202 million for 1983, registering an increase of 14.3 per cent. The United Nations, ECA, the ILO, FAO, IAEA, and ITC reported increased contributions, whereas UNIDO, UNCTAD, UNESCO and WMO reported reduced contributions. The contributions from the members of the Development Assistance Committee (DAC) of the Organization for Economic Co-operation and Development (OECD), which had slipped down to \$166 million in

1983 from \$206 million in 1982, reversed the declining trend and amounted to \$218 million for 1984.

20. An increase also has been observed in the contributions received by agencies from NGOs, from \$11.8 million received in 1983 to close to \$15.6 million received in 1984, an increase of about 32.2 per cent. The contribution to UNESCO went up from \$1.3 million in 1983 to \$5.3 million in 1984. FAO, UNIDO, ECLAC and ESCAP also reported increased contributions. However, WHO indicated reduced contributions while IMO reported nil contribution.

21. As also observed during the previous year, the second largest source of financing of agencies' extrabudgetary technical co-operation activities continues to be the United Nations system itself. Agencies reported contributions of \$201 million (see also notes to annex table 6) received in 1984, which was a decrease from the \$216 million received by the same agencies in 1983, a decrease of 7 per cent between 1983 and 1984. The contributions from non-United Nations multilateral sources also went down, amounting to \$20.6 million for 1984 against \$32 million for 1983.

22. In conformity with the practice of previous reports annex table 7 contains data on the contributions made to the United Nations system for "self-supporting" technical co-operation activities. Such contributions, which had declined to \$80 million in 1983 from \$106 million in 1982, regained the earlier trend of increased contributions and amounted to \$122 million for 1984. The contributions from Saudi Arabia went up steeply from \$37 million in 1983 to \$66 million for 1984. The contributions from the Libyan Arab Jamahiriya went up to \$18 million in 1984 as against \$12 million in 1983, though it continued to be lower than the \$22 million for 1982. However, some countries increased, though marginally, their contributions for "self-supporting" technical co-operation activities. FAO was the largest recipient of such funds, followed by ICAO, UNESCO, UNIDO and the ILO in descending order.

III. ASSISTANCE PROVIDED BY UNDP AND OTHER ORGANIZATIONS

23. For comparison purposes, table 1 and annex table 8 include summary data on UNDP project expenditures in 1984. These data conform with those in documents DP/1985/5/Add.1 and Add.3 and are provisional, as indicated in those documents.

24. Total UNDP project expenditures decreased by 5.8 per cent between 1983 and 1984 from \$560 million to \$527 million, as against a decrease of some 15 per cent observed in 1983. Non-UNDP-financed technical co-operation expenditures, however, remained at the level of 1983 and amounted to \$841 million for 1984 (see para. 5). Nevertheless, the majority of agencies continue to have the larger part of their technical co-operation expenditures financed by UNDP. The only exceptions to this rule are WHO, IAEA, WIPO, UNCTC, ITC, the ILO, UNESCO, FAO and ESCAP.

25. As in previous years, data on World Bank and IDA technical co-operation

expenditures have been incorporated into the report (see annex table 8). These data reflect a proxy measure of technical co-operation expenditures financed under World Bank loans and IDA credits for the categories "training" and "consultants". Total disbursements under these categories reached almost \$845 million in 1984, down from \$873 million in 1983, as in 1982, they surpass UNDP-financed technical co-operation expenditures. However, caution in the use of these data is advised, since these data should be used as an indication of the magnitude only and not compared directly with UNDP and agency expenditure data. Apart from the difficulty of deciding what constitutes technical co-operation in World Bank expenditures, these data reflect disbursements against approved loans and credits, rather than grant-financed expenditures, as is the case with agency expenditures.

26. Annex table 8 also contains data on expenditures incurred by two non-technical co-operation bodies, namely UNICEF and WFP. Expenditures by WFP maintained the momentum regained in 1982 and have risen to \$679 million in 1984, thereby registering an increase of about 8 per cent from \$629 million in 1983. The expenditures by UNICEF amounted to about \$244 million in 1984, while the corresponding figure for 1983 was \$246 million.

27. The data on operational activities for development by the United Nations system contained in the country-by-country summaries in annex table 8 are to some extent incomplete and in many cases provisional. However, much of the double-counting present in previous reports has been eliminated which, together with the more comprehensive coverage of expenditures (including not only specialized agencies and IAEA, but also expenditures incurred by funding organizations themselves as well as Governments and NGOs) has made it possible to present a more accurate picture of the technical co-operation activities of the United Nations system. The total grant assistance in the amount of \$2.2 billion for 1984 continues to be at the same level reported for 1982 and 1983 and probably reflects a true comparable picture in view of the similar coverage and methodology employed in the preparation of the latest reports in this series.

28. A more complete picture of expenditures on operational activities for development of the United Nations system will be found in the report of the Director-General for Development and International Economic Co-operation submitted to the General Assembly.
