**FOURTH CYCLE INDICATIVE PLANNING FIGURES (IPFs)  
1987-1991**

Fourth cycle IPFs calculated on the basis of  
Governing Council decision 85/16

Note by the Administrator

1. Following Governing Council decision 85/16 adopted on its thirty-second session in June 1985, IPFs for the fourth programming cycle have been calculated on the basis of the detailed guidelines contained in this decision. The calculated IPFs for individual countries and programmes are attached as an annex to this note for the information of the Council. Table 1 has the countries in alphabetical order, table 2 shows fourth cycle country IPFs in ascending order of 1983 GNP per capita and table 3 provides summary information of all IPFs established by region and programmes. Additional information to facilitate a comparison with IPFs established for the third cycle is included in table 3.
2. Paragraph 3 of decision 85/16 requested that, for the purpose of forward planning, an assumed average annual growth of total voluntary contributions of at least 8 per cent on a basis of the target of \$700 million anticipated for 1986 be used. Based on this assumption, the total amount of resources available for IPFs during the fourth cycle was established at \$3,166 million. This figure was subsequently used as the basis for calculating the IPFs for different programmes, as reflected in the annex to this note.

3. In calculating individual country IPFs, 1983 World Bank data on population and per capita GNP have been used in all cases where they were available, in accordance with paragraph 2 of decision 85/16. For those few countries where no 1983 World Bank data were available, 1983 figures provided by the United Nations Statistical Office have been used. The latter office is also the main primary source for population data for the World Bank. In such cases, United Nations Statistical Office data on GNP were double-checked against other, secondary sources of information. In addition, GNP data in local currencies provided by the United Nations Statistical Office were converted into United States dollars with assistance from the World Bank, using the World Bank Atlas methodology, which was also applied to data directly provided by the Bank.

4. IPFs for the various intercountry programmes (global, interregional and regional programmes) have been computed in accordance with paragraphs 5 and 6 of decision 85/16.
