REPORT BY THE PRESIDENT ON THE WORK AND DECISIONS OF THE COMMITTEE OF THE WHOLE

I. ORGANIZATIONAL MATTERS

1. By paragraph 2 of section III.A of decision 83/5, the Governing Council of the United Nations Development Programme (UNDP) decided that, for a trial period of three years, it should, in the context of regularly scheduled sessions, resolve itself into a Committee of the Whole, in order to:

- (a) Consider major issues related to programme matters,
- (b) Review country, regional, interregional and global programmes and projects;
- (c) Review programme and project implementation,
- (d) Consider reports on evaluation studies;
- (e) Deal with other matters related to the programme management of UNDP.

2. Paragraph 3 of the same decision provided, <u>inter alia</u>, that the meetings of the Committee of the Whole should be scheduled so as not to coincide with the meetings of the plenary and that a written report sould be submitted to plenary by the presiding officer, who should be the President of the Council or another member of the Bureau designated by him.

3. At its organizational meeting for 1986, the Governing Council decided to allot the following items to the Committee of the Whole:

Agenda item 5 (b) (i) Relevant trends and problems in country programmes,

Agenda item 5 (b) (ii) Implementation of country programmes in various regions;

Agenda item 5 (b) (iii) All country and intercountry programmes; global and interregional projects;

Agenda item 4 (d) Evaluation matters.

4. Subsequently, the Governing Council assigned three items from its own agenda to the Committee of the Whole. In accordance with decision 86/1, paragraph (e), the Committee of the Whole on 19 February 1986 assigned to the Working Group of the Committee of the Whole three topics falling within the scope of the mandate of the Committee of the Whole, as established in decision 83/5, section III a, paragraphs 2 (c) and (d), as follows:

(a) Implementation of the Substantial New Programme of Action for the 1980s for the Least Developed Countries;

(b) Evaluation;

(c) Management aspects of programme and project implementation.

5. At the opening of its thirty-third session, the Governing Council decided to resolve itself into the Committee of the Whole on 2 June 1986. It held 15 meetings up until 17 June 1986. The Working Group of the Committee of the Whole held two sessions on 24-25 February and 24-26 March 1986.

III. THE COMMITTEE'S DELIBERATIONS

7. In addition to the documentation made available to the Committee, each document was introduced by the Assistant Administrator, or senior official concerned. In some cases, Resident Representatives introduced country programmes. Following the debate on the various items, these senior officials responded to the points raised in the debate on the agenda items as required.
8. The discussion in the Committee of the Whole of the various programmes and other items involved the broad participation of members and observers.
Observations were also made by agencies. A number of points were raised in the debate to which senior officials of UNDP and, in some cases involving country programmes, concerned delegations provided answers. Several Resident Representatives were present to provide further details on the programming process utilized, as well as on other questions raised.

9. For the consideration of all matters before the Committee, in particular the global projects and country programmes and extensions, full information was made available by the Administration and representatives of countries concerned. This permitted an extensive examination of the various issues and programmes before the Committee.

10. The President of the Council, in his capacity as Chairman of the Working Group, at the meeting of the Committee of the Whole held on 16 June 1986, submitted a report in the form of a statement on the work of the Working Group of the Committee of the Whole. The Committee of the Whole considered this report on 17 June. 2/

The future of the Committee of the Whole and of its Working Group

To extend the trial period of the Committee of the Whole by one year, and to review the experience with the Committee of the Whole and the Working Group of the Committee of the Whole at the thirty-fourth session of the Governing Council (1987). To confirm, until then, the mandate of the Committee of the Whole, as contained in decision 83/5 and of the Working Group of the Committee of the Whole, as contained in decision 85/17, as well as the continued validity of the arrangements for the Working Group of the Committee of the Whole, as laid down in decision 86/1, and as modified at the current session of the Council.

V. FUTURE ARRANGEMENTS FOR THE WORKING GROUP OF THE COMMITTEE OF THE WHOLE

12. In accordance with decision 86/1, as modified at the current session of the Council, the Committee decided on the topics to be assigned to the Working Group and the number and timing of sessions as follows:

Topics assigned to the Working Group of the Committee of the Whole for the coming year

(a) <u>Management issues: delivery rates</u> - Update on steps taken and an analysis of the main factors affecting the delivery rates (including discussions with agency representatives to review their procedures). (b) Implementation of the UNDP programme - the role of UNDP and the executing agencies in facilitating the timely use of inputs (experts, equipment, fellowships, counterparts).

(c) Project development facility and preparatory assistance.

(d) Government execution.

(e) <u>Equipment</u> - procurement of equipment and services with special reference to procurement from developing countries.

(f) <u>Project personnel</u> - with special reference to quality of project personnel and use of developing country nationals.

(g) <u>Co-ordination</u> - in 1987, the Council will receive a report on this subject, including UNDP and agency consultative arrangements at the country level. Selected agencies could be invited to participate in discussions. Number and timing of sessions of WG/COW:

(a) There will be a session of the Working Group in New York,September 1986. The proposed dates are 15-17 September 1986, subject tofurther inquiries with United Nations Conference Services by the Secretariat.

(b) In 1987, two sessions will be held in New York between January and late April. The proposed dates for the first session are 11-13 February 1987, while the dates for the second session remain to be determined, subject to the availability of conference services.

Notes

1/ These reports were considered by the Working Group of the Committee of the Whole, except for DP/1986/13, which was reviewed in part only. In addition, UNDP staff prepared several background papers which had been requested by the members of the Working Group.

2/ It may be recalled that, at its 23rd meeting on 17 June 1986, the Governing Council already decided, upon recommendation by COW, to refer the Report of the Chairman on the work of WG/COW, documents DP/1986/17 and DP/1986/20 to the Council's Drafting Group for elaboration of appropriate draft decisions, if necessary.
