## Provisional agenda and organization of work of the Budgetary and Finance Committee

### Note by the secretariat

- 1. In accordance with Governing Council decision 81/37, paragraph 4(a), this document contains, in annexes I and II, respectively, the provisional agenda and the tentative schedule of work of the Budgetary and Finance Committee for the thirty-fourth session of the Governing Council.
- 2. At its organizational meeting in February 1987, the Governing Council, by decision 87/2, approved the provisional agenda for its thirty-fourth session scheduled from 26 May to 19 June 1987 in New York and decided to allocate the following items to the Budgetary and Finance Committee:
  - 6 United Nations Fund for Population Activities: budgetary and financial matters;
  - 8(a) 8(h) Other funds and programmes: financial and administrative questions;
  - 9(a) Annual review of the financial situation, 1986;

9(b)	Budget estimates for 1988-1989;
9(c)	Trust funds;
9(4)	Guidelines for procurement;
9(e)	Audit reports;
9(f)	Sectoral support;
9(g)	Other matters.

- 3. In accordance with Council decision 87/2, the Budgetary and Finance Committee will also review the financial implications of draft decisions before the Council takes action thereon. Consequently, provision has been made for this Committee to review all documents having financial implications, including draft decisions formulated by the Drafting Group, as well as other matters which the Council may wish to refer to it under item 7 of the provisional agenda of the Committee.
- 4. Annex II of this document, which contains the work schedule of the Budgetary and Finance Committee, should be considered provisional and indicative in nature so that the Committee may be in a position to take up items on a more flexible basis. In particular, should it complete consideration of an item before the date indicated, it would move immediately to the next item on its work schedule.
