COMMITTEE OF THE WHOLE

REPORT BY THE PRESIDENT ON THE WORK AND DECISIONS  
OF THE COMMITTEE OF THE WHOLE

I. ORGANIZATIONAL MATTERS

1. By paragraph 2 of section III. A of decision 83/5 of 24 June 1985, the Governing Council of the United Nations Development Programme (UNDP) decided that, for a trial period of three years, it should, in the context of regularly scheduled sessions, resolve itself into a Committee of the Whole, in order to:

- (a) Consider major issues related to programme matters;
- (b) Review country, regional, interregional and global programmes and projects;
- (c) Review programme and project implementation;
- (d) Consider reports on evaluation studies;
- (e) Deal with other matters related to the programme management of UNDP.

2. Paragraph 3 of the same decision provided, inter alia, that the meetings of the Committee of the Whole should be scheduled so as not to coincide with plenary meetings and that a written report should be submitted to the plenary Council by the presiding officer, who should be the President of the Council or another member of the Bureau designated by him.

3. This decision was to be reviewed by the Council at its thirty-third session (1986), on the basis of experience gained, with a view to examining the possibility of establishing a programme committee. The Council decided, however, in its decision 86/23 of 27 June 1986, to extend the trial period of the Committee of the

Whole by another year in order to gain more experience. Thus the role of the Committee of the Whole and its Working Group, established by Governing Council decision 85/17 of 29 June 1985, were reviewed at the thirty-fourth session (1987) of the Council.

4. At its organizational meeting for 1987, the Governing Council decided in its decision 87/2 to allocate the following items to the Committee of the Whole:

- Agenda item 5 (b) (i) Relevant trends and problems in country programmes;
- Agenda item 5 (b) (ii) Implementation of country programmes in various regions;
- Agenda item 5 (b) (iii) All country and intercountry programmes; global and interregional projects;
- Agenda item 4 (c) Evaluation matters.

5. At its thirty-fourth session (1987), the Governing Council decided to resolve itself into the Committee of the Whole on 5 June and from 9 June to \_\_\_ June 1987. It held a total of \_\_\_ meetings.

### III. THE COMMITTEE'S DELIBERATIONS

7. In addition to the documentation made available to the Committee, each document was introduced by the Assistant Administrator, or senior official concerned. In some cases, resident representatives introduced country programmes. Following the debate on the various items, these senior officials responded to the points raised in the debate on the agenda items as required.

8. The discussion in the Committee of the Whole of the various programmes and other items involved the broad participation of members and observers. Observations were also made by agencies. A number of points were raised in the debate to which senior officials of UNDP and, in some cases involving country programmes, concerned delegations provided answers. Several resident representatives were present to provide further details on the programming process utilized, as well as on other questions raised.

9. For the consideration of all matters before the Committee, in particular the global projects and country programmes and extensions, full information was made available by the Administration and representatives of countries concerned. This permitted an extensive examination of the various issues and programmes before the Committee.

10. The President of the Council, in his capacity as Chairman of the Working Group, at the meeting of the Committee of the Whole held on 5 June 1987, submitted a report in the form of a statement on the work of the Working Group of the Committee of the Whole. At the same meeting, the Committee of the Whole recommended to the plenary that it take note of the oral report, which the plenary did on 5 June 1987.
