Annual financial review, 1990

SUMMARY

In this report, the Executive Director provides, as requested by the Governing Council, a financial review of the activities financed by UNFPA and of its trust funds in 1990. The report shows the Fund's financial position and accounts as at the end of 1990. Annual data on income and expenditures are included for 1988, 1989 and 1990. The annexes include the unaudited financial statements for the year ended 31 December 1990.

Introduction

1. In response to decisions 85/20 II and 87/31, paragraph 9, adopted by the Governing Council at its thirty-second and thirty-fourth sessions, respectively, the Executive Director presents in this report a review of the financial situation of the United Nations Population Fund (UNFPA) for 1990. As in prior years, the information and financial data available for the preparation of this report include the unaudited financial statements of the Fund (Annexes I and II). Pursuant to UNFPA financial regulation 16.3, the financial statements for the biennium 1990-1991 will be submitted to the Board of External Auditors on or before 30 April 1992 and transmitted by the Chairman of the Board to the President of the General Assembly in June 1992. It is estimated that the unaudited financial statements and preliminary data presented in this report will not vary substantially from the audited financial statements so as to alter the analysis and conclusions of this presentation in any significant manner.

2. This document includes the actual data available for 1988, 1989 and 1990. Audited data for 1988 and 1989 were extracted from the UNFPA year-end audited financial statements as contained in documents A/44/5/Add.7 and A/45/5/Add.7. For the reasons noted in documents DP/1990/50 and DP/1991/39 concerning Audit Reports, the United Nations Board of Auditors qualified its audit opinion on the financial statements of UNFPA for the years ended 31 December 1988 and 1989 respectively. The 1990 figures provided herein include data obtained from the 1990 unaudited annual accounts of the executing agencies with regard to the status of funds allocated to them and expended in the execution of UNFPA projects during 1990. Should any changes be reported in the audited accounts of any of the executing agencies, they will be reported by the Executive Director to the Governing Council at its next (thirty-ninth) session in the audited statements and audit reports. A financial summary containing information on budgetary trends is provided in Annex IX. These data are provided as requested by the Governing Council at its thirty-second and thirty-fourth sessions.

I. ANNUAL REVIEW OF THE FUND'S FINANCIAL SITUATION

A. Income and expenditure

3. Table 1 provides a summary of 1990 pledges and payments by donors as compared to 1988 and 1989. Annex III shows in detail the status of the voluntary contributions pledged by all donors as at 31 December 1990. The outstanding cumulative balance of unpaid pledges as at 31 December 1990 was \$8.5 million, as follows:

4. Table 2 shows a comparison of income and expenditures for 1988, 1989 and 1990. Total income in 1990 amounted to \$212.4 million and total expenditures to \$221.3 million. This resulted in an excess of expenditure over income of \$8.9 million. Annual income includes pledges from Governments, investment income and miscellaneous income but excludes contributions to trust funds. In accordance with UNFPA financial rule 116.1(a), income was recorded on an accrual basis. As required by financial rule 104.1, all pledges were recorded in United States dollars, converted at the United Nations operational rate of exchange in effect on the date of the pledge.

5. Total income in 1990 increased by \$27.2 million or 14.7 per cent over the 1989 income of \$185.2 million and by \$34.4 million or 19.3 per cent over the 1988 income of \$178.0 million. Total contributions pledged by 106 Governments in 1990 reached \$205.8 million, an increase of \$25.1 million in dollar terms or 13.9 per cent over the \$180.7 million pledged in 1989. Interest income amounted to \$5.9 million or 2.8 per cent of total income. Other miscellaneous income and adjustments, including revaluation of currencies and gains/losses on currency exchange, totalled \$0.7 million (table 2). As required by financial rule 104.2, all payments of voluntary contributions were recorded in United States dollars at the United Nations operational rate of exchange in effect on the date of payment.

B. Programme expenditures and operational costs

6. As shown in table 2, total expenditures in 1990 were \$221.3 million, an increase of \$17.8 million or 8.7 per cent compared to 1989 expenditures and an increase of \$54.1 million or 32.4 per cent compared to 1988 expenditures. In table 3, programme expenditures and operational costs (composed of the administrative and programme support services (APSS) budget expenditures and agency support costs) are compared for 1988, 1989 and 1990 as a percentage of total expenditures. Programme expenditures in 1990, which amounted to \$168.9 million, constituted 76.3 per cent of the total expenditures, compared to 77.3 per cent in 1989 and 77.6 per cent in 1988. Operational cost expenditures in 1990 totalled \$52.4 million or 23.7 per cent of total expenditures. The total APSS budget expenditure in 1990, comprising the headquarters administrative budget and total field office costs, amounted to \$37.8 million or 17.1 per cent of total expenditures compared to \$32.1 million or 15.8 per cent of total expenditures in 1989 and \$26.7 million or 16.0 per cent of total expenditures in 1988.

7. The APSS field office expenditure in 1990, which includes all field office costs as in 1989, totalled \$15.6 million. This compares to all field office costs of \$11.6 million in 1989 and \$9.7 million in 1988. Agency support costs in 1990 totalled \$14.6 million, or 6.6 per cent of total expenditure (compared to \$14.0 million or 6.9 per cent of total expenditure in 1989 and \$10.7 million or 6.4 per cent of total expenditure in 1988). In 1990, as in 1989 and 1988, the agency support costs comprised the reimbursement to United Nations executing agencies for support services, payment of overhead charges to non-governmental organizations (NGOs) and reimbursement to UNFPA for support and procurement services provided for government-executed projects.

8. As shown in table 4, in 1990 the United Nations executing agencies, including the regional commissions, executed projects amounting to \$90.5 million compared to \$88.3 million in 1989 and \$68.8 million in 1988. Governments executed \$33.3 million in 1990, compared to \$22.4 million in 1989 and \$14.1 million in 1988, with the assistance of UNFPA field offices. Expenditures for government-executed projects did not include \$6.6 million of advances to Governments, which at year-end were held by Governments and not reported as expenditure (see also Annex II). UNFPA-executed projects totalled \$25.6 million in 1990, compared to \$26.9 million in 1989 and \$28.6 million in 1988, and included procurement assistance in respect to Governments' projects amounting to \$15.5 million in 1990. Programme expenditures for projects executed by NGOs and other agencies, such as intergovernmental institutions and academic and research centres, were \$19.5 million in 1990, compared to \$19.8 million in 1989 and \$18.3 million in 1988.

9. Table 4 also shows the percentage breakdown of programme expenditures by executing agency for 1988, 1989 and 1990. Projects executed by the United Nations and its specialized agencies and regional commissions amounted to \$90.5 million or 53.6 per cent of programme expenditure of \$168.9 million in 1990. Governments executed \$33.3 million or 19.7 per cent of programme expenditure in 1990. NGOs and other agencies executed \$19.5 million or 11.5 per cent of programme expenditure in 1990. Annex IV shows 1990 expenditures by executing agency and by major expenditure component of the project budgets. Annex VII shows programme expenditures by country for 1988, 1989 and 1990.

C. Status of unexpended balance of general resources

10. On 1 January 1990, the balance of available unspent funds for programming was \$8.5 million. As shown in table 5, after subtracting an excess of expenditure over income of \$8.9 million, the unexpended balance of general resources available for programming resulted in a deficit of \$0.4 million as at 31 December 1990 (see also Annex II).

D. Status of the operational reserve

11. During 1990, UNFPA maintained a fully funded operational reserve at the level of \$45 million (see Annex II). The operational reserve was established by the Governing Council in January 1973 at the \$20 million level to guarantee the financial viability and integrity of the UNFPA programme. By decision 81/7 III, paragraph 5, adopted by the Governing Council at its twenty-eighth session, UNFPA was requested to increase the reserve annually to reach a level equivalent to 25 per cent of contributions by 1990. At the thirty-sixth session, the Council, however, decided that, "with effect from 1989, the level of the operational reserve will be set at \$45 million and that the level of the operational reserve should be reviewed at the thirty-eighth session (1991) of the Governing Council" (decision 89/49, para. 16). All other provisions of decision 81/7 III relating to the operational reserve were to remain in effect.

E. Liquidity position

12. Table 6 shows the Fund's gross liquid assets as at 31 December 1990, as compared to 1988 and 1989. As at 31 December 1990, UNFPA had bank balances in convertible currencies and time-deposit investments amounting to \$84.2 million,

which included \$45.0 million of time-deposit investments of the operational reserve and \$10.9 million belonging to UNFPA trust funds (see Annexes II and V). The investments reported in table 6 and in Annex II were recorded using the United Nations operational rate of exchange, which came into effect on 1 December 1990. At the United Nations operational rate of exchange in effect from 1 January 1991, which more closely reflected the market rate of exchange as at 31 December 1990, the value of these investments would amount to \$173,100 less than that shown in the accounts.

F. Special population programmes

13. As authorized by the Governing Council at its seventeenth session (decision 74/16, paragraph (e)), UNFPA received cash remittances totalling \$18.4 million in 1990 from the Governments of Japan, the Netherlands and Norway to be transferred by UNFPA to designated special population programmes. The four recipients of these funds were the International Planned Parenthood Federation (\$17.9 million, from Japan and the Netherlands), The Population Council (\$0.2 million from the Netherlands and Norway), the International Union for the Scientific Study of Population (\$0.2 million from the Netherlands and Norway) and the International Council on the Management of Population Programmes (\$0.1 million from Norway). These transfers of funds are not included in the UNFPA financial statements.

II. UNFPA TRUST FUNDS

14. Table 7 shows that in 1990 total income (contributions received plus interest income) from donors for projects and activities under funds-in-trust arrangements were the equivalent of \$11.8 million, showing an increase of \$4.5 million compared to \$7.3 million received in 1989 and approximately equal to the 1988 funds-in-trust income. As at 1 January 1990, the unexpended balance of the trust funds was \$10.4 million, which added to the total income received in 1990, resulting in a total amount available for programming in 1990 of \$22.2 million. Total expenditures were \$11.3 million in 1990 compared to \$6.2 million in 1989 and \$6.1 million in 1988. The unexpended balance as at 31 December 1990 stood at \$10.9 million, which is available to finance trust fund activities in 1991. Annex V shows the statement of accounts as at 31 December 1990 for 22 trust funds managed by UNFPA in 1990, while Annex VI reflects the status of collections and unpaid pledges as at 31 December 1990.

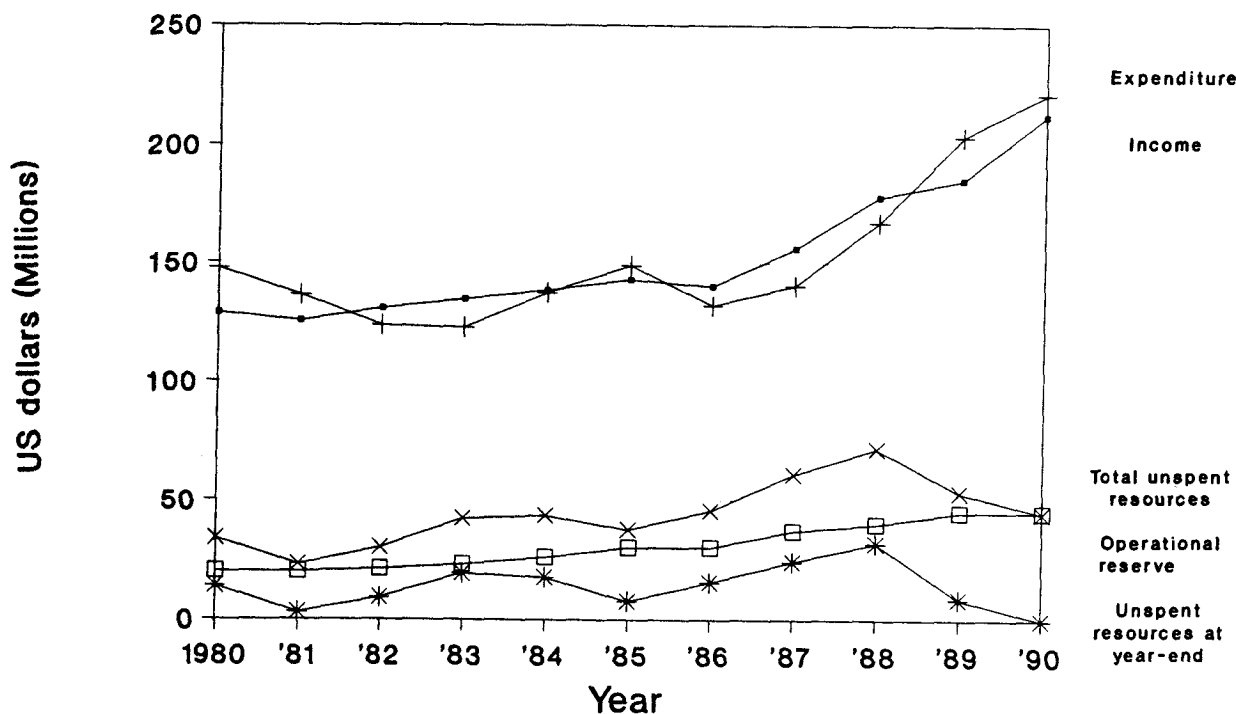
