OPENING OF THE SESSION AND ADOPTION OF THE AGENDA

Provisional agenda and organization of work of the
thirty-eighth session

Note by the secretariat

1. At its organizational meeting for 1991, by its decision 91/1 of 22 February 1991, the Governing Council of the United Nations Development Programme (UNDP) decided that the thirty-eighth session of the Council, including the meetings of the Standing Committee for Programme Matters, the Budgetary and Finance Committee and the Drafting Group, should be held in New York from 3 to 21 June 1991. By the same decision the Council approved the provisional agenda for its thirty-eighth session (see annex I) and the tentative schedule of work (see annex II).

2. At its organizational meeting on 19 February 1991, the Governing Council elected, by acclamation, the following officers for 1991:

President: H.E. Mr. Ramiro Piriz-Ballon (Uruguay)

First Vice-President: Mr. Jeremiah E. Kramer (Canada)

Second Vice-President: Mr. Wojciech A. Jasinski (Poland)

Third Vice-President: Mr. Shaukat Umer (Pakistan)

Fourth Vice-President: Mr. Robert K. Gathungu (Kenya)

3. By its decision 91/1, the Governing Council decided to dispense with the general debate at its thirty-eighth session, thereby making a three-week

session possible. However, item 2 on the provisional agenda, entitled "Annual report of the Administrator for 1990 and programme-level activities", will provide the opportunity for an overall review of major policy issues as well as for high-level attendance. Statements during the discussion of this item should be limited to 10 minutes in order to allow full participation. (See also paras. 6 and 7 concerning item 2.)

4. Meetings will normally be scheduled from 10 a.m. to 1 p.m. and from 3 p.m. to 6 p.m. In that context, it may be recalled that, by section I, paragraph 3 (j), of its decision 81/37 of 27 June 1981, the Governing Council decided that its meetings should start promptly at their scheduled time. The Council, by section III of its decision 91/1, decided to waive rule 22 of its rules of procedure for its meetings in 1991, in so far as that rule refers to the requirement that there be a quorum of one third of the members of the Governing Council present to open a meeting or to proceed with a debate.

5. The tentative schedule of work set out in annex II shows the proposed schedule for the plenary, the Standing Committee for Programme Matters, the Budgetary and Finance Committee and the Drafting Group. The consideration of the various items is scheduled in such a manner as to avoid simultaneous meetings by the sessional bodies dealing with the same matter. The Governing Council approved the tentative schedule of work by its decision 91/1, on the understanding that the Bureau of the Council be entrusted with the task of adjusting the schedule of meetings within the overall allocation of services to ensure a smooth and proper conduct of the session.

I. PLENARY

6. The Economic and Social Council, in its resolution 1990/54 of 24 July 1990 on the implementation of the Declaration on International Economic Cooperation, in particular the Revitalization of Economic Growth and Development of the Developing Countries, recommended that the governing bodies of the organs and organizations of the United Nations system include in their agenda the question of the implementation of the Declaration and invited them to report to the Council, at its second regular session of 1991, on steps taken by them and by Governments within their respective spheres of competence, with a view to ensuring the implementation of the Declaration. The General Assembly, in its resolution 45/234, of 21 December 1990, requested the Secretary-General to submit to the Assembly, at its forty-sixth session, a report on the implementation by Governments and the organizations of the United Nations system of the commitments and policies agreed upon in the Declaration. Delegations may wish to address the question of implementation of the Declaration under item 2 of the provisional agenda (Annual report of the Administrator for 1990 and programme-level activities).

7. Reports have been prepared concerning the following programme-level activities which will be discussed together with the annual report of the Administrator:

Human development;

Management Development Programme;

Technical Cooperation among Developing Countries;

Non-governmental and grass-roots organizations;

Women in development;

Role of UNDP in combating HIV and AIDS.

8. At its special session, held from 20 to 22 February 1991, the Governing Council began consideration of a draft decision concerning Namibia which was submitted by Zaire on behalf of the African States members of the Governing Council (DP/1991/L.5). Since the consideration of the item was not completed, the Bureau of the Governing Council has recommended that it be taken up under item 3 (a) of the provisional agenda entitled "Africa-related matters". Under this sub-item, reports have been prepared concerning the role of UNDP in the implementation of the United Nations Programme of Action for African Economic Recovery and Development 1986-1990 and the Transport and Communications Decade in Africa. The item is scheduled for consideration on 12 June 1991 together with items concerning least developed countries, refugees and the United Nations Sudano-Sahelian Office.

9. Provision is being made for in-session, informal consultations on item 5 (c) of the provisional agenda, entitled "Support costs: successor arrangements", to begin at the earliest possible stage. It will be recalled that the Governing Council did not conclude its consideration of this item at its special session in February 1991. The Council completed its general discussion in plenary meeting but did not receive a report from the Vice-President in charge of the informal consultations. The plenary is scheduled to discuss the report prepared for the thirty-eighth session on this subject on Thursday, 13 June 1991.

10. In paragraph 6 of its decision 90/23 of 23 June 1990, the Governing Council requested the Administrator, with respect to the working methods of the Governing Council, inter alia, to examine further possibilities "to biennialize or even triennialize specific items". At its organizational meeting on 19 February 1991, the Council took note of the proposals submitted in the report of the Administrator (DP/1991/3). To allow for a continued discussion of the possibilities of biennialization or triennialization, item 12 (Matters relating to the work of the Council in 1992) will be taken up on Tuesday, 18 June 1991.

II. STANDING COMMITTEE FOR PROGRAMME MATTERS

11. In paragraph 4 of its decision 91/2 A of 22 February 1991, the Governing Council decided that the Standing Committee for Programme Matters should work within the framework of procedures of the Council, in a similar manner to the
