OPENING OF THE SESSION AND ADOPTION OF THE AGENDA

Provisional agenda and organization of work of the Standing
Committee for Programme Matters

Note by the secretariat

- 1. At its organizational meeting for 1991, by its decision 91/1 of 22 February 1991, the Governing Council of the United Nations Development Programme (UNDP) decided that the thirty-eighth session of the Council, including the meetings of the Standing Committee for Programme Matters, would be held in New York from 3 to 21 June 1991. By the same decision the Council approved the provisional agenda and the tentative schedule of work for its thirty-eighth session, including the schedule of work for the Standing Committee for Programme Matters (DP/1991/L.4, annexes I and II).
- 2. The Governing Council, by section VI of its decision 91/1 and in accordance with its decisions 90/23 of 23 June 1990 and 91/2 of 22 February 1991, agreed that the Standing Committee for Programme Matters should deal with the following items at the thirty-eighth session:
 - (a) Implementation of country programmes in various regions;
 - (b) All country and intercountry programmes;
 - (c) Global and interregional projects;
- (d) Country and intercountry programmes of the United Nations Population Fund;
 - (e) Evaluation.

- 3. In paragraph 4 of its decision 91/2 A of 22 February 1991, the Governing Council decided that the Standing Committee for Programme Matters should work within the framework of procedures of the Council, in a similar manner to the Budgetary and Finance Committee, taking into account, inter alia, the latter's practice with respect to the organization of work, the preparation of decisions, as well as the reporting to the plenary meetings of the Council.
- 4. In accordance with section I, paragraph 4 (a), of Governing Council decision 81/37 of 27 June 1981, the Budgetary and Finance Committee has its own agenda in a separate document and its own organization of work (DP/1991/BFC/L.1).
- 5. Similarly, the present document contains, in annexes I and II, respectively, the provisional agenda and tentative schedule of work of the Standing Committee for Programme Matters.
- 6. In paragraph 3 of its decision 91/2 A, the Governing Council decided that the meetings of the Standing Committee for Programme Matters should be chaired by the President of the Governing Council or by another member of the Bureau designated by the President.
- 7. The Standing Committee will elaborate and finalize draft decisions on those items referred to it by the plenary for the ultimate adoption of such decisions by the Governing Council.
- 8. Annex II, which contains the tentative schedule of work of the Standing Committee for Programme Matters, should be considered provisional and indicative in nature so that the Committee may be in a position to take up items on a more flexible basis. In particular, should it complete consideration of an item before the date indicated, it would move immediately to the next item on its work schedule.
