Reports of the Joint Inspection Unit of interest to the United Nations Development Programme

1. Seven reports of the Joint Inspection Unit (JIU) have been issued since the last note by the Administrator to the Governing Council on the subject (DP/1991/55). Of these reports, six are of interest or concern to the United Nations Development Programme (UNDP) and to the Council, and are the subject of the present note.

JIU/REP/91/1 <u>Technical cooperation and the use of national Project Personnel (NPPP)</u>

2. The report was circulated as a document of the General Assembly at its forty-sixth session, under the symbol A/46/186. Comments of the Administrative Committee on Coordination were circulated under the symbol A/46/186/Add.1. The report was considered by the Second Committee of the General Assembly under the agenda item on operational activities for development, following which the Assembly adopted resolution 46/219 of 20 December 1992.

JIU/REP/91/2 Assessment of the environmental focus of projects financed by UNDP and other United Nations agencies

3. UNDP cooperated in the preparation of this report and provided comments thereon. The report is expected to be submitted to the General Assembly at its forty-seventh session.

JIU/REP/91/3 Report on the rotation of staff within the United Nations

4. The report was circulated as a document of the General Assembly at its forty-sixth session under the symbol A/46/326. Comments of the Secretary-General were circulated as document A/46/326/Add.1. This report was submitted for action to the United Nations, and for information to other organizations. The General Assembly postponed action on the report until its forty-seventh session.

JIU/REP/91/4 Follow-up report on the Management Advisory Service of the United Nations

5. The document was circulated as a document of the General Assembly at its forty-sixty session under the symbol A/46/327. Comments of the Secretary-General were circulated as document A/46/327/Add.1. This report was submitted for action to the United Nations, and for information to other organizations. The General Assembly postponed action on the report until its forty-seventh session.

JIU/REP/91/5 Grade overlap

6. This document has not yet been distributed. It is expected to be submitted to the General Assembly at its forty-seventh session.

JIU/REP/91/7 Advantages and disadvantages of the post classification system

7. This report, issued at the end of 1991, is expected to be submitted to the General Assembly at its forty-seventh session. UNDP was consulted in the preparation of the report and is cited in recommendation 8 as an example of a United Nations organization that has already successfully organized training courses for classifiers.
