OPENING OF THE SESSION AND ADOPTION OF THE AGENDA

Provisional agenda and organization of work of the Budgetary and Finance Committee

Note by the secretariat

- 1. In accordance with Governing Council decision 81/37, paragraph 4 (a), this document contains, in annexes I, II and III, respectively, the provisional agenda, the tentative schedule of work, and list of documents for the Budgetary and Finance Committee for the thirty-ninth session of the Governing Council. The session will begin at the United Nations Office at Geneva on Monday, 4 May 1992. For various reasons, the Bureau of the Governing Council has suggested that the closure of the session should be scheduled for Wednesday, 27 May 1992.
- 2. At its organizational meeting in February 1992, the Governing Council, in its decision 92/1, approved the provisional agenda for its thirty-ninth session and decided to allocate the following items to the Budgetary and Finance Committee:
 - 7. United Nations Population Fund: financial, budgetary and administrative matters.
 - 10. United Nations Development Programme: financial, budgetary and administrative matters:
 - (a) Annual review of the financial situation, 1991 (including trust funds);
 - (b) Revised budget estimates for 1992-1993;

- (c) Audit reports and other matters;
- (d) Status of management services;
- (e) UNDP financial regulations: matters on which consensus has not yet been achieved.
- 3. In accordance with Governing Council decisions 86/53 and 92/1, the Budgetary and Finance Committee will also review the financial implications of draft decisions before the Council takes action thereon. Consequently, provision must be made for the Committee to review all documents having financial implications, including draft decisions formulated by the Drafting Group and the Standing Committee for Programme Matters, as well as other matters which the Council may wish to refer to under item 6 of the provisional agenda of the Committee. For the present, it is assumed that the following items, in total or in part, may be referred by the Council to the Budgetary and Finance Committee. Tentative provision has therefore been made for these items; they are included in annexes I, II and III to the present document:
 - (a) Item 3 Special programmes of assistance: Humanitarian programmes;
 - (b) Item 6 Programme planning: Matters relating to the programming cycles;
 - (c) Item 11 Other matters: The Commonwealth of Independent States: Ways of establishing a United Nations presence;
 - (d) Item 11 Other matters: Venue of sessions of the Governing Council.
- 4. Annex II, which contains the provisional schedule of work of the Budgetary and Finance Committee, should be considered indicative in nature so that the Committee may be in a position to take up items on a flexible basis. In particular, should it complete consideration of an item before the date indicated, it would move immediately to the next item on its work schedule.
- 5. In accordance with Governing Council decision 88/49 of 1 July 1988, the attention of members is drawn to the following General Assembly documents which relate to the subject of audit reports (agenda item 3 (c) of the Budgetary and Finance Committee), a limited quantity of which will be made available at the time of the thirty-ninth session:
 - (a) A/46/5/Add.1 Interim report of the Board of Auditors on the United Nations Development Programme for the first year of the biennium 1990-1991 (A/46/5/Add.1);
 - (b) A/46/510 Report of the Advisory Committee on Administrative and Budgetary Questions on the financial reports and audited financial statements and reports of the Board of Auditors.

- 6. Annex II provides the organization of work of the Budgetary and Finance Committee for the period 4 to 27 May 1992, on a weekly basis.
- 7. Annex III provides a list of all documentation that relates to the provisional agenda of the Budgetary and Finance Committee.
