II. ANNOTATIONS

1. Adoption of the agenda

The present provisional agenda and annotations have been prepared in accordance with past practice and reflect items which need to be considered pursuant to decisions emanating from previous sessions of the Governing Council.

2. Assistance to Djibouti, Ethiopia, Kenya, Somalia, the Sudan and Yemen

In its decision 91/20 of 25 June 1991 concerning assistance to Djibouti, Ethiopia, Kenya, Somalia, the Sudan and Yemen, the Governing Council requested the Administrator to assist the efforts of the Secretary-General in mobilizing the necessary resources to meet the immediate needs of the refugees, returnees and displaced persons. The Council will have before it a progress report of the Administrator on the efforts made to implement decision 91/20 (DP/1992/3).

3. United Nations Development Programme Gulf Task Force

In accordance with its decision 91/21 of 25 June 1991, the Governing Council will have before it a document containing proposals for the socio-economic and environmental recovery of countries affected by the Gulf crisis of 1990-1991 (DP/1992/4), scheduled to be submitted to the international community at a meeting in New York on 16 December 1991.

The Council will also, as requested in decision 91/21, have before it a report of the Administrator thereon (DP/1992/5).

4. Preparations for the fifth programming cycle

The Governing Council will have before it a report of the Administrator as follow-up to decision 91/29 of 25 June 1991 relating to countries with a per capita gross national product above \$3,000 and for small island developing countries with a population of less than 2 million and a per capita gross national product above \$4,200 (DP/1992/6).

In accordance with its decision 91/54 of 20 September 1991 concerning Special Programme Resources, the Council will have before it a report of the Administrator containing programming documents for technical cooperation among developing countries, the transfer and adaptation of technology for development and the social dimensions of adjustment as well as revisions to the programming documents originally submitted in document DP/1991/64/Add.2 (DP/1992/7).

Under this item, the Council will also have before it a document containing letters from the Foreign Ministers of Estonia, Latvia and Lithuania to the Administrator, in which the Governments of the three Baltic States are requesting to be given recipient status by the United Nations Development Programme (DP/1992/8).

5. Programme planning: country and intercountry programmes and projects
