TRUST FUNDS ESTABLISHED BY THE ADMINISTRATOR IN 1992

Report of the Administrator

#### SUMMARY

The present document contains information on those trust funds established by the Administrator in 1992 under the authority granted to him in 1981 by regulation 5.1 of the revised Financial Regulations of the United Nations Development Programme. Summary financial information on all trust funds established by the Administrator since 1981 is provided in document DP/1993/44/Add.2.

#### INTRODUCTION

1. Regulation 5.1 of the Financial Regulations of the United Nations Development Programme (UNDP), which the Governing Council adopted by its decision 81/28 of 30 June 1981, gives the Administrator the authority to establish trust funds for specified purposes consistent with the policies, aims and activities of UNDP.

2. The present report covers all trust funds established by the Administrator during the calendar year 1992. A brief description of the activities of each trust fund is provided below and summary information on each trust fund is contained in annex I to the present document.

3. Annex II provides information concerning individual projects financed by the Russian Federation Trust Fund for the Training in the Russian Federation of Specialists from Developing Countries, which was established in 1982.

4. In accordance with Financial Regulation 5.1, the present report has been submitted to the Advisory Committee on Administrative and Budgetary Questions (ACABQ).

#### I. TRUST FUNDS ESTABLISHED ON BEHALF OF THE UNITED NATIONS DEVELOPMENT PROGRAMME

#### A. Family Health International Trust Fund

5. This trust fund was established to provide partial financial support to the organizing committee of the Informal Consultation on Behaviour Change: A Central Issue in the Response to the HIV Epidemic, held from 12 to 15 December 1991 at Dakar, Senegal.

#### B. <u>Rehabilitation Assistance to Anhui Province following</u> Flood Disaster

6. This trust fund was established to meet urgent needs for basic rehabilitation of the most impoverished and severely affected counties in Anhui Province, China. Anhui province was hit by continuous rains during the middle part of 1991. Schools, hospitals and rural industries would be rehabilitated and government capacity for disaster management would be strengthened.

#### C. Trust Fund for the FMLN Relocation Points in El Salvador

7. This trust fund was established to provide ex-combatants of the FMLN (Frente Farabundo Martí Para La Liberación Nacional) with the necessary basic services such as health, basic education, complementary food supply and an integrated programme of agricultural training in order to assist them in their reinsertion to civil life.

#### D. <u>UNDP Trust Fund for Humanitarian and Rehabilitation</u> Assistance for Cambodia

8. This trust fund was established to provide economic and financial support for the rehabilitation and reconstruction of Cambodia as provided in the Declaration on the Rehabilitation and Reconstruction of Cambodia, which forms part of the Paris Peace Agreements for Cambodia, signed on 23 October 1991. As mentioned in the Declaration, in the rehabilitation phase, particular attention will be given to food, security, health, housing, training, education, the transport network and the restoration of Cambodia's existing infrastructure and public utilities.

#### E. <u>International Development Research Centre (IDRC) Trust Fund</u> for Information Management Training Series

9. This trust fund was established to improve the direct and/or indirect delivery of services to beneficiaries of IDRC-assisted project by significantly upgrading the knowledge and skills of selected project personnel in communication planning and project/programme monitoring and evaluation.

#### F. <u>UNDP Trust Fund for Technical Assistance to</u> <u>Electoral Processes</u>

10. This trust fund was established to provide technical and material assistance to requesting countries for the purpose of undertaking free and fair elections.

#### G. <u>Trust Fund to Mainstream Human Development into</u> <u>Operational Activities</u>

11. This trust fund was established to assist developing countries, at their request, to operationalize the human development approach, which is broadly defined to encompass investment in people and participation by people. It funds national and international consultants to assist with long-term planning and programming exercises and organizes exchange of experience between countries and regions.

#### H. The UNDP Trust Fund for the Baltic Republics

12. This trust fund was established to finance projects, with the concurrence of the Government(s) concerned, to assist capacity-building and training in economic and social areas in the Republics of Estonia, Latvia and Lithuania.

#### I. Trust Fund for the Inter-Parliamentary Union

13. This trust fund was established to provide support to the parliaments and representative institutions within the framework of the Technical Cooperation Programme of the Inter-Parliamentary Union.

#### J. UNDP Trust Fund for the Mozambique Demobilization Programme

14. This trust fund was established to finance the demobilization programme in Mozambique. This programme is part of the terms and conditions of the peace agreement signed between the Government of Mozambique and RENAMO and within the scope of the United Nations peace-keeping and humanitarian assistance operations under the responsibility of the Special Representative of the Secretary-General.

#### K. Capacity 21 Trust Fund

15. This trust fund was established to finance the provision of technical cooperation to assist developing countries in building their capacity at all levels of society to implement Agenda 21, through, inter alia, support for the formulation and implementation of sustainable development strategies and action plans.

#### II. TRUST FUNDS ESTABLISHED ON BEHALF OF THE UNITED NATIONS CAPITAL DEVELOPMENT FUND

#### A. Development of Rice Farming Potential in Banie Valley

16. This trust fund was established for the project entitled "Développement Rizicole dans la Vallée de la Banie" (GUI/86/CO2), which aims at developing rice cultivation on 970 hectares, establishing credit systems, supporting private initiatives and developing social infrastructure in Guinea.

#### B. Grameen Deep Tubewell Irrigation Project

17. This trust fund was established to enable the Grameen Agricultural Foundation to rehabilitate and operate 650 deep tube wells in the Rangpur/Dinajpur District in Bangladesh. The project will expand cropped areas under irrigation, increase food production, and generate local employment through the operation of the wells and the generation of agricultural surplus. Grameen Agricultural Foundation will also introduce improved systems of management for the wells which have fallen into severe disrepair and underutilization while under government authority.

## III. TRUST FUNDS ESTABLISHED ON BEHALF OF THE UNITED NATIONS VOLUNTEERS PROGRAMME

#### A. Inter-Agency Humanitarian Programme for Irag/Kuwait

18. This trust fund was established to provide United Nations specialized agencies and international organizations with qualified technical staff to support them in the delivery of emergency assistance to refugees and vulnerable groups in the region.

#### B. UNV Specialists for Humanitarian Relief in the Horn of Africa

19. This trust fund was established to implement relief projects executed by United Nations specialized agencies in the affected countries of the Horn of Africa.

#### C. <u>UNV Multisectoral Technical Support for Development and</u> <u>Humanitarian Assistance (Phase II)</u>

20. This trust fund was established to provide specific technical expertise in areas such as business, administration, agriculture, education and to train local personnel in carrying out the programme in Asia and the Pacific and in Latin America.

#### D. UNV Support to UNHCR Programmes in the Latin America Region

21. This trust fund was established to provide UNV specialists in support of programmes of the Office of the United Nations High Commissioner for Refugees (UNHCR) in Central America.

#### E. Domestic Development Services Regional Programme in Asia

22. This trust fund was established to set up 12 volunteer coordinating centres in three countries in Asia: Bangladesh, India and Nepal.

#### F. <u>Technical Support to UNHCR and other United Nations agencies</u> for Humanitarian Assistance in Cambodia

23. This trust fund was established to provide a contingent of UNV specialists in support of UNHCR and other United Nations specialized agencies involved in humanitarian assistance in Cambodia.

#### G. <u>UNV Technical Support to Relief and Humanitarian Assistance</u> to South East Asia and Other Areas - Phase I

24. This trust fund was established to contribute to relief, rehabilitation and repatriation efforts with special emphasis on refugees and returnees in the countries of South East Asia and the Horn of Africa.

#### H. Drought Emergency - Southern Africa (DESA)

25. This trust fund was established to support the UNV Programme for the Southern African Development Consultative Conference (SADCC) appeal: Drought Emergency - Southern Africa.

#### I. United Nations Volunteers for Service with UNHCR and WFP

26. This trust fund was established to provide UNV specialists in support of UNHCR and the World Food Programme in the areas of food delivery, monitoring and other assistance.

#### J. Inter-Agency Humanitarian Programme for Irag

27. This trust fund was established to support the revised United Nations appeal for the inter-agency humanitarian programme in the Gulf, specifically for programmes to meet the needs of refugees and displaced persons in the northern Kurdish areas.

#### K. <u>Deployment of UNV Specialists to Support United Nations</u> <u>Humanitarian Assistance Activities in Somalia</u>

28. This trust fund was established to support the UNV technical support programme for United Nations emergency relief and humanitarian assistance for Somali refugees and displaced persons.

#### L. <u>UNV Preparatory Assistance to UNTAC for Elections</u> <u>in Cambodia</u>

29. This trust fund was established to provide several short-term UNV specialists in preparation for the electoral process.

#### M. <u>United Nations 100-Day Action Programme for Accelerated</u> <u>Humanitarian Assistance in Somalia</u>

30. This trust fund was established to support the UNV technical support programme for United Nations emergency relief and humanitarian assistance for Somali refugees and displaced persons.

#### N. <u>UNV Technical Support to Relief and Humanitarian Assistance</u> <u>in South East Asia and Other Areas - Phase II</u>

31. This trust fund was established to provide UNV multisectoral support to relief and humanitarian assistance in South East Asia and other areas and will enable UNV participation in UNHCR humanitarian assistance in former Yugoslavia.

## IV. UNDP TRUST FUND FOR HUMANITARIAN AND REHABILITATION ASSISTANCE FOR CAMBODIA

#### A. <u>UNDP/Sweden Trust Fund for the Rehabilitation of</u> <u>Infrastructure in Cambodia</u>

32. This trust fund was established for the purpose of accepting funds from the Government of Sweden to provide rehabilitation of the infrastructure in Cambodia.

#### B. UNDP/USA Trust Fund for Cambodia

33. This trust fund was established for the purpose of accepting funds from the United States Agency for International Development (USAID) for the partial defrayment of the costs of rehabilitation work that UNDP is currently undertaking on Route 5 and Pursat secondary roads in Cambodia.

#### C. UNDP/Netherlands Trust Fund for Cambodia

34. This trust fund was established for the purpose of accepting funds from the Government of the Netherlands to provide rehabilitation assistance to Cambodia.
