ADOPTION OF THE AGENDA OF THE SPECIAL MEETING AND OTHER ORGANIZATIONAL MATTERS

#### Note by the secretariat

- 1. Annex I to this document contains the draft provisional agenda for the special meeting of the Governing Council of UNDP, which is scheduled to follow immediately the organizational meeting of the Council on 14 February 1983 and will last until 18 February 1983, at United Nations Headquarters.
- 2. The tentative schedule of work for the Council's special meeting is contained in annex II to this document. This work schedule might be considered as provisional and indicative in character so that the Council may be in a position to take up various items on a more flexible basis. In accordance with past practice, the Council may wish, in any case, to decide that once it completes consideration of an item before an indicated date, it would move immediately to the next item on its work schedule, thereby avoiding loss of time and ensuring a full utilization of available conference services.
- 3. All meetings will normally be scheduled from 10:30 a.m. to 1:00 p.m. and from 3:00 to 6:00 p.m. In that context it may be recalled that by paragraph 3 (j) of its decision 81/37 the Council decided that its meetings should start promptly at the scheduled times.
- 4. To allow for the smooth planning of the Council's business and to accommodate any preferences by delegations within the proposed tentative schedule of work, the secretariat of the Governing Council (telephone: 906-5741) will, on 1 February 1983, open a list of speakers for the special meeting which will be kept for its entire duration.
