Organization of work

- 1. The Governing Council may wish to organize the consideration of the items on the provisional agenda of its special session in accordance with the timetable contained in the annex to this document.
- 2. This schedule should be considered tentative and indicative in character. Should the Council complete consideration of an item before an indicated date, it may be in a position to move immediately to the next item on its work schedule.
- 3. Following the practice of the thirty-third session and in an effort to minimize the time taken up by introductory statements, the Regional Directors and the Director of the Unit for Europe will each make only a single comprehensive 15-minute presentation for the country programmes of their respective regions which are before the Council. If need be, for each country programme brief remarks may be made so as to highlight significant features of the programme concerned or to reply to questions raised during the debate.
- 4. As in past years, the secretariat has again made arrangements for the participation of resident representatives to introduce their respective country programmes in a presentation of no more than 15 minutes, thereby enhancing the deliberations of the Committee of the Whole. The following will be present at the special session:

In addition, a special presentation will be made on activities supported by the global and interregional programme.

- 5. The President of the Council may wish to take up each country programme separately. The order of consideration need not be the same as that contained in document DP/1987/L.2, as it will be necessary, for example, wherever possible, to ensure that the representative of a country whose programme is being submitted for approval can be present.
- 6. As regards the three regional programmes before the Council at this special session, it is suggested that, upon completion of consideration of the country programmes for each region concerned, the Regional Director make a separate introduction of 10 minutes prior to consideration of the programme by the Council.
